#### 1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1a) PRE-QUALIFICATION CRITERIA (PQC): vendor should have supplied Vacuum Interrupter having short cir cuit capacity greater than or equal to 36kV, 25kA, 2500A rating in last 5 years from the date of enquiry. Ve ndor shall submit at least One PO copy of same in support of above.

1b)Relaxation of Norms for Startups: The condition of Prior Turnover and prior experience is relaxed for alls tartups whether Micro & Small Enterprises(MSEs) or otherwise subject to meeting of quality and technicals pecifications in accordance with the relevant provision of GFR,2005 and other DOE PPD notifications for rel axation norms for startups issued from time to time.

2) Payment term: 100% payment shall be made within the stipulated days as mentioned below from the d ate of receipt and acceptance of materials at BHEL Corporate R&D Vikasnagar, Hyderabad.

#### Type of bidder:

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
