100% payment will be made after receipt and acceptance of material and within **45-90 days** (subject to type of vendor's enterprise as MSE, Medium & Non MSME).

For MSEs (covered under MSME Act) which are registered and periodically renewed w ith BHEL, the Payment term is 45 days; For Medium Enterprises the Payment term is 60 days and For Non MSMEs the Payment term is 90 days.

Breach of contract, Remedies and Termination: In case of breach of contract, wherever the value of s ecurity instruments like performance bank guarantee available with BHEL against the said contract is at le ast 10% of the contract value, the same be encashed. In case the value of the security instruments available is less than 10% of the contract value, the balance amount be recovered from other financial rem edies (i.e. available bills of the contractor, retention amount, etc. with BHEL) or legal remedies be pursued . The balance scope shall be got done independently without Risk & Cost of the failed supplier/ contractor.
