1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1) Restriction: Submit duly filled signed and stamped Annexure - 144 which is attached in ATC document (on letter head).
- 2) BHEL GSTIN registration number is 36AAACB4146P1ZG
- 3) Security Deposit clause :
 - 3a) Successful bidder shall submit security deposit (SD) within 15 days from date of release of order. The S D amount will not carry any interest. The amount of security deposit will be 5% of the contract value. MODES of DEPOSIT : The amount to make up the required Security Deposit of 5 % of the contract value may be accepted in the following forms:
 - i) Cash (as permissible under the extant Income Tax Act)
 - ii) Local cheques of Scheduled Banks (subject to realization)/ Pay Order/ Demand Draft/ Electronic Fund Transfer in favour of BHEL R&D A/c 10202162640
 - iii) Bank Guarantee from Scheduled Banks/ Public Financial Institutions as defined in the Companies Act. The Bank Guarantee format should have the approval of BHEL
 - iv) Fixed Deposit Receipt issued by Scheduled Banks/ Public Financial Institutions as defined in the Companies Act (FDR should be in the name of the Contractor, a/c BHEL)
 - v) Securities available from Indian Post offices such as National Savings Certificates,
- 4) Interest chargeable on Delay in Submission of Security Deposit : SD is to be submitted by the successful vendor within 15 days from the date of order. Bidder agrees to submit security deposit required for execution of the contract within the time period mentioned above. In case of delay in submission of performance

security, enhanced amount which would include interest (Repo rate + 4%) for the delayed period, shall be submitted by the bidder. Further, if SD is not submitted till such time the first bill becomes due, the amount of SD due shall be recovered from the bills along with due interest.

5) Vendor has to submit this GeM bid document duly signed and stamped on all pages. By submitting signed GeM bid it affirms that vendor has accepted to all the terms and conditions mentioned in this bid such as Payment terms, delivery period, Security deposit clause etc.

6) Breach of contract, Remedies and Termination : In case of breach of contract, wherever the value of security instruments like performance bank guarantee available with BHEL against the said contract is at least 10% of the contract value, the same be encashed. In case the value of the security instruments available is less than 10% of the contract value, the balance amount be recovered from other financial remedies (i.e. a available bills of the contractor, retention amount, etc. with BHEL) or legal remedies be pursued. Further, levy of liquidated damages, debarment, termination, de-scoping, short-closure, etc., shall be applied as per provisions of the contract.

4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the [General Terms and Conditions/सामान्य नियम और शर्तें](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
