1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1) Qualifying Criteria [PQC]:

1a) PRE QUALIFICATION CRITERIA: The bidder should have supplied similar items i.e., printer cartridges for at least one order in the last three (03) years prior to enquiry date. Order copy shall be furnished along with bid as proof of the same.

1b) Relaxation of Norms for Startups: The condition of Prior Turnover and prior experience is relaxed for all startups whether Micro & Small Enterprises(MSEs) or otherwise subject to meeting of quality and technical specifications in accordance with the relevant provision of GFR,2005 and other DOE-PPD notifications for relaxation norms for startups issued from time to time.

2) Payment term:

100% payment shall be made within the stipulated days as mentioned below from the date of receipt and acceptance of materials at BHEL Corporate R&D Vikasnagar, Hyderabad

Stipulated time based on type of bidder:

- A. For Micro & Small enterprises(MSEs) payment will be made with-in 45 days
- B. For Medium Enterprises will be made with-in 60 days
- C. Non MSMEs will be made with-in 90 days

However, GST Portion of Invoice shall be released only upon:

- i) Vendor declaring the Invoice in their GSTR-1.

4) Breach of contract, Remedies and Termination:

In case of breach of contract, wherever the value of security instruments like performance ba

Bank guarantee available with BHEL against the said contract is at least 10% of the contract value, the same to be encashed. In case the value of the security instruments available is less than 10% of the contract value, the balance amount to be recovered from other financial remedies (i.e. available bills of the contractor, retention amount, etc. with BHEL) or legal remedies to be pursued. The balance scope shall be got done independently without Risk & Cost of the failed supplier/ contractor.

Further, levy of liquidated damages, debarment, termination, de-scoping, short-closure, etc., shall be applied as per provisions of the contract.
