### 1) Earnest Money Deposit (EMD) :

Submission of earnest money deposit (EMD) along with offer is required. EMD is to be deposited in cash (a s permissible under IT act), or by pay-order/Demand Draft drawn in 4 / 6 f avour of BHEL R&D-A/c 1020216 2640,Vikasnagar,Hyderabad 500 042. EMD amount will be returned to all unsuccessful bidders after place ment of order. EMD amount shall not carry any interest. EMD by the Tende rer will be forfeited as per NIT c onditions, if: i) After opening the tender and within the offer validity period, the tenderer revokes his tende r or makes any modification in his tender which is not acceptable to BHEL. ii ) The Contractor fails to depos it the required Security deposit or commence the work within the period as p er LOI/ Contract. - 3) **Interest for delayed submission of SD**: Bidder agrees to submit performance security required for exec ution of contract within 15 days from the date of award of contract. In case of delay in submission of perfor mance security, enhanced performance security which would include interest (SBI rate + 6%) for the delay ed period, shall be submitted by the bidder. Further, if performance security is not submitted till s uch time the first bill becomes due, the amount of performance security due shall be recovered as per terms define d in NIT/Contract, from the bills along with due interest.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
