Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

4. TAXES AND DUTIES

4.1 Bidder's quoted/ accepted rates/ price shall be inclusive of all taxes including GST, Charges, Royalties, any State or Central Levy and other taxes for materials if any obtained for the work and for execution of the contract.

Any increase of above at any stage during execution of contract, including extension of the contract, shall have to be borne by successful bidder. However, any increase of GST subsequent to due date of offer sub mission as per NIT & TCN, by statutory authority during contract period (including extension, if the same i s not attributable to you), shall be reimbursed by BHEL on production of relevant supporting document to the satisfaction of BHEL.

Benefit of any decrease of taxes including GST, Charges, Royalties, any State or Central Levy and other ta xes for materials if any obtained for the work and for execution of the contract; subsequent to due date of offer submission as per NIT & TCN, by statutory authority shall be passed on to BHEL.

4.2 Successful bidder shall furnish proof of GST registration with GSTN Portal covering the services under this contract.

Registration should also bear endorsement for the premises from where the billing shall be done by succe ssful bidder on BHEL for this project / work.

- 4.3 Since GST on output will be paid by BHEL as enumerated above, bidder's quoted rates / price should be after considering the Input Credit under GST law at bidder's end.
- 4.4 TDS under Income Tax Act shall be deducted as per prevailing IT rules from the bills.
- 4.5 TDS under GST shall be deducted as per prevailing GST rules from the bills.
- 4.6.1 You may collect TCS under section 206C(1H) of Income Tax Act, 1961 if applicable.

- 4.6.4 In event of failure to comply with the provisions of the Act, or proper certificate not issued, or if tax c ollected but not remitted to the Government, or for any other reason and thereby causing loss to BHEL, the same shall be recoverable from the vendor with applicable interest.
- 4.6.5 You shall comply with all statutory amendment/notifications in this respect.

4.8 Successful bidder to intimate immediately on the day of removal of goods (in case of any supply of go ods) to BHEL along with all relevant details and send a scanned copy of Tax Invoice to BHEL through following communication mode for enabling BHEL to meet its GST related compliances.

Portal address and Email address - Shall be intimated later.

Specific details of above shall be intimated to successful bidder by BHEL at appropriate juncture.

4.9 In case of delay in submission of above-mentioned documents on the date of dispatch, BHEL may incu r penalty/ interest for not adhering to Invoicing Rules under GST Law. The same will be liable to be recove red from successful bidder, in case such delay is not attributable to BHEL.

4.10 In case of raising any Supplementary Tax Invoice (Debit / Credit Note), successful bidder shall issue the same containing all the details as referred to in Section 34 read with Section 31 of GST Act & Rules referred there under.

4.11 Successful bidder shall comply with the Time Limit prescribed under the GST Law and rules thereof f or raising of the Tax Invoice. If any supply of goods is applicable, successful bidder shall also ensure prompt delivery of goods after dispatch.

4.12 Bidder shall note that in case GST credit is delayed / denied to BHEL due to delayed / non-receipt of goods and / or Tax Invoice or expiry of the timeline prescribed in GST Law for availing such ITC, or any oth er reasons, not attributable to BHEL, GST amount shall be recoverable from successful bidder along with i nterest levied/ leviable on BHEL, as the case may be.

4.13 Successful bidder shall upload the invoices raised on BHEL in IFF/GSTR-1 within the prescribed time as given in the GST Act, and the same should be available to BHEL in FORM GSTR-2B electronically through the common portal; and confirmation of payment of such GST to the Government through filing of GSTR-3B of corresponding month/quarter.

Bidder shall note that in case of delay in declaring such invoice in your return and GST credit availed by B HEL is denied or reversed subsequently as per GST Law, GST amount paid by BHEL towards such ITC reve rsal as per GST law shall be recoverable from the successful bidder along with interest levied / leviable on BHEL.

4.14 Successful bidder to arrange for e-waybill for any movement of goods for the execution of the contra ct. - 5.2 During the period of mass concreting and concreting of important structures/ foundation s, un-interrupted supply of cement is envisaged. BHEL site shall give advance written inti mation of required cement quantity (tentatively upto 1000 MT for supply within 3 days) t o supplier before 7 days of such mass concreting/ concreting of important foundations. MDCC in such cases shall be issued at appropriate juncture and supplier to ensure un-int errupted delivery of cement and necessary logistics for delivering the required cement q uantity within 3 days from MDCC.

6. MATERIAL DISPATCH CLEARANCE CERTIFICATE (MDCC)

MDCC for dispatch of required quantity of cement shall be issued by BHEL Raghunathpur site. Supp ly shall be in line with respective MDCC. No material shall be dispatched by supplier until and unles s Material Dispatch Clearance Certificate (MDCC) is issued by BHEL Site. Each consignment will be accompanied by copy of MDCC.

7. SPECIAL INSTRUCTIONS

- 7.1. The unloading of cement will be done by BHEL at site within a reasonable time.
- 7.2 Site test of cement shall be conducted as per BHEL/Customer's field quality plan. BHEL reserves the right to conduct necessary test at vendor's works if required.
- 7.3 The representative of the vendor should be available at RAGHUNATHPUR site wh enever required as per BHEL site requirement to provide single window expeditio us service and quality checks as per IS code.
- 7.4 Guarantee / Warranty certificate to be furnished by the successful bidder.
- 7.5 Quality of cement is associated with shelf life. Shelf life of cement supplied shoul d be in line with IS specification, considering manufacturing & transit time so that minimum 8 weeks shelf life is available from the date of receipt at site, for use of BHEL. Bidder shall ensure supply of cement at site accordingly.
- 7.6. Copy of Manufacturer's test certificate (MTC) in original for 7 & 28 days compres sive strength test result submitted by successful bidder is to be accepted by BHE L/Customer.
- 7.7 Store Receipt Voucher shall be generated at site.
- 7.8 Item should be delivered through cement bulkers.
- 7.9 Weighment of cement bulkers shall be done at BHEL / BHEL agencies' weighbrid ge. For the purpose of payment, the weighment slips of weighbridge shall be considered.
- 7.10 Transit Insurance shall be in scope of BHEL. Details of policy and underwriter s

hall be suitably intimated to the successful bidder.

9. INSPECTION

The test results of th ird-party test shall be final and binding on the vendor. In case of rejection at any stage, supplier shall be liable to replace at his own cost.

10. REJECTION

In case any material is found defective or unsuitable at our works/Site after supply, the same shall be subjected to test by third party and the result of the third-party test shall be acceptable and binding to the vendor. In case the test results show that the material does not conform to the standards specified, the whole lot shall be rejected, taken back by the vendor and replaced by the acceptable material at vendor's cost.

11. QUALITY INSTRUCTION

- a. Preliminary acceptance of cement will be on the basis of 7 days compressive strength test result as per MTC submitted by supplier. Final acceptance criteria will be 28 days compressive strength test result a s per supplier's MTC or if required through testing at BHEL lab/ BHEL approved third party lab.
