1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum

local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.

3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1a) Qualifying Criteria [Experience in delivering the simulation tool]: Vendor should have supplied simulation tool software with option to export the developed model into code based FMU in the last 5 years. Reference of at least one such supply to be submitted along with the PO copy and completion certificate. BHEL will carry out independent verification of the documents submitted. Hence prospective bidders are required to give only reference of those customers who are willing to confirm the independent verification and not refrain from the

same on grounds of confidentiality.

1b) Relaxation of Norms for Startups: The condition of Prior Turnover and prior experience is relaxed for all startups whether Micro & Small Enterprises(MSEs) or otherwise subject to meeting of quality and technical specifications in accordance with the relevant provision of GFR,2005 and other DOE-PPD notifications for relaxation norms for start-ups issued from time to time.

2) Payment term: 80% payment of the supply value shall be made within 15 days from the date of receipt

pt of material with clear documents at BHEL. Balance 20% of supply value plus 100% of the E&C portion of PO Value will be paid against E&C certificate issued by BHEL and submission of Performance Bank Guarantee by supplier.

However, GST Portion of Invoice shall be released only upon:

- i) Vendor declaring the Invoice in their GSTR-1.
- ii) Receipt of Goods and Tax Invoice by BHEL.
- iii) Confirmation of Payment of GST thereon by vendor on GSTN.

3) Risk Purchase: In case of default/late delivery, BHEL reserves the right to make alternate arrangement for procurement at supplier's risk and cost.

4) Contract execution Bank Guarantee(CEBG): The successful vendor shall have to furnish a Contract Execution Bank Guarantee (CEBG) for **10% of the Total PO value** in the prescribed format **within 30 days from the date of P.O**. CEBG shall be from one of the Consortium Banks of BHEL or from a reputed Bank and confirmed by any Consortium Bank of BHEL. All bank charges on account of issuance and confirmation of CEBG will have to be borne by the vendor.

CEBG shall be kept valid unit 30 days after the date of E&C Certificate, which will be issued on completion of Erection & Commissioning of equipment which includes commissioning, demonstration and training to operators etc. as prescribed in PO.

If the supplier fails to submit the CEBG even with-in 60 days from the date of PO, BHEL reserves the right to cancel PO & forfeit the EMD given by the supplier. In addition, in such case, action will be initiated in line with extant guidelines for Suspension of Business dealings with Suppliers.

Note: Proforma of Contract Execution Bank Guarantee (CEBG) is attached in ATC documents (refer page no. 2 to 4).

5) Interest of delayed submission of ePBG and CEBG: Bidder agrees to submit Contract Execution Bank Guarantee(CEBG) with-in 30 days from the date of P.O and performance bank guarantee (ePBG) with-in 15 days from the date of completion of commissioning.

In case of delay in submission of PBG and CEBG, enhanced performance security which would include interest (SBI rate + 6%) for the delayed period, shall be submitted by the bidder. Further, if performance security is not submitted till such time the first bill becomes due, the amount of performance security due shall be recovered as per terms defined in NIT/contract, from the bills along with due interest.

6) Unpriced-bid format: Vendor should provide unpriced bid document with technical bid as per the format provided as Annexure - 2. Please note that, Annexure-2 is provided in specification document. **Supplier should not mention any price in this.**

7) Priced-bid format: Vendor should provide price breakup (with financial bid). For price break-up, Priced-bid format i.e. Annexure-3 attached in ATC document may be used (refer page no. 6 & 7). Please note that, total price quoted in GeM portal should be equal to the Total price mentioned in format.

8) Integrity Pact :

9a) Delivery period: The delivery period 176 days (from PO) is for complete scope i.e. Supply, commissioning and training. Schedule for each activity is as mentioned below:

i) Supply: Licenses are to be delivered preferably within 8 weeks from the date of firm P.O. However, vendor has to obtain Line of clearance from BHEL before delivering either physical form (CD/DVD) or link for downloading both software & licenses.

ii) Commissioning and Training: Vendor to complete commissioning and training activities within 30 days from the date of receipt of line of clearance from BHEL. BHEL will furnish the line of clearance for commissioning within 90 days from date of receipt and acceptance of licenses

9b) The bidders should quote their earliest schedule for supply (i) and commissioning & training (ii) against the schedule indicated above. BHEL, however, reserves the right to accept an offer not meeting the enquiry schedule.

10) Penalty for Delay in supply and commissioning:

10a) For the purpose of penalty for delay in commissioning of the 1-D simulation tools (with 5 licenses) the duration will be reckoned from the date of intimation by BHEL to vendor for readiness of site.

10b) Penalty on delay in 'Supply' and/or 'commissioning' will be applicable to the delays attributed to vendor.

Penalty will be considered separately for 'Supply' and 'commissioning'.

The rate of penalty for delayed Supply shall be @ 0.5% per week of delay of total PO value

(Supply+ Commissioning) in supply subject to a maximum of 10% of total PO value (Supply+ commissioning).

The rate penalty for delayed commissioning shall be @0.5% per week of delay of total PO Value (Supply+ commissioning) in commissioning subject to a maximum of 10% of total PO value (Supply+ commissioning). Maximum penalty for delay in Supply and commissioning together shall be limited to 15% of total PO value (Supply+ commissioning).

10C) In case, any shortage is noticed viz-a-viz PO requirement in the main 1-D simulation tools (with 5 licenses), such shortages shall be replenished by supplier on for destination basis without any cost implication to BHEL i.e. Custom Duty and freight charges etc. up to destination for such short supplies shall be borne by the supplier.
