NET WORTH: Net Worth of the OEM should be positive as per the last audited financial statement.

8. Scope of Supply

Scope of supply (Bid price to include all cost components): Only supply of Goods

9. Generic

Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

10. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buye
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior writ consent of buyer.

11. Generic

- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchas Order on the Seller.

12. Generic

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screensh GST portal confirming payment of GST.
