1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating

- 3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
 - i. If number of technically qualified bidders are only 2 or 3.
 - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.

1a) Qualifying Criteria [PQC]:

- 1. OEM or Vendor should have supplied at least ONE such Electro Dynamic Vibration Shaker Syste m in last 05 years from the date of enquiry. Installation and commissioning reports along with pur chase order copies in proof of this has to be submitted along with the technical bid.
- 2. vendor should produce valid authorization certificate from OEM to participate in tender.
- **1b) Relaxation of Norms for Startups:** The condition of Prior Turnover and prior experience is relaxed for all startups whether Micro & Small Enterprises(MSEs) or otherwise subject to meeting o f quality and technical specifications in accordance with the relevant provision of GFR,2005 and ot her DOE-PPD notifications for relaxation norms for start-ups issued from time to time.
- **2) Payment term:** 80% payment of the supply value shall be made within stipulated time as me ntioned below from the date of receipt of material with clear documents at BHEL. Balance 20% of supply value plus 100% of the E&C portion of PO Value will be paid against ICT certificate issued by BHEL and submission of Performance Bank Guarantee by supplier.

Stipulated time based on type of bidder:

EMD by the Tenderer will be forfeited as per tender documents if, the successful bidder/vendor ref uses to honour the order after award of the same on him and/or withdraws his bid and/or unilatera lly changes the offer and/or any of its terms conditions within the validity period

EMD given by all unsuccessful Tenderers shall be refunded on acceptance of award/LOI/Po by succ essful tenderer. The EMB of successful bidder shall be returned after submission of Contract Execution Bank Guarantee (CEBG)

4) Contract execution Bank Guarantee(CEBG): The successful vendor shall have to furnish a Contract Execution Bank Guarantee (CEBG) for **10% of the Total PO value** in the prescribed for mat **within 30 days from the date of P.O**. CEBG shall be from one of the Consortium Banks of BHEL or from a reputed Bank and confirmed by any Consortium Bank of BHEL. All bank charges on account of issuance and conformation of CEBG will have to be borne by the vendor.

CEBG shall be kept valid unit 30 days after the date of ICT Certificate, which will be issued on completion of Installation & Commissioning of equipment which includes Installation, commissioning a nd training to operators etc. as prescribed in PO.

If the supplier fails to submit the CEBG even with-in 60 days from the date of PO, BHEL reserves the right to cancel PO & forfeit the EMD given by the supplier. In addition, in such case, action will be initiated in line with extant guidelines for Suspension of Business dealings with Suppliers.

Under all circumstances, CEBG shall be kept valid till PBG becomes operational.

5) Interest of delayed submission of ePBG and CEBG: Bidder agrees to submit Contract Exec ution Bank Guarantee(CEBG) with-in 30 days from the date of P.O and performance bank guarante e (ePBG) with-in 15 days from the date of completion of commissioning.

In case of delay in submission of PBG and CEBG, enhanced performance security which would include interest (SBI rate + 6%) for the delayed period, shall be submitted by the bidder. Further, if performance security is not submitted till such time the first bill becomes due, the amount of performance security due shall be recovered as per terms defined in NIT/contract, from the bills along with due interest.

6) Delivery period:

Penalty will be considered separately for 'Supply' and 'commissioning'.

The rate of penalty for delayed Supply shall be @ 0.5% per week of delay of total PO value

The rate penalty for delayed commissioning shall be @0.5% per week of delay of total PO Value (Supply+ commissioning) in commissioning subject to a maximum of 10% of total PO value (Supply+ commissioning). Maximum penalty for delay in Supply and commissioning together shall be limited to 15% of total PO value (Supply+ commissioning).

Further, levy of liquidated damages, debarment, termination, de-scoping, short-closure, etc., shall be applied as per
