1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1) Please ensure to provide/upload the following document s and take a note of following while submitting your offer:

- I. Please refer GEM GTC 4.0 (Version 1.1) Clause No. f "The partici pation by the Seller in e-bidding shall be construed as his / her acc eptance for all the Terms and Conditions as outlined in the e-bidding including GTC, STC and ATC." Evaluation of the bidder's offer will also be done in consideration of this clause.

3) Risk Purchase:

Participa tion by a Bidder in more than one Bid will result in the disqualification of a II bids in which the parties are involved. - 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
