If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. - Bidder shall submit the following documents along with their bid for Vendor Code Creation:

 - Copy of Cancelled Cheque.

If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. 8. Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.
9. While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.
10. **Buyer Added text based ATC clauses**
 1. Bidder shall fill the technical bid form uploaded in Buyer uploaded ATC document suitably, sign, stamp and uploaded the same
 2. Bidder shall sign, stamp and upload all the attachments uploaded along with the bid.
 3. Bidder shall submit required documents as per PQC & other attachments uploaded along with the bid.

Disclaimer
