1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase

preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local contents shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) of 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to big Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and strength enterprises will be allowed to participate. In case Buyer has selected Purchase preference to Micro and Small Enterp clause in the bid, the same will get precedence over this clause.

2. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all with any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% b qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OE (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to particip the RA process.

1. Inspection

Pre-dispatch inspection at Seller premises (Fee/Charges to be borne by the BUYER): Before dispatch the goods will be inspected by Buyer / Consignee or their Authorized Representative or by Nominated Externa Inspection Agency (independently or jointly with Buyer or Consignee as decided by the Buyer) at Seller premi (or at designated place for inspection as declared / communicated by the seller) for their compliance to the

contract specifications. Fee/Charges taken by the External inspection Agency and any external laboratories to charges shall be borne by the Buyer. For in-house testing, the Sellers will provide necessary facilities free of consigner shall notify the Buyer through e-mail about readiness of goods for pre-dispatch inspection and Buyer with notify the Seller about the Authorized Representative/ Nominated External Inspection Agency and the date for testing. The goods would be dispatched to consignee only after clearance in pre-dispatch inspection. Consigning right of rejection as per GTC in respect of the goods finally received at his location shall in no way be limited waived by reason of the goods having previously been inspected, tested and passed by Buyer/ Consignee or in Nominated External Inspection Agency prior to the goods' shipment. While bidding, the sellers should take int account 7 days for inspection from the date of email offering the goods for inspection. Any delay in inspection beyond 7 days shall be on the part of the buyer and shall be regularised without Liquidated Damages. When there is requirement of submission the advance sample, the seller shall inform the buyer promptly throemails about the date of submission of sample to the buyer nominated Inspection agency.

2. Inspection

Nominated Inspection Agency: On behalf of the Buyer organization, any one of the following Inspection Age would be conducting inspection of stores before acceptance:

3. Generic

After award of contract – Successful Bidder shall have to get Detailed Design Drawings approved from buyer before starting fabrication. Successful Bidder shall submit Detailed Design Drawings for Buyer's approval, witl 15 days of award of contract. Buyer shall, either approve the drawings or will provide complete list of modifications are quired in the drawings within 10 days. Seller shall be required to ensure supply as per approved Drawings with modifications as communicated by Buyer. If there is delay from buyer side in approval of drawing– the deliver period shall be refixed without LD for the period of delay in approval of Drawing.

4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

5 Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibilit this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject the maximum of quoted GST %.

This is a conditional open tender enquiry and participation of a bidder in Reverse Auction (RA) shall be subj to the following: a) Offered item should mandatorily conform to PP-MII order provisions. Terms and conditions of PP-MII order a latest amendments shall be applicable. b) Qualification of Technical PQR. c) Techno-Commercial recommendation by BHEL. d) Approval of bidder by end customer i.e. M/s WBPDCL Payment Terms: As per clause no. 12 (i) of GTC on GeM. However, payment will be released within 60 after submission of complete documents (45 days for vendors qualified and registered as Micro or Small a MSMED Act). Offline payment mode shall be selected. Supplier has to provide original+1 copy of Tax in Packing List, LR/RR or AWB, CRAC, Insurance intimation, Guarantee Certificate, E-way bill (as applicable payment. Liquidated Damage: Purchaser reserves the right to recover from the Seller/ Contractor, as agreed liqui damages and not by way of penalty, a sum equivalent to half (1/2) percent and applicable GST thereon, of the contract price excluding GST per week or part thereof, subject to a maximum of ten (10) percent of the total s contract price excluding GST, if the Seller/ Contractor fails to deliver any part of the ordered goods/stores with period stipulated in the Order/ Contract. NOTE: i. LR/RR date for indigenous supplies (Bill of Lading/AWB for Foreign supplies) shall be treated as the d dispatch for levying LD. However, if receipted LR date for indigenous supply is beyond 30 days for F days for PTL from the date of LR (PTL to be clearly mentioned in LR), such excess period sh considered for LD purpose irrespective of dispatch date. Import General Manifest (IGM)/Bill of entry (whichever is earlier), for foreign supplies, is beyond 90 days from the date of Bill of Lading/AWB, excess period shall be considered for LD purpose irrespective of dispatch date. ii. In case of any amendment/ revision, LD shall be linked to the amended/ revised contract valu delivery date(s). iii. f) Risk & Cost Purchase

BHEL reserves the right to terminate the contract or withdraw portion of work and get it done through other agency, at the risk and cost of the contractor after due notice of a period of 14 days' by BHEL in any of the following cases:

- i) If the Seller/Contractor fails to deliver the goods or materials or any instalment thereof within the period(s) for such delivery or the Seller's poor progress of the supply/ services vis-à-vis delivery/execution timeli stipulated in the Contract, backlog attributable to seller including unexecuted portion of supply does not app be executable within balance available period;
 - ii) Delivers goods or materials not of the contracted quality and failing to adhere to the contract specifications;
 - iii) Withdrawal from or repudiation/ abandonment of the supply/ services by Seller before completion a contract or if the Seller refuses or is unable to supply goods or materials covered by the Order/Co either in whole or in part or otherwise fails to perform the Order/Contract;
 - iv) Non-supply by the Seller within scheduled completion/delivery period as per Contract or as extended from time to time, for the reasons attributable to the Seller;
 - v) Termination of Contract on account of any other reason (s) attributable to Seller.
 - vi) Assignment, transfer, subletting of Contract without BHEL's written permission resulting in termination of Contract or part thereof by BHEL.
 - vii) If the Seller be an individual or a sole proprietorship Firm, in the event of the death or insanity Seller:
 - viii) If the Seller/Contractor being an individual or if a firm on a partnership thereof, shall at any tin adjudged insolvent or shall have a receiving order for administration of his estate made against him o take any proceeding for composition under any Insolvency Act for the time being in force or mak assignment of the Order/Contract or enter into any arrangement or composition with his credit suspend payment or if the firm dissolved under the Partnership Act;
 - ix) If the Seller/Contractor being a company is wound up voluntarily or by order of a Court or a Rec Liquidator or Manager on behalf of the debenture holders and creditors is appointed or circumstance: have arisen which entitles the Court of debenture holder and creditors to appoint a receiver, liquida manager;
 - x) Non-compliance to any contractual condition or any other default attributable to Seller.

Such defaulting vendor/Seller shall not be eligible to participate in re-tendering conducted on accorisk purchase made due to fault of such vendor/Seller.

Risk & Cost Amount against Balance Work:

Risk & Cost amount against balance work shall be calculated as follows:

Risk & Cost Amount= $[(A-B) + (A \times H/100)]$

Where,

A= Value of Balance scope of Work (*) as per rates of new contract

B= Value of Balance scope of Work (*) as per rates of old contract being paid to the contractor at the till termination of contract i.e. inclusive of PVC & ORC, if any.

H = Overhead Factor to be taken as 5 In case (A-B) is less than 0 (zero), value of (A-B) shall be taken as 0 (zero)

* Balance scope of work (in case of termination of contract):

Difference of Contract Quantities and Executed Quantities as on the date of issue of Letter for 'Termir of Contract', shall be taken as balance scope of Work for calculating risk & cost amount.

Contract quantities are the quantities as per original contract. If, Contract has been amended, qua as per amended Contract shall be considered as Contract Quantities.

Items for which total quantities to be executed have exceeded the Contract Quantities based on drawings it of contractor from time to time till issue of Termination letter, then for these items total Quantities as per items would be deemed to be contract quantities.

Substitute/ extra items whose rates have already been approved would form part of contract quantities for purpose. Substitute/ extra items which have been executed but rates have not been approved, would also part of contract quantities for this purpose and rates of such items shall be determined in line with contr provisions.

However, increase in quantities on account of additional scope in new tender shall not be consider this purpose.

NOTE: In case portion of work is being withdrawn at risk & cost of contractor instead of termination of cor contract quantities pertaining to portion of work withdrawn shall be considered as 'Balance scope of work calculating Risk & Cost amount.

LD against delay in executed work in case of Termination of Contract :

LD against delay in executed work shall be calculated in line with LD clause no. 16 of GCC, for the

delay attributable to contractor. For limiting the maximum value of LD, contract value shall be as Executed Value of work till termination of contract.

Method for calculation of LD against delay in executed work in case of termination of contract" is given below.

- ii. Let the value of executed work till the time of termination of contract = X
- iii. Let the Total Executable Value of work for which inputs/fronts were made available to contract were planned for execution till termination of contract = Y
- iv. Delay in executed work attributable to contractor i.e. $T2 = [1-(X/Y)] \times T1$
- v. LD shall be calculated in line with LD clause (clause 16) of the Contract for the delay attributa contractor taking "X" as Contract Value and "T2" as period of delay attributable to contractor.

Recoveries arising out of Risk & Cost and LD or any other recoveries due from Contractor:

Without prejudice to the other means of recovery of such dues from the Seller recoveries from the Se whom risk & cost has been invoked shall be made from the following:

- a) Dues available in the form of Bills payable to seller, SD, BGs against the same contract.
- b) Dues payable to seller against other contracts in the same Region/Unit/ Division of BHEL.
- c) Dues payable to seller against other contracts in the different Region/Unit/ division of BHEL.

In-case recoveries are not possible with any of the above available options, Legal action shall be initiat recovery against contractor.

- g) Transit Insurance shall be in BHEL scope.
- h) **Terms of Delivery :** As per cl. No. 13 of GTC on GeM (i.e. Free Delivery at site basis including loading/unloa However, Transit insurance & unloading of items (at delivery point) shall be in the scope of buyer. Bidder to prices accordingly.

Further, w.r.t. - J) Bidders shall be required to submit applicable Freight % & GST % w.r.t Ex-works price included in their quoted (F.O.R) prices during clarification stage of Tender.

- Quantity Variation: Overall (%) variation in contract values due to changes in the scope shall be li +25%.

Purchaser will issue MDCC to the Seller/ Contractor within 7 days based on inspection report certificates/Certificate of Conformance as applicable. In case of delay in issuance of MDCC beyond 7 stipulated time (i.e. from the date of successful inspection report), by BHEL arising due to reason attributable to vendor, BHEL will extend the delivery period for such delay in issuing MDCC. If BHEL able to issue MDCC up to 15 days then in addition to delay beyond stipulated period, 7 days' add time shall be given to vendor to facilitate the vendor for arranging logistics arrangements.
