

**S-1.0 PRE-QUALIFICATION REQUIREMENTS (PQR)**

Bidders to furnish details as per attached **FORMAT- I** on their Letter Head.

The bidder shall comply with the following requirements and submit all relevant documents to be eligible for this rate contract. Completed **Check List for Technical Compliance (Annexure-A)** to be submitted as **Part - I**, in the two part bid system. The rates are to be submitted as **Part - II** of the bid in the **Price Bid (Annexure-III)**. Rates of only those bidders will be opened meeting all the technical requirements as per Annexure- A.

S-1.1 IBA recommendation: Transporter to submit copy of IBA (Indian Banker's Association) recommendation valid on the date of tender opening.

S-1.2 Average annual turnover during the last 3 years ending 31st March 2019 shall be minimum **Rs. 615 Lakhs**. Audited balance sheet / Profit & Loss account for last three years viz. 2016-17, 2017-18 and 2018-19 to be submitted.

S-1.3 Transporter should have earned profit in at least one year during last three financial years ending 31-03-2019 and should possess positive net worth as on 31.03.2019.

S-1.4 Experience: Transporters to submit evidence of having carried out road transportation as follows:

Bidders should have executed transportation of minimum 02 package of more than 35 MT in last 15 years in NEPAL/ BHUTAN/ HILLY REGION of India by road. Hilly region mean destinations beyond Pathankot for Jammu & Kashmir, Rishikesh/ Kashipur/ Mohand in Uttarakhand and Parwanoo/ Kiratpur in Himachal Pradesh, destinations beyond Siliguri in North Eastern Sector.

No Consortium bidding/ JV is allowed.

S-1.5 Ownership of vehicles: Bidders are required to submit evidence of ownership of the vehicles offered for this tender. **Registration particulars in the name of the transporter** (Copies of RC along with Gazette Notification of Govt. of India to ascertain no. of axles against chassis number mentioned in the RC) to be submitted along with the offer for the following minimum no. of vehicles :

Hydraulic trailers

Axles – Minimum 60 Nos.

Pullers – Minimum 6 Nos. (Out of which Min.02 Nos. must be of 460 HP or above)

S-1.6 Declaration in the form of Affidavit.

All bidders must confirm, by way of a notarized affidavit cum undertaking executed on a non-judicial stamp paper of Rs. 100/- as per attached **FORMAT – II**
