Any deviation in design/type from the approved model shall render the offer liable for rejection.</p> <p style="text-align: center;">(OR)</p> <p>The Bidder to be an OEM of tracker systems and should have designed, manufactured, supplied, erected/supervised erection, and commissioned/supervised commissioning Solar Tracker System of the proposed design/type of cumulative capacity of 40 MWp or above, out of which at least one such supply order for a single plant should be of 10 MWp or above capacity. The bidder may use the credentials of its Parent/Group/ Holding company for meeting the requirement. The reference plant in which 10 MWp or above capacity Solar Tracker System was supplied, must have been in successful operation for at least one (1) year as on Offer submission date for pre-bid tie-up. PO/WO copy, Completion certificates from Customer to be submitted for validation of the above experience clearly indicating date of commissioning and MW commissioned. Hence in line with the clarification issued by the Department of Expenditure, Ministry of Finance (vide No. F.20-2/2014-PPD(Pt.) dated 27.07.2017), no relaxation regarding prior experience shall be granted to any bidder for this Procurement.</p>
