- 1. Milk should be supplied fresh and good Quality.
- 2. Supplier should have their own shop.
- 3. Supplier should ensure that supply of Milk packet must be reached at BHEL Canteen up to 8:00 AM:
- 4. The cartage charges of supply shall be borned by the supplier.
- **5.** Quoted price must be F.O.R. BHEL basis inclusive of all packing, forwarding, freight, Insurance & octroi charges etc.
- **6.** Milk shall also be supplied for additional working days /programmes in Canteen on prior information.
- 7. The quantity of Milk can be increased or decreased as per our requirement.
- 8. Payment of supplier shall be made on monthly basis through e- payment.
- **9.** Payment shall be made on actual qty. basis which shall be verified by BHEL Canteen.
- 10. Supplier regarding supply of Milk packet will follow the Instructions of Officer Incharge, Canteen (BHEL).
- 11. The rate of Milk Packet should be given in per packet basis in "Price-Bid" (Sample of price bid is enclosed in tender documents for your ready reference).
- 12. GST /other Govt. Taxes & duties. If any will be paid extra.



- 13. Vendor shall submit EMD on-line in BHEL A/C No.10670828866 (IFS Code: SBIN0003807) & evidence must be enclosed along with the technical bid. EMD of successful vender shall be adjusted in Security deposit. The EMD of unsuccessful vender shall be refunded after needful action at BHEL's end. Please note that without EMD, tender will not be accepted.
- **14.** Security deposit @ 5% of order value shall be deposited before start of Supply. The EMD shall be adjusted in security deposit.
- **15.** Supplier shall deposit necessary stamp duty on security deposit as per Govt. stamp act.
- **16.** This Contract shall be valid for one year but BHEL have full right to cancel the contract before the completion tenure of contract.
- 17. BHEL can cancel tender without giving any reason.
- 18. On account of delay in supply of Milk packet, LD will be imposed. Deduction of money from running bill/SD @ 5% of invoice for first time. If delay more than once than LD @ 10% of invoice will be deducted. BHEL may be cancel the contract if delay happens more than three times. Moreover, BHEL shall procure items at vendor's risk & cost.
- 19. Excess quantity & expiry will be returned to the supplier and the cost will be deducted from supplier's bill.
- **20.** The tender must be submitted in two bid system i.e. one technical bid & second price bid. Both bid should kept in separate envelop & both envelop should kept in another envelop with details of tender no & due date. The envelop should have details of vender.
