

1. Enquiry No., due date etc. must be legibly super scribed on the sealed envelopes as per clause no. 2.0 of "Instructions to Bidders" of GCC, Rev. 06.
2. Offers should be submitted in two parts i.e. in two separate sealed covers as follows:
Part-I: TECHNO-COMMERCIAL BID Part-II: PRICE BID

12. **INSTRUCTIONS REGARDING CENTRALISED TENDER ROOM:**

- Vendors are advised to submit the tenders in the tender box, containing Part-I & II offers in separate covers, preferably cloth lined envelopes should be used, properly marked before due date and time.
- The dispatch department shall not accept any tender in torn condition and return the same to the courier immediately with the Stamping "Returned to Sender-Package Damaged". Offers in damaged condition will not be considered and no request for extension on this account will be considered.
- Bidder's representative shall deposit the offer in tender box only.
- Bidders shall be allowed in the tender room in area identified for bidders and only one authorized representative from each bidder shall be allowed.
- Bidder shall not be allowed to carry mobile/camera/ laptop in the tender room. The same shall have to be deposited at security in advance and taken back after tender opening.

13. **Reverse Auction:**

"BHEL reserves the right to go for Reverse Auction (RA) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. All bidders to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

In case BHEL decides to go for Reverse Auction, only those bidders who have given their acceptance to participate in RA will be allowed to participate in the Reverse Auction. Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'online sealed bid' in the Reverse Auction. Non-submission of „online sealed bid" by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue."



24. **We have envisaged installation check for correctness of installation, alignment etc. For installation check and replacement of gland packing with mechanical seal (if applicable as per spec.), 3 nos. visits of 3 days duration each are envisaged in bidder scope.**
The cost of same shall be included by bidder in their base price itself for each project, however break-up for the same shall be given separately as per Schedule of Unit Prices.



For pumps where HT motor is to be free issue by BHEL, HT motor GA will only affect the GA drawing preparation from vendor. Vendor to furnish tentative GA drawing for pump within specified time schedule. Vendor to furnish final GA drawing within 10 days of receipt of Motor GA drawing from BHEL. Bidders to note that HT motors inputs viz. Load Torque vs. speed curves of the pumps, selected motor ratings, rpm, GD2 value of driven equipment furnished along with offer shall be considered final and BHEL may proceed with final motor designs as per same.

Drawings submitted shall be complete in all respects with revised drawing submitted incorporating all comments. Any incomplete drawing submitted shall be treated as non-submission with delays to bidder's account. For any clarification/ discussion required to complete the drawings, the bidder shall himself depute his personal to BHEL for across the table discussions/ finalizations/ submissions of drawings.
