2.	Earnest Money Deposit (EMD) [NIT Clause 1.0 (vii) and GCC Clause 1.9]	Rs. 20,00,000/- (Rupees Twenty Lakh Only)
3.	Price Variation Compensation (GCC clause 2.17)	Applicable. However, PVC Shall Not be applicable on Section-II of BOQ as specified in TCC.
4.	Overrun Compensation (GCC clause 2.12)	Applicable. However, ORC Shall Not be applicable on Section-II of BOQ as specified in TCC.
5. 7.	Retention Amount (RA) (GCC Clause 2.22)	5% of contract value and shall be furnished before the first RA Bill becomes due for payment. On successful bidder's request, the Retention Amount can also be recovered at the rate of 10% of the gross amount, progressively, from each of the running bills of the contractor till the total amount of the required retention amount is collected. RA to be released along with Final Bill.
8.	Reverse Auction (NIT Clause 19.0)	Not Applicable
9.	BOCW Cess (TCC Chapter – VIII, Clause 8.4)	Not to be borne by Bidder.
10.	T&Ps and MMEs	All T&Ps are to be provided by the Contractor as per Chapter-IV of TCC.
11.	T&PS AND MMES to be provided by BHEL on sharing basis	Refer TCC Chapter-V
12.	Labour and Staff Colony	Refer TCC Chapter – III
13.	Construction Power: (Clause 3.2 of TCC Chapter -III)	Construction power (three phase, 415 V/ 440 V) for construction purpose will be provided on free of cost basis . Further, distribution shall be arranged by the contractor at his own cost and services. Construction power (three phase, 415 V/ 440 V) for office, stores, canteen etc. within the site premises will be provided on chargeable basis . Further, distribution shall be arranged by the contractor at his own cost and services.
14.	Construction Water: (Clause 3.3 of TCC Chapter -III)	BHEL may provide water supply (at single point source) for construction purpose on Free of charge basis as and when made available by customer. However, contractor shall make his own arrangement for water supply.
