Sealed tender in prescribed form are invited on behalf of the Bharat Heavy Electrical Limited- CFP- Rudrapur for sale of 64 nos. marked various trees in the factory premises at Kichha by Pass Road, Near FCI Godown, Rudrapur. The work shall involve "Cutting, Uprooting and taking the parts of trees including roots (36 Nos. Trees as mentioned in price Bid, Sl. No. 01) out of the Factory". The Value of 64 Nos. of various trees is estimated Rs. 589973/- (Rupees Five Lakh Eighty Nine Thousand Nine Hundred and Seventy-Three) only.

**Terms and conditions of Limited Tender for sale of 64 nos. various Trees**

- 1- Party (s) quoting **highest Grand Total amount** shall be awarded the sales of tree. However, BHEL-CFP-Rudrapur reserves the right of sale of trees to any party (s) on its sole discretion. The decision of BHEL with regard to any matter on sale of trees shall be final and binding on all parties participating in the tender.
- 2- Tender document should be submitted along with the Earnest Money Deposit (EMD) Rs. 29,500/- in the form of /NEFT/RTGS/Debit Card/Demand Draft of any nationalized bank in favour of "**BHEL Rudrapur**" as participation fees. After completion of Tender process, EMD will be returned to the unsuccessful bidders. EMD of the successful bidder shall be converted & adjusted towards the requirement amount of Security Deposit.
- 3- The party, on award of work, shall submit Security Deposit (SD) equivalent to 10% of total work awarded amount in the form of Bank Draft/Cash in favor of "**BHEL-CFP-Rudrapur**" as advance before start of cutting of trees. After completion of work the SD amount will be returned to the party.
- 4- The party shall arrange necessary Permit, Registration, if any other necessary requirements from Forest Department, Govt. and other local authorities, interested in the work.
- 5- The party who will be awarded the work, in addition to the price quoted shall also pay all applicable taxes and duties, tax, etc. and BHEL shall not entertain any claim what so ever in this respect.
- 6- The vendor who wish to receive GST bill must submit GST certificate.
- 7- The party shall complete the work within one month of award of the work order/ Sale letter failing which penalty @ 1% per week shall be levied on the party subject to maximum of 10% of Sale value, which shall be effected by forfeited the Security Deposit (SD) against the sale of trees. If the work is not completed after expiry of one more month (total 2 months from the award of Sale Order), the work shall be awarded to second party on cost and risk of the party. In addition to the penalty imposed as above, bid security amount (SD) of the first party shall also be forfeited.
- 8- Any damage of loss of property/ material/ man etc. to BHEL while performing the work in factory premises shall be recovered in full from the party.
- 9- The party shall abide by the laws applicable while performing the work in factory premises.
- 10- All disputes arising in connection with the contract shall be settled by mutual consultation. If no agreement is reached the dispute shall be settled in accordance with the provisions of the Arbitration and Conciliation Act, 1996 and the rules made





there under. The dispute shall be referred for arbitration to any arbitrator to be appointed by the Head of the Unit. The award of the arbitrator shall be final and binding on both the Parties. The venue of the Arbitration shall be Rudrapur in India. The Award to be given by the Arbitration shall be a speaking award. All questions, disputes, differences arising under, out of or in connection with this contract shall be to the exclusive jurisdiction of Rudrapur Courts.
