Terms and conditions

1.1 Eligibility Conditions for Bidders:

Bidders should have a valid license taken under Shops and Establishment Act. The license should be issued by statutory authority for Hiring out of AC or Sales/ Service / AMC of AC. Bidders shall preferably have an experience in the air conditioner sales and service business / hiring business of 3 years. Bidders should have a turnover of Rs 5 lakhs per annum in last 2 financial years.

- 1.2 Successful Bidder shall install <u>brand new</u> air conditioners of reputed brands either Hitachi or Panasonic. Air conditioner to be installed should have <u>BEE rating of minimum 2</u>.
- **1.3** Air conditioners other than above mentioned brands will not be accepted for installation.
- 1.4 Capacity and type of AC whether Window/ Split-Wall mounted/ etc shall be decided by
- 1.5 Complete maintenance of air conditioners in good running condition with replacement of spares and related accessories as and when required shall be carried out by successful bidders.
- **1.6** All complaints related to failure or non functioning of the AC shall be attended within 1 working day.
- **1.7** Successful bidders shall do one preventive maintenance and all called-for attendance during every month till the contract is in force.
- **1.8** If necessary, i.e. in the event of non function / faulty functioning of air conditioners successful bidders will arrange to replace the AC at their cost, so as to maintain proper services.
- **1.9** Bid evaluation will be done on basis of lowest submitted offer, for items mentioned in price bid at landed cost to BHEL. Bidders have to submit their quotations for all items in the price bid. Incomplete price bids will not be considered for further evaluation and treated as unqualified.
- **1.10 Earnest Money Deposit:** The bidders have to submit interest free EMD in the envelope containing the Techno-commercial Bid for Rs.20,000/- in the form of Demand Draft / Pay Order drawn in favor of BHEL. The EMD will be refunded to the unsuccessful bidder only after a week of award of contract.
- **1.11 Security Deposit(S.D.):** Successful bidders have to deposit 10 % amount of contract value as security deposit. S.D shall be refunded upon one month of successful completion of contract. The EMD amount of Rs.20,000/- submitted along with the bid

- **1.12 Payments terms:** Bills shall be submitted once in a month for services rendered. Payment shall be made within 15 days of receipt of bills.
- **1.13** Taxes as applicable shall be payable @ statutory rates in force from time to time.
- 1.14 Payment shall be made by ECS/RTGS; successful bidders have to provide their bank details like A/c No, A/c Type, Bank Name, Branch Name, MICR Code, IFSC Code, etc to enable payment. Copy of cancelled cheque to be submitted for providing above required details.
- 1.15 TDS at applicable statutory rates will be deducted and a certificate for deductions made will be issued at the end of financial year. Successful bidders have to provide their PAN no. to enable us remit the TDS amount against the PAN.
- **1.16 Contract validity:** For the period of 2 years from date of award of contract. BHEL will have an option to extend the contract at the same rates, terms and conditions for a further period of one year at its discretion.
- **1.17 Delivery terms**: Air conditioners should be Installed and operational within one week of award of contract /issue of letter of Intent.
- 1.18 BHEL may Increase or decrease the quantity required against different capacities as and when required. In case of increase, charges will be paid separately as per the quoted rates. In case of decrease charges shall be decreased as per quoted rates.
- **1.19 Penalty:** Failure to provide prompt service i.e. within 24 hours of report of problem for continuously 3 times in a month, leads to a penalty of non-payment of hire charges for one 2 ton capacity machine per month.
- **1.20** Any condition not stated above or any uncalled for information shall be ignored.
- 1.21 Any disputes arising out of this enquiry shall be referred to sole arbitration of General Manager / Additional General Manager , BHEL/EMRP Mumbai-93. Or any officer nominated by him and his award shall be binding on the parties.
- **1.22** The venue of arbitration in all cases shall be Mumbai only.
- 1.23 Interested parties shall submit their offer in sealed cover, subscribing "Tender for providing air conditioners on hire" Tender Ref No. and Due date should be mentioned on each cover.

2 PROCEDURE FOR SUBMISSION OF TENDER

2.1 Bidder shall submit the offer in three bid system in two different sealed covers.

- 2.2 Part 'A': Techno-Commercial Bid
- 2.3 Part 'B': Price Bid
- 2.4 Part 'C': EMD
- 2.5 Tender No., date and due date of opening should be written on each covers.
- 2.6 These three covers shall then be placed in a large cover and sealed. The Large cover should also have Tender no., Date and Due Date. This should be dropped in the tender box placed at the entrance of our works before due date and time.
- 2.7 Part 'A' Techno Commercial Bid: Techno Commercial Bid shall contain technical and commercial offer as per NIT Performa, indicating acceptance of NIT terms, as per Annexure-II. Acceptance of all technical and commercial terms and conditions given in the format Annexure II. (No Deviation certificate duly filled in signed as required.
 - 2.8 Part A Any deviation in the above mentioned terms and conditions or conditional offer may render the offer invalid and shall be liable to be rejected, and price bid of such bidders shall not be opened. Price bid of only those bidders shall be opened whose Techno-Commercial offer is found suitable and acceptable. Date of opening of price bid shall be communicated to only those bidders whose Techno-Commercial bid will be accepted.
 - 2.9 <u>Part 'B'</u> Price Bid Part B should contain only the price duly filled in Price Bid Performa Annexure I, without any terms and conditions. Any terms and conditions, if mentioned in the price bid, shall be ignored and not considered.
