2	All Statutory procedure (wage payment, Gate pass, Medical certificate, insurance, PF, UAN, accommodation, Transportation, tiffin allowance etc.) for payment compliance as per govt procedure in the scope of bidder.
3	Welder shall undergo qualification test as per BHEL practice and standard. Billing of welder will be started from successful qualification test by BHEL Engineer.
