A	Scope of work of bidder with, Terms & conditions				
1	Scope broadly covers supervision of application of intermediate & finish paint works as per drawing no: PL:C3-PS/1731/02 , curing, testing, handing over, etc. in line with drawings/ documents/ test procedures approved by BHEL/ customer, compliance of Guarantee/warranty conditions for the total scope defined in the technical specification and terms & conditions of tender, taking into account all clarifications, confirmations for completion of painting at boiler materials of 1x660 MW, Unit # 5 at WBPDC, Sagardighi, West Bengal.				
2	The work shall be executed in a workman like manner and to the entire satisfaction of BHEL Engineer and as per technical specification issued in tender. In case of conflict, the decision of BHEL Engineer shall be final & binding.				
3	Scrap cutting & surface preparation work can be started from the date of intimation in coordination with BHEL site authority. Painting application to be complete within 90 days.				
4	Work includes painting of colour bands, lettering, marking and signs for direction of flow/rotation, names etc of approved colours as per the standard colour codes and specifications specified in tender specification or as advised by BHEL/Customer engineer at site for the equipment / components covered in these specifications.				
5	Surface to be painted should be free of oil and grease. It should be removed by using suitable cleaning agents including permitted solvents. Surface cleaned by chemical agent, if required, shall be treated further as prescribed in use of such cleaning agents.				
6	During the preparation of surface, if the shop coat is damage by chemical cleaning or by mechanical means, contractor shall repair the same free of cost.				
7	Specified drying time shall be permitted from one to another coat. This work requires working at higher altitudes from ground level to as high as 50 mtr and more. The work spread is also substantial involving substantial run of structures and piping. Contractor shall take sufficient precautions to avoid any accident and hazard in all respects. The ropes, ladders, scaffolding materials, clamps etc and climber used should be of standard quality for safe and smooth execution of work.				
8	Contractor shall carry out the work in such a way that other erected equipment, structure, civil foundations and other property are not damaged. For damages in any of such cases due to lapses by Contractor, shall have the right to recover the cost of such damages from the Contractor.				
9	Contractor shall take due care to cover/protect the equipment which are already painted while carrying out the painting of other adjacent equipment. If so happens, it shall be cleaned and repainted by the Contractor without any extra charges.				
10	In general, painting of structural parts and colour bands, lettering, marking of direction of flow/rotation etc will be carried out by brush painting. However, areas/equipment inaccessible for manual painting have to be painted by spray painting.				
11	Final painting work shall be started after obtaining clearance from BHEL engineers and as per his instructions.				
12	Acceptance of Final Painting for required thickness as per painting schedule shall be as per the thickness measured by Alcometer by customer/BHEL Engineer. Contractor shall have to carry out painting till the required thickness is achieved. Painting work will be done as per BHEL FQP like Visual Check, Pinhole Check, Dry Film Thickness Test, Hammering Test etc as mentioed in FQP.				
13	Contractor shall carry out preservation painting. Periodical inspection shall be made as per the instructions of BHEL engineer and the portion of items or the complete items needing painting shall be carried out to the satisfaction of BHEL engineer.				
14	All Statutory procedure (wage payment, Gate pass, Medical certificate, insurance, PF, UAN, accommodation, Transportation, tiffin allowance etc.) for payment compliance as per govt procedure in the scope of bidder.				

15	Schedule of deployment: within 10 days after awarding LOI. LD will be applicable to successful bidder for amounting Rs 5000/ day for delay in deployment is attributable to bidder only.	
16	Schedule of completion: within 90 days after Deployment. LD will be applicable to successful bidder for amounting Rs 1000/ day for delay in achievement of completion of work if delay is solely attributable to agency. Providing front is in the scope of BHEL.
