Technical requirement

- (a). **Drawing Approval:** To be submitted within 15 days Upon ordering, along with signed copy of Manufacturing Quality plan. **Manufacturing:** As per attached specification, Approved drawing, Quality plan and Data sheet. **Inspection:** as per CI (b) below stated. **Dispatch Clearance:** Upon submission of inspection reports (IR) along with test certificates/reports in original and Packing list, accordingly dispatch clearance (MDCC) will be provided by BHEL.
- (b). **Inspection:** Inspection (call to be raise at BHEL CQIR portal) before despatch at supplier's works (as per Quality terms and Quality plan) by BHEL/authorised agency (TPI) for indigenous supplies at BHEL cost. Inspection includes for painting and packing also. All the Test and inspection reports shall be sent to BHEL-Ranipet for review and dispatch clearance.
- (c). **Packing requirement:** Waterproof packing such that No transit damage. Seaworthy packing shall be provided for transit through sea route.
- (d). **Delivery Location:** Site In-charge (BHEL). All the spares shall be sent to Stores-BHEL, BAP-Ranipet.
