Inspection includes for painting and packing also, as applicable. All the Test and inspection reports shall be sent to BHEL-Ranipet for review and dispatch clearance.
- **(c). Packing requirement**: Packing shall be waterproof and inline with the technical specification. The material code with description & Supplier name shall be marked on the packing and to be dispatch to Stores-Incharge, Ward N3, Sub-Delivery Stores-BAP, BHEL-Ranipet 632 406, TN.
- **(d). Documents**: Accepted IR copy along with relevant test certificates (in original) before despatch to be given to BHEL. This is required for Dispatch clearance.
