#### 1. ELIGIBILITY CRITERIA:

- Tenderer should enclose EPF, ESI, PAN, GSTIN New registration no., Income tax returns for last three years (AY 2019-20, 2020-21 & 2021-22) and Profit & Loss account and Balance Sheet certified by the Practicing Chartered Accountant for the last 3 years.
- II) The Contractor should have experience in completion of similar works during the last 7 years ending 28<sup>th</sup> Feb 2022 as given below: -
- (a) Three similar completed works costing not less than the amount equal to 40% of the estimated value (i.e. ₹ 34,750/- each)

(OR)

(b) Two similar completed works costing not less than the amount equal to 50% of the estimated value (i.e. ₹ 43,500/- each).

(OR)

(c) One similar completed work costing not less than the amount equal to 80% of the estimated value (i.e. ₹ 69,500 /-).

Work orders & Job Completion Certificates reflecting work orders and amount from the customer shall be enclosed in support of successful and satisfactory completion of the orders.

#### 2. <u>VENDOR'S SCOPE OF WORK:</u>

a) Local SR of C-seam of C-Seams of Shell, Shell + Dished end as per relevant HTTS including mobilization of required manpower, equipment like Generator, Transformer, Power Supply cables, Element connecting cables, Glass fibre wool, Heating Elements, Calibrated Thermocouples, Temperature Recorders, Other materials required for performing the Local SR etc. and submission of necessary documents & charts to BHEL–QC for inspection clearance and records.

b) Transportation of SR machinery, tools & tackles from vendor's place to BHEL – HPVP works and back to vendor's place after completion of work.

- c) Qualified manpower shall be deployed for proper execution of the job.
- d) Thermocouples / Equipment being used for this work shall be calibrated.
- e) Though not mentioned specifically, any activity which is required for completion of the work is deemed to be included in the scope of work of vendor.
- 3. **BHEL SCOPE:** BHEL shall provide the followings at free of cost:
  - a) Drawings and Heat Treatment Technology Sheet.
  - b) Area and power at one point. Further distribution to work location is to be carried out by the vendor.
  - c) Handling facilities like crane for shifting of job and stands, wherever required.
  - d) Job shall be handed over at Shops of HPVP Visakhapatnam.

# 4. EARNEST MONEY DEPOSIT:

- I. The tenderer shall submit EMD for ₹1,800/- (Rupees One Thousand and Eight Hundred only) in the following forms only: -

#### 5. LOCATION OF WORK:

Local SR is to be carried out at Production Shops in BHEL – HPVP, Visakhapatnam.

Note: The intending tenderers are advised to visit the above place, note down the entry procedures, safety requirements, work permit system etc. and satisfy themselves of all conditions prevailing there before submission of their tenders.

#### 6. INSPECTION:

Inspection shall be carried out by M/s. BHEL-HPVP / TPIA or BHEL approved IA at BHEL-HPVP's works Visakhapatnam as per applicable QAP and relevant documents.

#### 7. CONTRACT PERIOD:

Contract is valid for a period of **6 Months** from the date of work order or intimation from Engineer-in-Charge, whichever is later.

#### 8. DELIVERY:

Local SR is to be completed within <u>3 days</u> per joint after handing over of that particular joint by shop / engineer-in-charge to the vendor.

#### 9. PENALTY:

If delivery exceeds the stipulated delivery schedule, penalty **0.5%** per week subject to a maximum of **10%** on the value of delayed supplies will be levied. However, time taken for the following will not be considered as delay on the part of the vendor.

- a. Intermediate operations carried out by BHEL (Time Period from the date of Handing over to BHEL to the date of Receipt after completion of intermediate operations will be excluded for the LD Calculation)
- b. Waiting time for BHEL / Third party Inspection beyond a normal time of 3 days.

#### 10. PAYMENT TERMS:

Payment will be made after handing over of the finished items duly inspected & cleared by Inspection Authority along with all inspection documents.

100% Payment shall be made within **15 days** from the date of submission of RA/Final Bills. Bills are to be submitted to Engineer-in charge along with following documents:

- b) Job completion certificate issued by the Engineer-in-charge.
- c) Proof of GST payment as per Annexure GST.

#### 11. INCOME TAX:

Income tax as per statutory requirement will be deducted on each payment made to the contractor and TDS certificate will be issued to this effect.

#### 12. TDS ON GST:

TDS on GST amount as per statutory requirement as applicable will be deducted on each payment made to the contractor. Present TDS on GST is 2%.

#### 13. REVERSE AUCTION: Not applicable

#### 14. <u>SECURITY DEPOSIT:</u>

- A. Security deposit means the security provided by the contractor towards fulfilment of any obligations in terms of the provisions of the contract.
- B. The total amount of the security deposit will be **3% of the contract value**. EMD of the successful tenderer shall be converted and adjusted towards the required amount of Security deposit.

#### C. Modes of Deposit:

The balance amount to make up the required Security Deposit of **3%** of the contract value may be accepted in the following forms:

#### D. Collection of Security deposit:

At least 50% of the required security deposit, should be submitted before start of the work. Balance security deposit can be collected by deducting 10% of the gross amount progressively from each of the running bills of the contractor till the total amount of the required security deposit is collected.

Security deposit shall be released to the contractor upon fulfilment of contractual obligations as per the terms of the contract.

#### E. Refund of Security Deposit:

- i. The security deposit shall be refunded after successful completion of the Contract as per agreement and subject to deduction of any amount due to BHEL.
- ii. Security deposit shall not be refunded to the Contractor except in accordance with the terms of the Contract.

- 1) Heat at the rate of 100°C/hr (Max) by electrical means up to the temperature of 610 ± 10°C.
- 2) Soak at 610 ± 10°C for 90 minutes.
- 3) Cool at the rate of 110°C/hr (Max) up to 400°C and controlled cooling rates are not applicable from 400°C.

# GENERAL PRECAUTIONS:

- A. Sufficient number of thermocouples shall be placed in consultation with shop inspector / inspection agency on the vessel at bottom, centre And top of the charge by covering the areas of maximum and minimum thickness and other areas as possible variation. It shall be ensured that distance between any two thermocouples along with length of equipment is not more than 4.6 meters.
- B. Thermocouple (TC) shall be tack welded to the plate on consultation with shop inspector / inspection agency and the same TC shall be removed by grinding.
- C. Material temperature shall be recorded with the help of calibrated automatic recorder and calibrated thermocouples only.
- D. During heating period, the temperature difference shall not exceed 138°C over any length of 4.6 metres.
- E. Technology department shall incorporate necessary precautions to be followed in shop floor to avoid distortion.
