PRE QUALIFICATION REQUIREMENTS

The following conditions have to be satisfied by the tenderer, with documentary proof to be enclosed with tender bid (Technical):

i) Average annual financial turnover during the last 3 years, ending 31st March of the previous financial year (should submit balance sheet & P&L account for last 3 years – preferably certified by Chartered Accountant), should be at least 30% of the estimated cost. Further, the tenderer fail to submit the figure (s) for 3 years, non-submitted year will be considered as “0” (Zero) for averaging the turnover. In the 3 years turnover, previous year turnover is compulsory.

ii) Particulars of experience / credentials for the works executed of similar nature during not older than 7 years (Completion and experience certificate of the works to be enclosed) ending last day of month previous to the one in which applications are invited should be either of the following:

a. Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

GENERAL TERMS & CONDITIONS

1. BHEL, Ramachandrapuram, Hyderabad a Maharatna PSU needs **Maruti Swift Dzire 1197 CC VXi MT / equivalent for 2000 KM per month @24hrs per day on all days including Sundays and holidays** for official use of Head of the Unit (HOU) – PE&SD in BHEL, RC Puram, Hyderabad. The Car should be of **2018 or later model** and should be in good working condition. KM run should not exceed **30,000 KM**.
2. Contractors in possession of above car, should submit vehicle documents at the time of submission of tender.
3. Contractors **not in possession** of above car can also take part in the tender by submitting the undertaking at Annexure II.
4. Ownership of vehicle has to be in the name of Individual/Proprietor / Proprietary Firm / Partner /Partnership Firm / Director / Limited Company. Right to use of vehicle for the contract period shall be registered in the name of proprietor / proprietary firm / partner / partnership firm / Director / Limited company.
5. The Fuel, Maintenance, Road tax, Insurance, Fitness & PUC costs shall be in the scope of contractor only.

ANNEXURE-I

Terms & conditions for entering into rate contract for “Hiring of Maruti Swift Dzire 1197 CC VXi MT / equivalent for HOU-PE&SD” for a period of 1 year for the use of BHEL, RC Puram, Hyderabad – 502 032.

1. The basic rate per month and Extra kilometer rate is to be quoted in Annexure-III.
2. **Once the contract is finalized, the car shall be at the operational disposal of BHEL during the entire period of contract @ 24 hours per day, including extensions, if any.**
3. The Car shall be of **January 2018 or later model. KM run should not exceed 30,000 KM.**
4. Daily mileage will be mailed on the next working day to the Contractor’s official email ID. Contractors will be authorized to verify the meter readings on a weekly basis.
5. Minimum basic rate plus extra KMs., if any (**Beyond 2000 KM. / Month**) only will be paid along with applicable taxes.
6. **The minimum rental charges will be paid as per the basic rate quoted for 2000 Kms. per month, irrespective of the actual mileage. Extra Kms. will be reckoned only in case the usage exceeds 2000 KMs. in a calendar month. The first & last claim / bill will be calculated on prorata basis.**
7. Billing cycle will be on monthly basis and payment will be released through NEFT within 25 days of submission of bills.
8. All the offers received will be scrutinized and only the technically qualified offers will be considered.
9. All entries in the tender should be clearly written in ink and all corrections are to be duly attested by the tenderer.
10. Issue of tender documents does not mean that the bidder fulfills the qualifying requirements of the contract.
11. Submission of offer shall mean that the bidder has read the bid documents and agrees to abide by the terms and conditions mentioned in the documents.
12. The contractor will take comprehensive insurance for the vehicle at his own cost.
13. Quotation should be valid for a period of four months from the date of opening of Bid.
14. **The contractor shall make available a relief vehicle of Hiring of Maruti Swift Dzire 1197 CC VXi / Equivalent / higher model immediately in the event of any breakdown or accident. Such relief car will be subject the same conditions of maintenance and compliance with statutory requirements as those covered in the original contract.**

15. The Transport contractor should obtain at his own cost, all required permits, fitness & pollution certificate etc., and its renewals for running the Maruti Suzuki Maruti Swift Dzire 1197 CC VXi MT / equivalent car without break or any type of difficulty during the entire period of contract. Failure to maintain these requirements will entail BHEL for cancellation of the contract forfeiture of security deposit.
16. EMD furnished by the successful bidder will be adjusted as part security deposit towards contract performance guarantee and shall be refunded within three months of the date of expiry/completion/revocation of the contract. In the event of the agency failing to comply with any provision of the contract, the security deposit shall be forfeited by BHEL.
17. Successful tenderer shall pay a Security Deposit (maximum of 5% of contract value) as per the works policy 2016 which shall be indicated while issuing workorder / LOI.
 - a. The successful tenderers EMD paid will be converted and adjusted into Security Deposit.
 - b. Minimum 50% of the Security Deposit amount should be paid by Demand Draft/NEFT at the time of agreement and before commencing the contract, balance 50% to be recovered from Monthly bills to the Maximum of 10% of the Total Contract value.
 - c. The Security Deposit will not carry any interest and will be paid after successful completion of contract to BHELs satisfaction.
18. If the transport contractor is not able to provide his Maruti Suzuki Maruti Swift Dzire 1197 CC VXi MT / equivalent car continuously, alternate arrangement will be made by BHEL and the extra cost incurred will be recovered from the transport contractors pending bills in BHEL RC Puram or any of its Sister units/ROD's/Sectors.
19. The Maruti Swift Dzire 1197 CC VXi MT / equivalent car should be registered and duly insured i.e. comprehensive insurance and the same should be renewed from time to time during contract period at his own cost.
- 20. The contract once finalized will be valid till the completion of contract. The contract can be extended further on same scope, rates, terms and conditions on mutual agreement. The extension period shall be as per BHEL works policy prevailing at the time of contract completion.**
21. The rates quoted shall remain valid for entire contract period including extension, if any.
22. A total of 5% of awarded contract value should be paid as security deposit for faithful completion of work.
23. The transport contractor shall submit his bills on 5th day of the following month. The trips will be authorized by the user or transport pool authorities. In case the bills are not submitted by 5th of the following month, these bills cannot be settled in the month in

24. The orders, notices or any correspondence to the transport contractor will be sent to the address furnished by registered post. This is deemed to have been served on the transporter, on date of report of delivery of such correspondence. The transport contractor shall carry out the orders without any delay.
 25. Soon after the acceptance of the tender, the transport contractor shall enter into an agreement with M/s BHEL, RC Puram, Hyderabad – 502 032. The agreement shall be entered on Non-judicial stamp paper of the value of Rs.200/- to be purchased by the transport contractor at his own cost.
 26. The contractor shall maintain regular contact with the designated employee of BHEL and will interact on matters relating to the work awarded under this contract.
 27. Notwithstanding anything contained in the contract agreement which will be entered after award of work, the contract may be terminated by BHEL, without assigning any reason thereof by giving a notice of 30 days to the contractor.
 28. The orders, notices or any correspondence to the transport contractor will be sent by registered post to the address furnished. This is deemed to have been served on the transporter, on date of report of delivery of such correspondence. The Transport Contractor shall carry out the orders without any delay.
 29. The contractor shall not resort to subcontracting under any circumstances. If found subcontracting at a later date, BHEL reserves the right to take whatever action it deems fit, including cancellation of the contract.
 30. Whenever the term — CONTRACTOR is used, it shall be understood to refer to the particular person, firm or corporation with whom an agreement has been made by the concerned company official for executing the work defined in the concerned agreement and for the purpose of instructions regarding compliance with contract conditions, it shall include the contractor's authorized agents, who are entrusted with the work by contractor.
 31. All the works shall be carried out in accordance with the directions and to the satisfaction of the company official in accordance scope of work.
 32. In the event of any question or dispute or under this contract, the same shall be referred to a competent Authority in the company for sole arbitration and his decision shall be final and binding on the parties to the contract.

33. In case of any suit or other legal proceeding arising under this contract, the courts at Sangareddy (Medak Dist.) Telangana only shall have the Jurisdiction.
34. Wherever, BHEL/COMPANY standards are mentioned, the same shall be strictly followed.
35. Nothing contained in the contract agreement and its conditions shall be deemed to preclude or render inoperative the service of any notice, letter or other communication upon the contractor personally.
36. All disputes, claims and demands arising in connection with the contract shall be settled by mutual consultation. If no such agreement is reached between the parties each party can appoint one Arbitrator and the Arbitrators so appointed can appoint a Presiding Arbitrator. The proceedings of the tribunal shall be in accordance with the provisions of the Arbitration and Conciliation Act, 1996 and the rules made there under. The venue of the Arbitration shall be at BHEL, Hyderabad or at such place as the Arbitrators may direct. The Award to be given by the Arbitral Tribunal shall be a speaking award. The arbitration costs, fees and expenses shall be borne by both the parties equally. The award of the tribunal shall be final and binding on both the parties equally. The award of the tribunal shall be final and binding on both the parties. All questions, disputes, differences arising under, out of or in connection with this contract shall be exclusive jurisdiction of the Courts at Sangareddy, Medak District, Telangana.
37. Tax will be deducted at source from the running bills as per applicable income tax rules and other statutory requirements.
38. **FINALIZATION OF TENDER:** The bids of all the vendors would be opened and the L1 party would be decided on basic cost. If L1 rates are greater than our estimation, negotiation will be carried out and rates shall be finalized. If there is a tie in the basic cost, then the rate quoted for extra Km. (beyond 2000 Kms.) will be considered for breaking the tie. If there is a further tie, the model of the car will be considered for evaluation of tender.
39. **PENALTY CLAUSE:** A penalty equivalent to payment per day shall be recovered from the bills, in case the vehicle is under break down.
40. Any discrepancies in the tender documents shall be brought out separately on a letter.
41. ***Price Variation Clause(PVC):****The rates quoted shall remain valid for entire contract period. However reimbursement or recovery will be made for increase/decrease only in the cost of fuel. No other variation other than cost of fuel will be allowed by BHEL during the tenure of the contract period. The escalation is based on the fuel cost on the date of opening of technical bids. Escalation for increase/decrease in fuel cost will be reimbursed or recovered at the rate of 0.0071 rupee per KM for every 10 paise per litre increase/decrease in fuel cost (Prevailing on the last day of the calendar month). The escalation is applicable at actual KM run for reimbursement/recovery.*
