## ANNEXURE-T1

### DETAILED SCOPE OF WORK & TECHNICAL SPECIFICATIONS

#### **1. GENERAL REQUIREMENTS**

- 1.1 Job will be provided by BHEL on V-Blocks.
- 1.2 Refer drawings given in **NIT Page No.12, 13 & 14** for dimensions of the job.
- 1.3 The contractor should employ blasters & painters with experience in blasting and spray painting process.

#### **2. PRE-TREATMENT**

- 2.1 Cleaning of entire outer surface of Header to make the surface free from oil, grease and other external contaminants.
- 2.2 Surface shall be thoroughly cleaned using solvents like Acetone / Trichloroethylene / any other equivalent petroleum solvents.
- 2.3 Inspection of surface by BHEL & NPCIL to ensure removal of grease / oil by Water Film Break Test (Water film break test is performed by wetting the surface with water and observing the pattern of wetting).
- 2.4 The areas, where the water is not uniformly wetting and shattering into tiny droplets shall be further cleaned with alkaline degreasing agent.
- 2.5 Only those areas cleaned with alkaline degreasing agent shall be rinsed with water till the surface is free of alkali and then dried. Water film break test shall be further conducted in these areas to ensure the total removal of grease / oil.

#### **3. SHOT BLASTING**

- 3.1 Blasting of the surface to a surface finish of Sa 2 ½.
- 3.2 Optimum performance can be achieved by Blast Cleaning to Sa 2½ with suitable blast medium. No Copper slag is permitted.
- 3.3 After blasting, metal substrate shall be kept free from dust by cleaning with compressed air of the blast cleaning equipment by closing the grit/shot hose valve, no other cleaning shall be permitted.
- 3.4 Visual inspection for cleanliness of surface shall be carried out by comparing the blast cleaned surface with reference photograph/s of SSPC-VISI.
- 3.5 Profile achieved after blast cleaning of external surface shall be measured using profile comparator or surface profile gauge and recorded.
- 3.6 Inspection of surface finish shall be done by BHEL/NPCIL.

#### **4. POWER TOOL CLEANING**

- 4.1 Wherever blast cleaning is not practically possible due to design or product configuration power tool cleaning shall be done by mechanical surface preparation methods like hand grinding, wire brushing, disc sanders etc. to minimum St3 grade.
- 4.2 Suitable methods are hand grinding, power tools like wire brushing & disc sanders. Ensure the surface is free from mill scale, residual corrosion, failed coating and is suitable for painting. During power tool cleaning / wire brushing, care shall be taken to avoid the risk of polishing the surface. The surface shall appear rough and matt.

**5. PAINTING (DFT 40 MICRONS)**

- 5.1 'Airless Spray painting' process shall be used for painting with Heat Resistant Aluminium Paint Grade II.
- 5.2 First coat of painting shall be applied by spray within 4 hours of inspection clearance of surface preparation.
- 5.3 First coat shall be applied and should be allowed to cure for 48 hours.
- 5.4 The Dry Film Thickness (DFT) check to ensure DFT shall not be less than 20 microns after first coat.
- 5.5 Second coat of the above paint to be done after 48 hours of first coat, and to be cured for minimum 24 hours.
- 5.6 DFT of the two coats (cumulative) shall not be less than 40 microns.
- 5.7 In case the measured DFT of coating surface is not adequate, in some locations it shall be roughened by manual cleaning (emery paper, wire brushing etc) then touch up painting shall be done preferably by spray or brush to the required DFT as specified above.
- 5.8 Peel off test shall be done by BHEL.
- 5.9 Painting is not permitted, when there is a rain, fog, mist or sandstorm and when temperature falls below 10deg C or rises above 50deg C and when relative humidity rises above 85%.
- 5.10 Paint shall be applied with skilled painter only.
- 5.11 The finished coating surface shall be free of runs, sags, dimples, foreign particles or other defects.

**6. SCOPE OF BHEL**

- 6.1 Sufficient quantity of Heat Resistant Aluminum Paint to IS: 13183 Gr-II will be provided.
- 6.2 Power for lighting and other requirements shall be provided at single point near the job
- 6.3 Required quantity of Acetone, degreasing powder (maxi clean), Cotton waste, White cloth for pre treatment
- 6.4 Tools such as grinding machine, buffing wheels, emery papers for power tool cleaning, wherever required.

**7. SCOPE OF VENDOR**

- 7.1 Suitable Air compressor to supply the required pressurised air for operating the Shot blasting and Airless painting equipment.
- 7.2 All tools / equipment, consumables and raw materials required for blasting and spray painting such as
  - 7.2.1 Shot blasting equipment with adequate hoses with fittings.
  - 7.2.2 Adequate quantity of fresh steel shots and grits (copper slag should not be used)
  - 7.2.3 Airless spray painting equipment
  - 7.2.4 Paint stirring equipment
  - 7.2.5 Roller brushes and painting brushes
- 7.3 Necessary safety and personnel protective equipment.
- 7.4 Required exhaust fans & lighting arrangements with cables.

- 7.5 Required skilled & experienced manpower for blasting and spray painting.
- 7.6 Three shifts to be operated with minimum two blasters per shift and required helpers.
- 7.7 One supervisor/shift to be present throughout till completion of job for all necessary coordination
- 7.8 Pretreatment, blasting and painting to be completed as per the schedule given by BHEL.
- 7.9 Painters should be available for touch up work till packing of header.
- 7.10 Each painter is expected to know about the safety of self and surroundings, use of safety appliances, effect of solvent vapors on health etc. He is supposed to know personal hygiene as well as upkeep of painting equipment and painting area.
- 7.11 The painter should have the practical knowledge about surface cleaning and acceptance norms, paint systems, drying and curing behavior, use of proper thinner, control of viscosity and its importance, over coating interval, precautions to be observed during painting. Handling and upkeep of painting equipment like, selection of spray gun, adjusting spray pressure, painting environment, cleaning of brush, gun and other parts of equipment.
- 7.12 All shots/grits to be completely cleaned and collected after completion of blasting. Area to be completely cleaned when scaffolding is removed after completion of job
- 7.13 Pretreatment, Surface preparation and Painting as per the BHEL “procedure for painting of Reactor Header Assemblies – Doc. No. PR:CHEM:07-45 Rev01” is in vendor scope.
- 7.14 Availability of the vendor at BHEL for the sub-contracted works shall be ensured without fail – intimation about the readiness of the job will be provide to the vendor well in advance (~7 days).
- 7.15 Examination as given in the Doc. No. PR:CHEM:07-45 Rev01 is in vendor scope, final acceptance is with BHEL.
- 7.16 Rework if any based on the examination is in Vendor scope.

**1.0 SCOPE:**

- 1.1 The following procedure details the methods for pretreatment, surface preparation and painting of the exterior surface of nuclear reactor header assemblies.

**2.0 PRETREATMENT:**

- 2.1 The component shall be inspected thoroughly prior to painting to ensure that the surface is free from grease, oil and other external contaminants.
- 2.2 The surface shall be thoroughly cleaned using solvents like Acetone/ Trichloroethylene/any other equivalent Petroleum solvents.
- 2.3 Inspection shall be carried out for the total removal of grease/ oil by water film break test (Water film break test is performed by wetting the surface with water and observing the pattern of wetting).
- 2.4 The areas, where the water is not uniformly wetting and shattering into tiny droplets, shall be further cleaned with alkaline degreasing agent.
- 2.5 After complete degreasing, the surface shall be rinsed with water till the surface is free of alkali and then dried. Water film break test shall be further conducted to ensure the total removal of grease/oil.

**3.0 SURFACE PREPARATION:**

**3.1.0 Blast cleaning to Sa 2½**


- 3.1.1 The required quality of surface preparation can vary depending on the area of use, expected durability and if applicable, project specification.
- 3.1.2 Optimum performance can be achieved by blast cleaning to Sa 2½ with a suitable blast medium.
- 3.1.3 After blasting, metal substrate shall be kept free from dust by cleaning with compressed air of the blast cleaning equipment by closing the grit/shot hose valve, no other cleaning shall be permitted.

**3.2.0 Inspection for blast cleaning:**

- 3.2.1 Visual inspection for cleanliness of surface shall be carried out by comparing the blast cleaned surface with reference photograph/s of SSPC-VIS1.
- 3.2.2 Profile achieved after blast cleaning of external surface shall be measured using Profile comparator or Surface profile gauge and recorded.

### 3.3.0 Power Tool Cleaning

- 3.3.1 Wherever blast cleaning is not practically possible due to the design or product configuration, Power tool cleaned shall be done by mechanical surface preparation methods to minimum St3 grade.
- 3.3.2 Suitable methods are hand grinding, powered tools like wire brushing & disc sanders. Ensure the surface is free from mill scale, residual corrosion, failed coating and is suitable for painting.
- 3.3.3 Power wire brushing shall be taken care to avoid the risk of polishing the metal surface. The surface should appear rough and matt.


### 4.0 PAINTING:

- 4.1 The first coat of heat resistant Aluminium paint as per IS 13183 Gr.II, which withstands the temperature of 400°C shall be applied by spray, within 4 hours of surface preparation.  
( If primer is required to be applied as per selected paint manufacturer's recommendation, the same shall be applied prior to finish paint)
- 4.2 The paint film shall be allowed to cure for 48 hrs.
- 4.3 The dry film thickness (DFT) shall not be less than 20 microns.
- 4.4 The second coat of the above paint shall be applied after 48 hours of first coat, and allowed to cure for minimum 24 hours.
- 4.5 The DFT of the two coats (cumulative) shall not be less than 40 microns. In case the measured dry film thickness of coating surface is not adequate, it shall be roughened by manual cleaning (emery paper, wire brushing etc.,) then touch up painting shall be done by brush to the required DFT as specified above.
- 4.6 Instrument used for DFT measurement & its calibration details to be indicated in the report.
- 4.6 Do not paint when there is a rain, fog, mist or sandstorm. Do not paint when temperature falls below 10<sup>0</sup>C or rises above 50<sup>0</sup>C and when relative humidity rises above 85%. Paint shall be applied with skilled painter only.
- 4.7 The painter should have the practical knowledge about surface cleaning and acceptance norms, paint systems, drying and curing behavior, use of proper thinner, control of viscosity and its importance, over coating interval, precautions to be observed during painting. Handling and upkeep of painting equipment like, selection of spray gun, adjusting spray pressure, painting environment, cleaning of brush, gun and other parts of equipment.

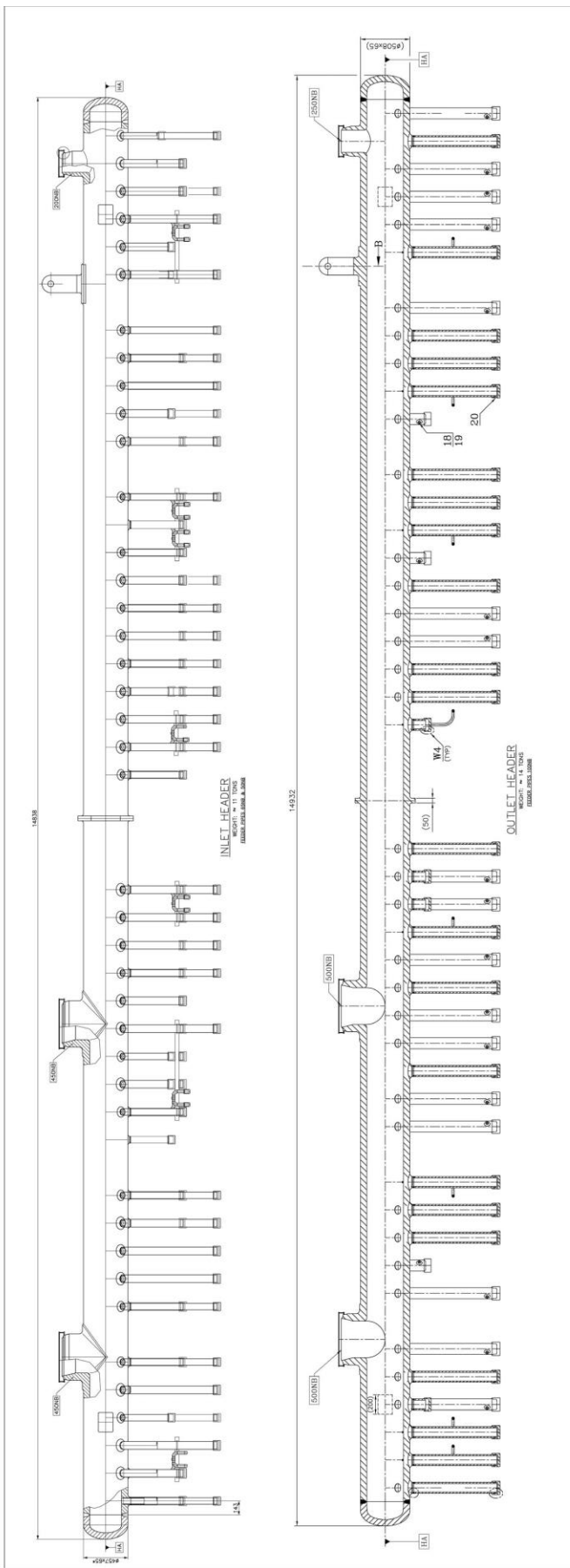

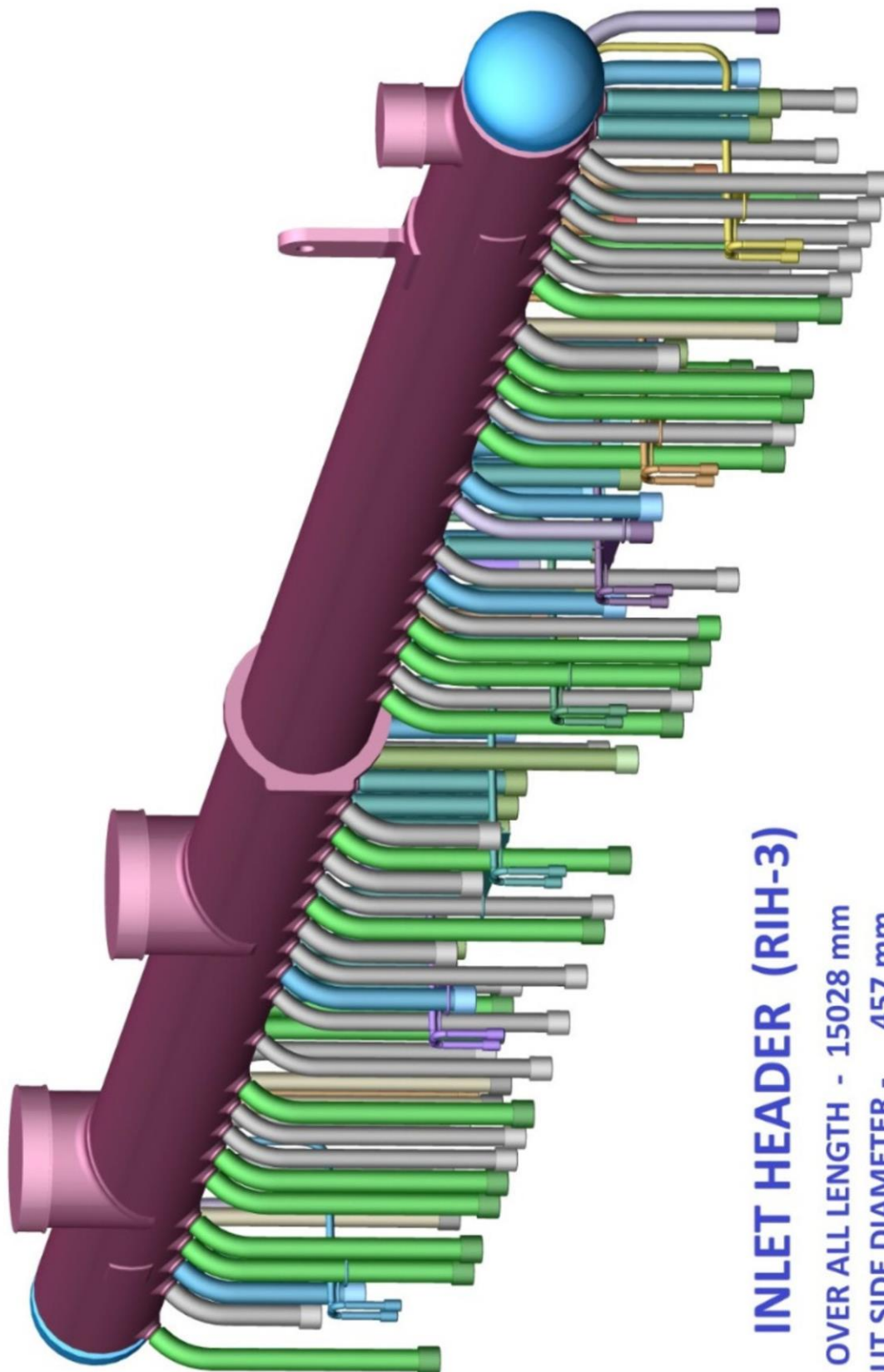

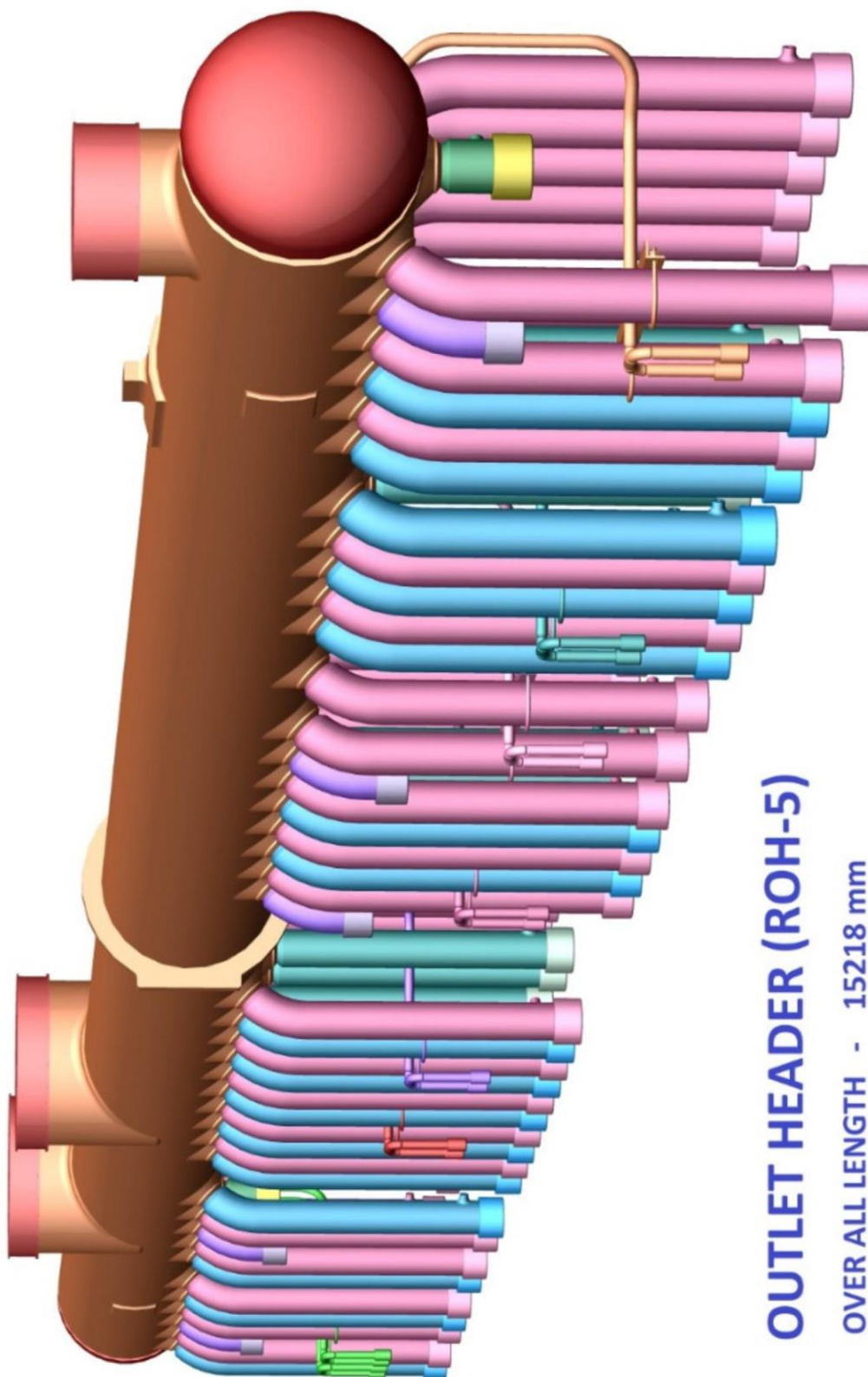

## ANNEXURE-T2

### SPECIAL TERMS AND CONDITIONS OF THE CONTRACT

#### **1. DURATION OF CONTRACT:**

1.1 The period of contract is **Two Years** from the date of award of contract.

#### **1. PRICE VARIATION CLAUSE**

1.1 Fixed price: Prices quoted by the bidder shall be fixed and not subject to any escalation whatsoever during the period of bid validity and execution of the Purchase Order. A bid submitted with an adjustable price will be treated as non - responsive and rejected

#### **2. LIQUIDATED DAMAGES (LD) / PENALTY:**

2.1 Vendor shall mobilize / arrange all the resources before 24 Hrs. of allotment of job. i.e. 7 days' notice time will be given and on the 6<sup>th</sup> day (24 Hrs. before) the vendor has to mobilize / arrange all the resources

2.2 Work completion duration for each header shall be 5 days from the allotment of the job.

2.3 Penalty @ 0.5 % of total order value per week of delay in execution of work as per scope of work or part thereof subject to maximum of 10 % of total order value. In case of any amendment / revision, LD shall be linked to amended / revised PO value.

#### **3. TERMS OF PAYMENT:**

3.1 All payments to be made to the contractor, shall be through NEFT (National Electronic Fund Transfer) / RTGS (Real Time Gross Settlement) within reasonable time, as given below, after the certification of bills by the end user / executing agency.

3.2 If UDYAM Certificate not submitted substantiating the same, payment will be processed in Non MSME basis

3.3 The agency shall raise the bill for claiming service amount and shall be routed through area in-charge/BHEL, the area where service was rendered. The payment would be effected only after recommendation from area in-charge for satisfactory completion of such service.

3.4 No advance payment shall be paid to the agency for service,

3.5 If Goods and Services tax (GST) has been paid by the agency, proof of same is required with the invoice to avoid deduction from our end.

3.6 Agency shall mention their GSTN registration number in all their invoices and invoices shall be in the format as specified/prescribed under GST laws for processing the bills on monthly basis.

3.7 Statutory deduction like IT etc. will be deducted from contractor payment as required by Law.

#### **4. INCOME TAX:**

4.1 Income Shall be deducted at the applicable rate in respect of the service contract including supply of labour for any work as follows:

- 4.2 Self-attested copy of PAN card shall be submitted to Account Dept. along with original for verification.
- 4.3 TDS Certificate will be issued to vendors for each quarter ending as on 30th June, 30th Sept, 31st Dec and 31st Mar during the following quarter.

**5. GST:**

- 5.1 Wherever GST is liable to be paid by the contractor, the contractor shall register himself under the GST Rules and a Self-attested copy of Certificate of Registration shall be furnished to Account Dept.
- 5.2 After registration, the payment of GST shall be effected by the contractor to the Central Government monthly/quarterly based on the invoices raised before the due date of payment. The GST Return also shall be submitted to the Government before the due date.
- 5.3 The invoice/bill in original duly signed by the contractor claiming the payment for GST shall clearly indicate the following:

If the dealer is exempted from GST registration, a declaration with due supporting documents need to be furnished for considering the offer. Dealers under composition scheme should declare that he is a composition dealer supported by the screen shot taken from GSTN portal.
- 7.2 The dealer has to submit necessary documents if there is any change in status under GST.
- 7.3 Supplier shall mention their GSTIN in all their invoices (incl. credit Notes, Debit Notes) and invoices shall be in the format as specified/prescribed under GST laws. Invoices shall necessarily contain Invoice number (in case of multiple numbering system is being followed for billing like SAP invoice no, commercial invoice no etc., then the Invoice No. which is linked/uploaded in GSTN network shall be clearly indicated), Billed to party (with GSTIN) & Shipped to party details, item description as per PO, Quantity, Rate, Value, applicable taxes with nomenclature (like IGST, SGST, CGST & UTGST) separately, HSN/ SAC Code, Place of Supply etc. Wherever E-Invoice is applicable, the tax invoice/ CN / DN submitted by the vendor must contain the QR code generated in E-Invoice Portal & IRN.

- 7.4 All invoices shall bear the HSN Code for each item separately (Harmonized System of Nomenclature)/ SAC code (Services Accounting Code)
- 7.5 Invoices will be processed only upon completion of statutory requirement and further subject to following:
- 7.5.1 Vendor declaring such invoice in their GSTR-1 Return/ IFF
- 7.5.2 Receipt of Goods or Services and Tax invoice by BHEL
- 7.6 As the continuous uploading of tax invoices in GSTN portal (in GSTR-1/ IFF) is available for all (i.e. both Small & Large) tax payers, all invoices raised on BHEL may be uploaded immediately in GST portal on dispatch of material /rendering of services. The supplier shall ensure availability of Invoice in GSTN portal before submission of invoice to BHEL. Invoices will be admitted by BHEL only if the invoices are available in GSTN portal (in BHEL's GSTR-2A/ GSTR-2B).
- 7.7 In case of discrepancy in the data uploaded by the supplier in the GSTN portal or in case of any shortages or rejection in the supply, then BHEL will not be able to avail the tax credit and will notify the supplier of the same. Supplier has to rectify the data discrepancy in the GSTN portal or issue credit note or debit note (details also to be uploaded in GSTN portal) for the shortages or rejections in the supplies or additional claims, within the calendar month informed by BHEL.
- 7.8 In cases where invoice details have been uploaded by the vendor but failed to remit the GST amount to GST Department (Form PMT-08 or Form GST RET-01 to be submitted) within stipulated time, then GST paid on the invoices pertaining to the month for which GST return not filed by the vendor will be recovered from the vendor along with the applicable interest (currently 24% p.a) and all subsequent bills of the vendor will not be processed till filing of the GST return by the vendor
- 7.9 In case GST credit is denied to BHEL due to non-receipt or delayed receipt of goods and/ or tax invoice or expiry of timeline prescribed in GST law for availing such ITC, or any other reasons not attributable to BHEL, GST amount claimed in the invoice shall be disallowed to the vendor.
- 7.10 Where any GST liability arising on BHEL under Reverse Charge (RCM), the vendor has to submit the invoices to BHEL well within the timeline prescribed in GST Law, to enable BHEL to discharge the GST liability. If there is a delay in submission of invoice by the vendor resulting in delayed payment of GST by BHEL along with Interest, then such Interest payable or paid shall be recovered from the vendor.
- 7.11 GST TDS will be deducted as per Section 51 of CGST Act 2017 and in line with Notification 50/2018 –Central Tax dated 13.09.2018. GST TDS certificate will be generated in GSTN portal subsequent to vendor accepting the TDS deduction in the GSTN portal & the vendor can directly download the Certificate from the GSTN Portal.

## **8. FORCE MAJEURE CLAUSE:**

- 8.1 If, at any time during the continuance of this Contract the performance in whole or in part by either party of any obligations under this Contract shall be prevented or delayed by reason of any War, Hostile acts of the public enemy Civil Commotion, Epidemics, or Acts of God (Floods, Storm/Cyclone, Hurricane, Earth Quake etc.) then provided notice of happening of any such event is given by either party to other within 7 days from the date of occurrence therefor neither party shall by reason of such event be entitled to terminate this Contract nor shall either party have any claim for damages against the other in respect of such non-performance and delay in performance under the Contract shall be resumed as soon as practicable after such event has come to an end or ceased to exist. If the performance in whole or part of any obligation under this Contract is prevented or delayed by reason of any such event, claims for extension of time shall be granted for periods considered reasonable by BHEL subject to prompt notification by the Contractor.

## **9. INDEMNITY:**

- 9.1 The Contractor shall have to indemnify BHEL against all claims for injury or damage to any person or property caused by his negligence or negligence of his employees whilst in BHEL premises / sites.

## **10. INSURANCE POLICIES**

10.1 The Contractor shall at his own cost take insurance and maintain at all times until the close out of the Contract, insurance policies in respect of equipment and workmen engaged by him for providing services under this Contract.

## **11. NOTICES OF ACCIDENTS:**

11.1 In the event of an accident the contractor shall be required to fill injury report and submit to the Engineer In-charge immediately and ensure compliance of ESI / Workmen's Compensation of accident as per the Act.

## **12. SAFETY CONDITIONS & GUIDELINES**

12.1 The Factories' Act, 1948:

12.1.1 Section 32: Floors, stairs and means of access shall be properly maintained to ensure safety. Every place of working should have safe access. When any person has to work at a height from which he is likely to fall, provision shall be made, so far as is reasonably practicable, by fencing or otherwise, to ensure the safety of person so working.

12.2 Tamil Nadu Factories' Rules, 1950

12.2.1 Rule 55: Hoists and Lifts & Rule 55A. Lifting machines, chains, ropes and lifting tackles: Shall be maintained in good condition, thoroughly inspected and examined by competent persons and records to be maintained.

12.2.2 Rule 57: Excessive Weights: No person shall, unaided by another person, lift, carry or move by hand or on head, any material, article, tool or appliance exceeding the maximum limit in weight set out in the schedule (50 kg for adult male and 30 kg for adult female).

12.2.3 Rule 61E: Machinery and plant: No machinery, plant or equipment shall be constructed, situated, operated or maintained in any factory in such a manner as to cause risk of bodily injury.

12.2.4 Rule 61F: Methods of Work: No process or work shall be carried on in any factory in such a manner as to cause risk of bodily injury.

12.2.5 Rule 61G: Stacking and storing of materials etc.: No materials or equipment shall be stacked or stored in such a manner as to cause risk of bodily injury.

- 12.2.9 Rule 96: Notification of accidents: Shall be complied with as required in the Factories Act (Section 88 and Section 88A) and Tamil Nadu Factories Rules.

**13. PREFERENCE TO MAKE IN INDIA:**

- 13.1 For this procurement, the local content to categorize a supplier as a Class I local supplier/ Class II local Supplier/ Non Local supplier and purchase preference to Class I local supplier, is as defined in Public Procurement (Preference to Make in India), Order 2017 dated 04.06.2020 issued by DPIIT. In case of subsequent orders issued by the nodal ministry, changing the definition of local content for the items of the NIT, the same shall be applicable even if issued after issue of this NIT, but before opening of Part-II bids against this NIT.

**14. BHEL'S FRAUD PREVENTION POLICY**

- 14.1 The Bidder along with its associate/ collaborators/ sub – vendors/ consultants/ service providers shall strictly adhere to BHEL Fraud Prevention Policy displayed on BHEL website <http://www.bhel.com> and shall immediately bring to the notice of BHEL Management about fraud or suspected fraud as soon as it comes to their notice. Fraud Prevention policy and List of Nodal Officers shall be hosted on BHEL website, vendor portals of Units / Regions intranet.

**15. BHEL'S GUIDELINES FOR SUSPENSION OF BUSINESS DEALINGS WITH SUPPLIERS / CONTRACTORS:**

- 15.1 Penal action can be initiated on the suppliers / Contractors in line with extant 'Guidelines for Suspension of Business Dealings with Suppliers/ Contractors'. The abridged version of extant 'Guidelines for suspension of business dealings with suppliers/ contractors' has been uploaded on <http://www.bhel.com> on "supplier registration page".
- 15.2 The offers of the bidders who are under suspension as also the offers of the bidders, who engage the services of the banned firms, shall be rejected. The list of banned firms is available on BHEL web site [www.bhel.com](http://www.bhel.com).

**16. INTEGRITY COMMITMENT, PERFORMANCE OF THE CONTRACT AND PUNITIVE ACTION THEREOF:**

- 16.1 Commitment by BHEL: BHEL commits to take all measures necessary to prevent corruption in connection with the tender process and execution of the contract. BHEL will during the tender process treat all Bidder(s) in a transparent and fair manner, and with equity.
- 16.2 Commitment by Bidder/ Supplier/ Contractor: The bidder/ supplier/ contractor commit to take all measures to prevent corruption and will not directly or indirectly influence any decision or benefit which he is not legally entitled to nor will act or omit in any manner which tantamount to an offence punishable under any provision of the Indian Penal Code, 1860 or any other law in force in India.
- 16.3 The bidder/ supplier/ contractor will, when presenting his bid, disclose any and all payments he has made, and is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the contract and shall adhere to relevant guidelines issued from time to time by Govt. of India/ BHEL.

**17. COMPENSATION CLAUSE FOR CONTRACTS VALUING ₹5 LAKHS AND ABOVE.**

- 17.1 BHEL shall recover the amount of compensation paid to victim(s) by BHEL towards loss of life / permanent disability due to an accident which is attributable to the negligence of contractor, agency or firm or any of its employees as detailed below.
- 17.1.1 Victim: Any person who suffers permanent disablement or dies in an accident as defined below
- 17.1.2 Accident: Any death or permanent disability resulting solely and directly from any unintended and unforeseen injurious occurrence caused during the manufacturing / operation and works incidental thereto at BHEL factories/ offices and precincts thereof, project execution, erection and commissioning, services, repairs and maintenance, trouble shooting, sewing, overhaul, renovation and retrofitting, trial operation, performance guarantee testing undertaken by the company or during any works / during working at BHEL Units/ Offices/ townships and premises/ Project Sites.
- 17.1.3 Compensation in respect of each of the victims:
- (i) In the event of death or permanent disability resulting from Loss of both limbs: ₹ 10,00,000/- (Rupees Ten Lakh)
  - ii) In the event of other permanent disability: ₹ 7,00,000/- (Rupees Seven Lakh)
- 17.1.4 Permanent Disablement: A disablement that is classified as a permanent total disablement under the proviso to Section 2 (l) of the Employee's Compensation Act, 1923

**18. SECRECY OF CONFIDENTIAL INFORMATION:**

- 18.1 The Contractor undertakes and agrees that he/it will not disclose or reveal in part or full the proprietary/confidential information, which terms shall mean and include patents, trademarks, service marks, registered designs, copyright, design rights, know-how, confidential information, trade and business names and any other similar protected information of BHEL received during negotiation or currency of the contract to any third party or governmental authorities without written permission from BHEL. In the event of termination or expiry of the contract, the contractor shall return all proprietary/confidential information to BHEL. This clause shall survive termination or expiry of the contract.
- 18.2 All the input details: transmittals and sample drawings supplied for preparation of drawings are confidential information of BHEL for specific purpose only. The contractor shall never pass on / part with the information to anybody and shall maintain the secrecy of the information. As soon as the bills are certified by BHEL, all the relevant drawing files shall be erased from PCs and shall not be made use under any circumstances.
- 18.3 BHEL reserves the right to initiate appropriate action including legal proceeds / termination of contract, recovery of damages, penalties etc., if the contractor is found guilty / wrong usage of the documents given by BHEL for any unauthorised activity.

## **19. BREACH OF CONTRACT, REMEDIES AND TERMINATION**

- 19.1 In case of breach of contract, wherever the value of security instruments like performance bank guarantee available with BHEL against the said contract is atleast 10% of the contract value, the same be encashed. in case the value of the security instruments available is less than 10% of the contract value, the balance amount be recovered from other financial remedies (i.e. available bills of the contractor, retention amount, etc. with BHEL) or legal remedies be pursued.
- 19.2 Further, levy of liquidated damages, debarment, termination, de-scoping, short-closure, etc., shall be applied as per provisions of the contract.
- 19.3 Accordingly, recovery of an amount equivalent to 10% of the contract value will be recovered in case of breach of contract

## **20. SECURITY DEPOSIT**

- 20.1 Security Deposit means the security provided by the Contractor towards fulfilment of any obligations in terms of the provisions of the contract.
- 20.2 The total amount of Security Deposit will be 5% of the contract value.
- 20.3 EMD of the successful tenderer (If Applicable) will be converted and adjusted towards the required amount of Security Deposit.
- 20.4 Submission of Security Deposit by the Contractors
- 20.4.1 At least 50% of the required Security Deposit, including the EMD, will be collected before start of the work. Balance of the Security Deposit will be collected by deducting 10% of the gross amount progressively from each of the running bills of the Contractor till the total amount of the required Security Deposit is collected.
- 20.4.2 In case of delay in submission of performance security, enhanced performance security which would include interest (Repo rate + 4%) for the delayed period, shall be submitted by the bidder.
- 20.4.3 If the value of work done at any time exceeds the contract value, the amount of Security Deposit will be correspondingly enhanced and the additional Security Deposit shall be immediately deposited by the Contractor or recovered from payment/s due to the Contractor.
- 20.4.4 The recoveries made from running bills (cash deduction towards balance SD amount) will be released against submission of equivalent Bank Guarantee in acceptable form, but only once, before completion of work, with the approval of the authority competent to award the work.
- 20.4.5 (Note: In case of small value contracts not exceeding Rs. 20 lakhs, work can be started before the required Security Deposit is collected. However, payment can be released only after collection/ recovery of initial 50% Security Deposit).
- 20.5 The balance amount to make up the required Security Deposit of the contract value may be accepted in the following forms:
- 20.5.1 Cash (as permissible under the extant Income Tax Act
- 20.5.2 Local cheques of Scheduled Banks (subject to realization)/ Pay Order/ Demand Draft/ Electronic Fund Transfer in favour of BHEL
- 20.5.3 Bank Guarantee from Scheduled Banks/ Public Financial Institutions as defined in the Companies Act. The Bank Guarantee format should have the approval of BHEL
- 20.5.4 Securities available from Indian Post offices such as National Savings Certificates, Kisan Vikas Patras etc. (held in the name of Contractor furnishing the security and duly endorsed/ hypothecated/ pledged, as applicable, in favour of BHEL)
- 20.5.5 Insurance Surety Bonds

- 20.8 In case of failure of the contractor to fulfil any of the tender / Contract obligations, either the whole of the contract or any part or in case actions under the Guidelines for Suspension of Business Dealings with Suppliers and Contractors is taken against a contractor, EMD and Security Deposit shall be liable for forfeiture as per BHEL Guidelines.

## **21. RESOLUTION OF DISPUTES**

- 21.1 The Parties agree that if at any time (whether before, during or after the arbitral or judicial proceedings), any Disputes (which term shall mean and include any dispute, difference, question or disagreement arising in connection with construction, meaning, operation, effect, interpretation or breach of the contract/tender which the Parties are unable to settle mutually), arise inter-se the Parties, the same may, be referred by either party to Conciliation to be conducted through Independent Experts Committee to be appointed by competent authority of BHEL from the BHEL Panel of Conciliators.
- 21.2 The proceedings of Conciliation shall broadly be governed by Part-III of the Arbitration and Conciliation Act 1996 or any statutory modification thereof.

### 21.3 Notes:

No serving or a retired employee of BHEL/Administrative Ministry of BHEL shall be included in the BHEL Panel of Conciliators.

Any other person(s) can be appointed as Conciliator(s) who is/are mutually agreeable to both the parties from outside the BHEL Panel of Conciliators.

- 21.4 The proceedings of Conciliation shall broadly be governed by Part-III of the Arbitration and Conciliation Act 1996 or any statutory modification thereof and as provided in **Annexure-1** to the Terms and conditions of the tender.
- 21.5 The **Annexure-1** together with its appendices will be treated as if the same is part and parcel hereof and shall be as effectual as if set out herein in the terms and conditions of the tender.
- 21.6 Except as provided elsewhere in this Contract, in case amicable settlement is not reached between the parties, in respect of any dispute or difference; arising out of the formation, breach, termination, validity or execution of the Contract; or, the respective rights and liabilities of the Parties; or, in relation to interpretation of any provision of the Contract ; or , in any manner touching upon the Contract, then, either Party may , by a notice in writing to other Party refer such dispute or difference to sole arbitration of an arbitrator appointed as per the Arbitration and Conciliation Act, 1996 (India) or statutory modification or re-enactment thereof and the rules made thereunder and for the time being in force .
- 21.7 The Arbitrator shall pass a reasoned award and the award of the Arbitrator shall be final and binding upon the parties.
- 21.8 Subject as aforesaid, the provision of Arbitration & Conciliation Act 1996 (India) or statutory modification or re-enactment thereof and the rules made thereunder and for the time being in force shall apply to the arbitration proceeding under this clause.

- 21.9 The seat of arbitration shall be the place from which the Contract is issued.
- 21.10 The cost of arbitration shall be borne as per the award of the Arbitrator.
- 21.11 Subject to arbitration in terms of clause above, the Courts at the place from which the Contract is issued shall have exclusive jurisdiction over any matter arising out of or in connection with this Contract.
- 21.12 Notwithstanding the existence or any dispute or difference and/or reference for the arbitration, the vendor shall proceed with and continue without hindrance the performance of its obligation under this Contract with due diligence and expedition in a professional manner except where the Contract has been terminated by either Party in terms of this Contract.
- 21.13 In Case of Contract with Public Sector Enterprise (PSE) or a Government Department, the following shall be applicable:
- 21.14 In the event of any dispute or difference relating to the interpretation and application of the provisions of commercial contract(s) between Central Public Sector Enterprises (CPSEs)/Port Trusts inter se and also between CPSEs and Government Departments/Organizations (Excluding disputes concerning Railways, Income Tax, Customs & Excise Departments, such dispute or difference shall be taken up by either party for resolution through AMRCD as mentioned in DPE OM No. 4(1)/2013 –DPE (GM)/FTS-1835 dated 22-05-2018.

**ANNEXURE-1**

**BRIEF PROCEDURE FOR CONDUCT OF CONCILIATION PROCEEDINGS**

1. The proceedings of Conciliation shall broadly be governed by Part-III of the Arbitration and Conciliation Act 1996 or any statutory modification thereof and as provided herein:
2. The party desirous of resorting to Conciliation shall send an invitation/notice in writing to the other party to conciliate specifying all points of Disputes with details of the amount claimed. The party concerned shall not raise any new issue thereafter. Parties shall also not claim any interest on claims/counter-claims from the date of notice invoking Conciliation till the conclusion of the Conciliation proceedings.
3. The party receiving the invitation/notice for Conciliation shall within 30 days of receipt of the notice of Conciliation intimate its consent for Conciliation along with its counter-claims, if any.
4. The Conciliation in a matter involving claim or counter-claim (whichever is higher) up to Rs 5 crores shall be carried out by sole Conciliator nominated by BHEL while in a matter involving claim or counter-claim (whichever is higher) of more than Rs 5 crores Conciliation shall be carried out by 3 Conciliators nominated by BHEL.
5. The Parties shall be represented by only their duly authorized in-house executives/officers and neither Party shall be represented by a Lawyer.
6. The first meeting of the IEC shall be convened by the IEC by sending appropriate communication/notice to both the parties as soon as possible but not later than 30 days from the date of his/their appointment. The hearings in the Conciliation proceeding shall ordinarily be concluded within two (2) months and, in exceptional cases where parties have expressed willingness to settle the matter or there exists possibility of settlement in the matter, the proceedings may be extended by the IEC by a maximum of further 2 months with the consent of the Parties subject to cogent reasons being recorded in writing.
7. The IEC shall thereafter formulate recommendations for settlement of the Disputes supported by reasons at the earliest but in any case within 15 days from the date of conclusion of the last hearing. The recommendations so formulated along with the reasons shall be furnished by the IEC to both the Parties at the earliest but in any case within 1 month from the date of conclusion of the last hearing.

8. Response/modifications/suggestions of the Parties on the recommendations of the IEC are to be submitted to the IEC within time limit stipulated by the IEC but not more than 15 days from the date of receipt of the recommendations from the IEC.
9. In the event, upon consideration, further review of the recommendations is considered necessary, whether by BHEL or by the other Party, then, the matter can be remitted back to the IEC with request to reconsider the same in light of the issues projected by either/both the Parties and to submit its recommendations thereon within the following 15 days from the date of remitting of the case by either of the Parties.
10. Upon the recommendations by the Parties, with or without modifications, as considered necessary, the IEC shall be called upon to draw up the Draft Settlement Agreement in terms of the recommendations.
11. When a consensus can be arrived at between the parties only in regard to any one or some of the issues referred for Conciliation the draft Settlement Agreement shall be accordingly formulated in regard to the said Issue(s), and the said Settlement Agreement, if signed, by the parties, shall be valid only for the said issues. As regards the balance issues not settled, the parties may seek to resolve them further as per terms and conditions provided in the contract.
12. In case no settlement can be reached between the parties, the IEC shall by a written declaration, pronounce that the Conciliation between the parties has failed and is accordingly terminated.
13. Unless the Conciliation proceedings are terminated in terms of para 22 (b), (c) & (d) herein below, the IEC shall forward his/its recommendations as to possible terms of settlement within one (1) month from the date of last hearing. The date of first hearing of Conciliation shall be the starting date for calculating the period of 2 months.
14. In case of 3 members IEC, 2 members of IEC present will constitute a valid quorum for IEC and meeting can take place to proceed in the matter after seeking consent from the member who is not available. If necessary, videoconferencing may be arranged for facilitating participation of the members. However, the IEC recommendations will be signed by all members. Where there is more than one (1) Conciliator, as a general rule they shall act jointly. In the event of differences between the Members of IEC, the decision/recommendations of the majority of the Members of IEC shall prevail and be construed as the recommendation of the IEC.
15. The Draft Settlement Agreement prepared by the IEC in terms of the consensus arrived at during the Conciliation proceedings between the Parties shall be given by the IEC to both the parties for putting up for approval of their respective Competent Authority.
16. Before submitting the draft settlement agreement to BHEL's Competent Authority viz. the Board Level Committee on Alternative Dispute Resolution (BLCADR) for approval, concurrence of the other party's Competent Authority to the draft settlement agreement shall be obtained by the other party and informed to BHEL within 15 days of receipt of the final draft settlement agreement by it. Upon approval by the Competent Authority, the Settlement Agreement would thereafter be signed by the authorized representatives of both the Parties and authenticated by the members of the IEC.
17. In case the Draft Settlement Agreement is rejected by the Competent Authority of BHEL or the other Party, the Conciliation proceedings would stand terminated.
18. A Settlement Agreement shall contain a statement to the effect that each of the person(s) signing thereto (i) is fully authorized by the respective Party(ies) he/she represents, (ii) has fully understood the contents of the same and (iii) is signing on the same out of complete freewill and consent, without any pressure, undue influence.

19. The Settlement Agreement shall thereafter have the same legal status and effect as an arbitration award on agreed terms on the substance of the dispute rendered by an arbitral tribunal passed under section 30 of the Arbitration and Conciliation Act, 1996.
20. Acceptance of the Draft Settlement Agreement/recommendations of the Conciliator and/or signing of the Settlement Agreement by BHEL shall however, be subject to withdrawal/closure of any arbitral and/or judicial proceedings initiated by the concerned Party in regard to such settled issues.
21. Unless otherwise provided for in the agreement, contract or the Memorandum of Understanding, as the case may be, in the event of likelihood of prolonged absence of the Conciliator or any member of IEC, for any reason/incapacity, the Competent Authority/Head of Unit/Division/Region/Business Group of BHEL may substitute the Conciliator or such member at any stage of the proceedings. Upon appointment of the substitute Conciliator(s), such reconstituted IEC may, with the consent of the Parties, proceed with further Conciliation into the matter either de-novo or from the stage already reached by the previous IEC before the substitution.
22. The proceedings of Conciliation under this Scheme may be terminated as follows:
- On the date of signing of the Settlement agreement by the Parties; or,
  - By a written declaration of the IEC, after consultation with the parties, to the effect that further efforts at conciliation are no longer justified, on the date of the declaration; or,
  - By a written declaration of the Parties addressed to the IEC to the effect that the Conciliation proceedings are terminated, on the date of the declaration; or,
  - By a written declaration of a Party to the other Party and the IEC, if appointed, to the effect that the Conciliation proceedings are terminated, on the date of the declaration.
  - On rejection of the Draft Settlement Agreement by the Competent Authority of BHEL or the other Party.
23. The Conciliator(s) shall be entitled to following fees and facilities:

If any witness(es) or expert(s) is/are, with the consent of the parties, called upon to appear at the instance of the IEC in connection with the matter, then, the costs towards such witness(es)/expert(s) shall be determined by the IEC with the consent of the Parties and the cost so determined shall be borne equally by the Parties.
26. The other expenditures/costs in connection with the Conciliation proceedings as well as the IEC's fees and expenses shall be shared by the Parties equally.
27. Out of the lump sum fees of ₹75,000/- for Sitting Fees, 50% shall be payable after the first meeting of the IEC and the remaining 50% of the Sitting Fees shall be payable only after termination of the conciliation proceedings in terms of para 22 hereinabove.
28. The travelling, transportation and stay at outstation shall be arranged by concerned Unit as per entitlements as per Serial No. 3 of the Table at para 23 above, and in case such arrangements are not made by the BHEL Unit, the same shall be reimbursed to the IEC on actuals limited to their entitlement as per Serial No. 4 of the Table at Para 23 above against supporting documents. The IEC Member(s) shall submit necessary invoice for claiming the fees/reimbursements.
29. The Parties shall keep confidential all matters relating to the conciliation proceedings. Confidentiality shall extend also to the settlement agreement, except where its disclosure is necessary for purposes of its implementation and enforcement or as required by or under a law or as per directions of a Court/Governmental authority/ regulatory body, as the case may be.
30. The Parties shall not rely upon or introduce as evidence in any further arbitral or judicial proceedings, whether or not such proceedings relate to the Disputes that is the subject of the Conciliation proceedings:
- Views expressed or suggestions made by the other party in respect of a possible settlement of the Disputes;
  - admissions made by the other party in the course of the Conciliator proceedings;
  - proposals made by the Conciliator;

32. None of the Conciliators shall act as an arbitrator or as a representative or counsel of a Party in any arbitral or judicial proceeding in respect of a Disputes that is/was the subject of that particular Conciliation proceeding.
33. The Parties shall not initiate, during the Conciliation proceedings, any arbitral or judicial proceedings in respect of a Disputes that is the subject matter of the Conciliation proceedings except that a Party may initiate arbitral or judicial proceedings where, in his opinion, such proceedings are necessary for preserving his rights including for preventing expiry of period of limitation. Unless terminated as per the provisions of this Scheme, the Conciliation proceedings shall continue notwithstanding the commencement of the arbitral or judicial proceedings and the arbitral or judicial proceedings shall be primarily for the purpose of preserving rights including preventing expiry of period of limitation.
34. The official language of Conciliation proceedings under this Scheme shall be English unless the Parties agree to some other language.

#### **2. ELIGIBILITY FOR PARTICIPATING IN THIS TENDER**

- 2.1 If the bidder has taken any deviation to this tender terms & conditions, and schedules of this tender it lead to total rejection of the offer submitted.
- 2.2 The offers of the Tenderer / bidders who are on the banned / Hold / Under Interim Suspension list and also the offer of the bidders, who engage the services of the banned Hold / Under Interim Suspension firms, shall be rejected. - 6.12 BHEL may reject the bid or in case the contract has been awarded, then terminate the contract apart from taking any other suitable action under the contract or applicable legal provisions or BHEL guidelines including GeM GTC, without any liability for any compensation to the bidder if, BHEL discovers at any time that any statement made by the bidder in the affidavit cum undertaking is false, fraudulent or any document submitted by the bidder was fake and forged or If BHEL determines in the sole discretion that any statement was aimed at deliberately misleading BHEL with a view to ensure award of the subject contract to the bidder
- 6.13 Expenses incurred by bidder towards preparation of bid incidental to Tender irrespective of whether it is accepted or not, shall be borne by bidder only
- 6.14 In order to avoid unforeseen delay, it is advised that, any correspondence by bidder to BHEL shall be emailed to all the addressees instead of one individual, as mentioned in Tender. - 1.3 Lowest prices received against BHEL Tenders need not be acceptable price to BHEL and in that case BHEL would not consider the same for award of Contract, despite the price being L1 in the Tender.
- 1.4 In the event of the final L1 prices are not reasonable / acceptable to BHEL; BHEL also may resort to short closure of this Tender.

#### **2. EVALUATION OF TECHNO-COMMERCIAL AND PRICE BIDS**

- 2.1 Only the Bid of L1 bidder will be opened by GeM. Both Techno Commercial bid and Price bid of L1 bidder will be opened at the same time in GeM for evaluation.
- 2.2 If L1 bidder is technically not qualified, then the bid of other bidders will be opened based on their price bid ranking.

#### **3. COUNTER OFFER**

- 3.1 Counter offer is applicable for the MSE bidders if the rate quoted is equal or less than L1+15%.
- 3.2 In case of non- MSE bidder become L1, then counter offer will be given to MSE bidders as per merit, if quoted lumpsum value will be within L1+15% and if accepted, contract will be awarded to MSE bidder.

**1. DEFINITION: - IN THESE GENERAL CONDITIONS OF CONTRACT, THE FOLLOWING TERMS SHALL HAVE THE MEANING HEREBY ASSIGNED TO THEM, EXCEPT WHERE THE CONTEXT OTHERWISE REQUIRES: -**

- 1.1 The "Contract" means, the documents forming the tender and acceptance thereof, together with all the documents referred to therein including general and special conditions to contract. All these documents as applicable taken together shall be deemed to form one contract and shall be complementary to one another.
- 1.2 The "work" means, the analytical work described in the tender documents.
- 1.3 The "contractor/ bidder" means, the individual Firm or Company whether incorporated or not, undertaking the work and shall include the legal personal representatives of such individuals or the persons composing the firm or Company or the successors of the firm or company and the permitted assigns of such individual or firm or Company.
- 1.4 "The Officer-In charge/ Lab-in-charge" means, the Officer deputed by the HEAD / NGA, WRI& Labs to supervise the work or part of the work.
- 1.5 "Approved" and "Directed" means, the approval or direction of HOD/WCM, or person deputed by him for the particular purposes.
- 1.6 "BHARAT HEAVY ELECTRICALS LIMITED" (herein after referred to as BHEL) shall mean the Board of Directors, Chairman, Executive Director, General Manager or other Administrative Officer of the said Company including SM/WCM authorized to invite tenders and enter into contract for works on behalf of the Company.
- 1.7 The "Contract sum" means, the sum accepted or the sum calculated in accordance with the prices accepted in tender and / or the contract rates as payable to the contractor for the execution of the work during the currency of the contract.
- 1.8 A "week" means, Seven Days, without regard to the number of hours worked or not worked in any day in that week.
- 1.9 A "day" means, the day of 24 hours (TWENTY-FOUR) irrespective of the number of hours worked or not worked in that day.
- 1.10 A "working day" means, any day other than that prescribed by the NEGOTIABLE INSTRUMENTS ACT as being a Holiday, and consists of the number of hours of labour as commonly recognized by good employers in the trade in the district where the work is carried out or as laid down in the BHEL regulations.

**2. HEADING TO THE CONTRACT CONDITIONS: -**

- 2.1 The heading to these conditions shall not affect the interpretations thereof.

**3. WORK TO BE CARRIED OUT: -**

- 3.1 The Contractor will be deemed to have satisfied himself as to the nature of the site, local facilities of access and all matters affecting the execution of the work. No extra charges consequent on any misunderstanding in these respects or otherwise will be allowed.

**4. DEVIATIONS: -**

- 4.1 The contractor shall not carry out any work not covered by schedule except in pursuance of the written instructions of an executive not below the rank of DGM of WCM / end user. No such work shall be valid unless the same has been specifically confirmed and accepted by BHEL in writing and incorporated in the Contract.

**5. ASSIGNMENT OF TRANSFER OF CONTRACT: -**

- 5.1 The Contractor shall not without the prior written approval of the BHEL, assign or transfer the contract or any part thereof, or any share, or interest thereon to any other persons. No sum of money which may become payable under the contract shall be payable to any person, other than the contractor unless the prior written approval of the BHEL to the assignment or transfer of such money is given.

- 5.2 **SUB-CONTRACT:** - The Contractor shall not sub-let any portion of the contract.

**6. COMPLIANCE TO REGULATIONS AND BY-LAWS: -**

- 6.1 The Contractor shall confirm to the provisions of any statute relating to the work and regulations and Bye-Laws of any local authority. The Contractor shall be bound to give all notices required by statute regulations or By-Laws as aforesaid and to pay all fees and taxes payable to any authority in respect thereof.

**7. SECURITY DEPOSIT: -**

- 7.1 BHEL shall not be responsible for any loss of securities, due to liquidation for any other reasons, what-so-ever or any depreciation in the value of the securities while in their charge or for any loss of interest there on.
- 7.2 All compensation or other sums of money payable by the Contractor to BHEL under the terms of this contract or under any other contract with BHEL may be deducted from the Security Deposit or realised by the sale of the securities or from the interest arising therefrom or from any sums which may be due or may become due to the contractor by BHEL and in the event of this Security Deposit being deducted by reason of such deductions or sale, as aforesaid, the Contractor shall within 7 days thereafter, make good in cash or in securities endorsed as aforesaid, any sum by which the Security Deposit has been reduced.

**8. REFUND OF SECURITY DEPOSIT: -**

- 8.1 Security Deposit will be refunded on completion of the work and after the expiry of the maintenance period, if any, provided always that the Contractor shall first have been paid the last and final bill and have rendered a "NO DEMAND CERTIFICATE". In case no maintenance period is applicable, then 100% of security Deposit will be refunded after providing "NO DEMAND CERTIFICATE" by the contractor as per format provide by BHEL

**9. ORDERS UNDER THE CONTRACT: -**

- 9.1 All orders, notices etc. to be given under the contract shall be in writing, type-script or printed and if sent by registered post to the address given in the Tender of the Contract, shall be deemed to have been served on the date, when in the ordinary course they would have been delivered to him. The Contractor shall carry out without delay all orders given to him. Contractor shall be deemed to have included in his tender price of all the plant, machinery and appliances required for the purpose of all operations connected with the work embraced under the contract to secure a satisfactory quality of work and rate of progress which in the opinion of the " Contract Signing Officer" will ensure the completion of the work within the time specified. BHEL is having every right to split the schedule and to award the work to single or many parties on the lowest offered rates basis. This is a time bound contract for period mentioned, and does not envisage any extension of time / period.

- 10.4 The respective area HOD have full powers and without assigning any reason, require the contractor to immediately cease to employ in connection with this contract, any agent, servant or employee where continued employment is, in his opinion undesirable. The contractor shall not be allowed any compensation on this account.

**11. LABOUR**

- 11.1 The Contractor shall remain liable for the payment of all wages or other moneys to his work-people or employees under the payment of Wages Act 1936, Employees Liability Act. 1938, Workmen's Compensation Act 1923 or any other Act or enactment, relating thereto and rules framed, there under from time to time.

**12. PRECAUTIONS AGAINST RISK: -**

- 12.1 The Contractor shall be responsible for providing at his own expense for all precautions to prevent loss or damage from any and all risks and to minimize the amount of any such loss or damage and for the necessary steps to be taken for the said purpose.

**13. DAMAGE & LOSS TO PRIVATE PROPERTY & INJURY TO WORKMEN: -**

- 13.1 The Contractor shall at his own expense reinstate and make good to the satisfaction of the respective area HOD and pay compensation for any injury, loss or damage occurred to any property or rights whatever including property and rights of BHEL (or agents) servants or employee of BHEL, the injury loss or damage arising out of or in any way in connection with the execution or purported execution of the contract and further the contractor shall indemnify, the BHEL against all claims enforceable against BHEL (or any agent, servant or employee of BHEL) or which would be so enforceable against BHEL where BHEL is a private person, in respect of any such injury (including injury resulting in death) loss or damage to any person whomsoever or property including all claims which may arise under the Workmen's Compensation Act or otherwise.

**14. LAWS GOVERNING THE CONTRACT: -**

- 14.1 The contract shall be governed by the Indian Laws for time being in force.

**15. CANCELLATION OF CONTRACT FOR CORRUPT ACTS: -**

- 15.1 BHEL, whose decision shall be final and conclusive, shall without prejudice to any other right or remedy which shall have accrued shall accrue thereafter to BHEL cancel the contract in any of the following cases and the Contractor shall be liable to make payment to BHEL for any loss or damage resulting from any such cancellation to the same extend as provided in the case of cancellation for default.

If the Contractor shall: -

- 15.2 Offer or give or agree to give to any person in BHEL service any gift or consideration of any kind, as an inducement or reward for doing or for bearing to do or for having done or for borne to do any act, in relation to the obtaining or execution of this or any other contract for BHEL service,

*BHEL, without prejudice to any other right or remedy which shall have accrued or shall accrue thereafter to BHEL shall cancel the contract in any of the following cases:  
If the Contractor,*

16.1 being an individual or if a firm any partner thereof shall at any time be adjudged bankrupt or have a receiving order for administration of his estate, made against him or shall take any proceedings for liquidation or composition under any bankruptcy Act or assignment of his effects of composition or arrangement for the benefit of his creditors or purport to do so, or if any application made under any Bankruptcy Act for the time being in force for the sequestration of his estate or if a trust deed be granted by him on behalf of his creditors  
OR

16.2 being a Company, shall pass a resolution or the Court shall make an order for the liquidation of its affairs, or a receiver or Manager on-behalf of the debenture holders shall be appointed or circumstances shall arise which entitle the Court or debenture holders to appoint a receiver or Manager,

16.3 Assigns, Transfers, Sub-lets or attempts to assign, transfer or sub-let any portion of the work.

16.4 Whenever BHEL exercise the authority to cancel the contract under this conditions, BHEL may have the work done by any means at the Contractor's risks and expenses provided always that in the event of the cost of the work so done (as certified by an Executive not below the rank of DGM of WCM / end user which is final and conclusive) being less than the contract cost, the advantage shall accrue to the BHEL and if the cost exceeds the money due to Contractor under the contract, the Contractor shall either pay the excess amount ordered by the Executive not below the rank of DGM of WCM / end user, or the same shall be recovered from the Contractor by other means.

16.5 In case the BHEL carries-out the work under the provisions of this condition the cost to be taken into account in determining the excess cost to be charged to the Contractor under this condition shall consist of the cost of the materials, hire charges of tools and plants and/or labour provided by the BHEL with an addition of such percentage to cover superintendence and establishment charges as may be decided by the Executive not below the rank of DGM of WCM / end user, whose decision shall be final and conclusive.

**17. CANCELLATION OF CONTRACT IN PART OF FULL FOR CONTRACATOR'S DEFAULT:**

*If the Contractor:*

17.1 Makes default in carrying out the work as directed and continues in that state after a reasonable notice from the Executive not below the rank of DGM of WCM / end user, or his authorized representative;

17.2 Fails to comply with any of the Terms and Conditions of the contract or after reasonable notice in writing with orders properly issued thereunder;

If the cost exceeds the moneys due to the Contractor under this contract the Contractor shall either pay the excess amount ordered **by the Executive not below the rank of DGM of WCM / End user** or the same shall be recovered from the Contractor by other means.
- 17.4 In case the BHEL carries out the work or any part thereof under the provisions of the conditions the cost to be taken into account in determining the excess cost to be charged to the Contractor under this condition shall consist of the cost of the materials, hire charges of tools and plant and/or labour provided by the BHEL with an addition of such percentage to cover the superintendence and establishment charges as may be decided by the Executive not below the rank of DGM of WCM / end user, whose decision shall be final and conclusive.

**18. TERMINATION OF CONTRACT ON DEATH OF CONTRACTOR. :-**

- 18.1 Without prejudice to any of the rights or remedies under this contract, if the Contractor dies, or if the firm is dissolved or the company is liquidated, BHEL shall have the option of terminating the contract without compensation to the Contractor.

**19. SPECIAL POWER TO TERMINATION: -**

- 19.1 If at any time after the award of contract, BHEL shall for any reason whatsoever does not require whole or any part of the work to be carried out, then Head of WCM shall give notice in writing of the fact to the Contractor and terminate the contract. The contractor shall have no claim to any payment of compensation or otherwise howsoever on account of any profit or advantage which he might have derived from the execution of the work in full but which he did not derive in consequence of the fore-closing of the work.

**20. RECOVERY FROM CONTRACTOR: -**

- 20.1 Whenever under the contract, any sum of money, shall be recoverable from or payable by the Contractors, the same may be deducted from or any sum then due or which at any time thereafter may become due to Contractor under the contract or under any other contract with BHEL or from his Security Deposit or he shall pay the claim on demand.

**21. POST TECHNICAL AUDIT OF WORK AND BILLS: -**

- 21.1 BHEL reserves the right to carry out the post-payment Audit and technical examination of the work and final bill including all supporting vouchers, abstracts etc., and enforce recovery of any sum becoming due as a result thereof in the manner provided in the presiding sub-paragraphs. However, no such recovery shall be enforced after three years of passing the final bill.

**22. SIGNING OF CONTRACT: -**

- 22.1 Each contract document shall be signed by the Contractor with his usual signature. Contract by partnership of Hindu Joint Family firm, may be signed in the FIRM'S name by one of the Partners or the Karta or Manager as the case may be or by any other duly authorised representative followed by the name and designation of the persons so signing. Contracts by a Company shall be signed with the name of the Company by a person authorised in this behalf and a power of attorney or other satisfactory proof showing that the persons signing the Contract documents on behalf of the Company is duly authorised to do so, shall accompany the contract.

- 23.3 Contractor shall indemnify BHEL against all claims and losses under various Labour Laws, statutes or any civil or criminal law in connection with employees deployed by him.
- 23.4 Contractor wherever applicable shall maintain proper records prescribed by the concerned statutory authorities and provide a copy of the same to BHEL.
- 23.5 Contractor shall furnish proper returns to the concerned statutory authorities and provide a copy of the same to BHEL.

**24. REGISTERS & RECORDS: -**

- 24.1 The Contractor shall maintain all registers and records in the proper manner and as required by the regulations of the various authorities concerned and indemnify the Employer from the consequences due to any inaccurate or faulty documentation on the part of the Contractor.

**25. REMOTE TRANSACTIONS: -**

- 25.1 The Contractor shall agree to and comply with all such terms and conditions as BHEL may prescribe from time to time and shall confirm that all transactions effected by or through facilities for conducting remote transactions including the Internet, World Wide Web, electronic data interchange, call centers, teleservice operations (whether voice, video, data or combination thereof) or by means of electronic, computer, automated machines network or through other means of telecommunication established by BHEL shall constitute legally binding and valid transactions when done.

**26. CHANGE IN CONSTITUTION OF FIRM: -**

- 26.1 Changes in constitution of firm whenever it is made after submission of application or during currency of the contract, the existing firm has to duly inform the proposed changes to contracting department of BHEL at the appropriate time before the changes in the constitution are made. In case the absence of any such information BHEL is not responsible for the consequences arising out of the absence or suppression of information and the issue / dispute arising out of these changes and the firm is responsible for settling the issue or dispute among themselves (Partners etc) or with the bankers or with any third party. Under the above circumstances when dispute arises and the firm does not inform the change in the constitution of the firm BHEL may reserve its rights for suspending or terminating the contract.
