1. Objective:

BHEL PEM requires two (2) Nos of A0 Multifunction (MFS) plotters on operating lease with pay per print basis for Seven (07) years for meeting mono A0-A2 size printing requirement

2. <u>Scope</u>:

The scope of this specification covers

- a. Supply, installation and onsite comprehensive maintenance of two (2) Nos of A0 Multifunction (MFS) plotter for BHEL-PEM, Noida on operating lease and pay per print basis for a period of seven years as per Technical specification given further.
- b. Supply of all consumables / non-consumable items like Cartridges, paper, drum etc. to make the PLOTTER available for operations during the entire lease period.

3. Technical specification

4. Additional points for consideration

- 4.1. All the items as required to meet the tender scope of supply shall be in the bidder's scope. Any equipment, material, software or supplies which may not be specifically mentioned in the specifications but which are necessary for carrying out the contract works within the scope of the tender are to be provided for and rendered to by the bidder. Such items not quoted by the bidder, if found necessary during execution of the contract, shall have to be supplied at no extra charge / time by the-bidder.
- 4.2. The bidder shall supply and install all cables, adapters, power cords and any other interconnects required by the systems to meet the specification. The bidder shall carry

out all electrical and systems interfacing pertaining to equipment at Site as per the best international standards and practices.

- 4.3. Arranging requisite tools, measurement equipment and resources required for installation and commissioning of the hardware, software and other equipment is the responsibility of the bidder.
- 4.4. The bidder shall ensure that none of BHEL's equipment/structure/setup gets damaged during commissioning and operations of the supplied equipment. Any damages, if caused to BHEL's property due to Bidder's activity/negligence or the operations of the equipment, shall be rectified, repaired by the bidder at their own cost.
- 4.5. The insurance (transit & during contract life) shall be in the scope of the bidder during the lease contract period.
- 4.6. The operating lease is for a period of seven years and consists of fixed rental charges and printing charges.
 - 4.6.1. The fixed rental charges include the following:
 - a. Packing, forwarding, transit insurance and transportation to BHEL's premises.
 - b. Installation and commissioning including transfer of data if any.
 - c. Scanning facility
 - d. Insurance at BHEL premises.
 - e. Other incidentals
 - 4.6.2. The printing charges are payable on per page printing basis for A1 and A0 pages
- 4.7. Arranging vehicle /manpower required for moving the equipment in BHEL premises for replacement of parts/whole machine will be bidder's responsibility.
- 4.8. The bidder shall undertake quarterly preventive maintenance for entire contract period.
- 4.9. The bidder should provide the service escalation matrix to BHEL for resolving problems within the stipulated time.
- 4.10. Contract period will start only after satisfactory installation and commissioning of equipment including all hardware and software products and after acceptance of commissioning report by PEM. The installation and commissioning certificate shall be jointly signed by the PEM's representative and the Bidder's representative. Quarterly charges (provided uptime as specified is maintained) become payable at the end of each Quarter.
- 4.11. All the equipment supplied shall be rodent proof. BHEL will not be liable for any damages done by rodents.
- 4.12. BHEL will provide Only one 15 Amps power socket and Network port (RJ-45). Further, the bidder shall supply and install all cables, adapters, power cords and any other interconnects required by the systems to meet the specification. The bidder shall carry out electrical and network cabling pertaining to the equipment.
- 4.13. Plotter should be capable of working under Windows operating systems starting from Windows 11 and including the latest Windows desktop/server operating systems those are released within the expiry of the contract period.
- 4.14. Equipment offered shall be New. Re-built / Re-conditioned / Used equipment will not be accepted. An undertaking supporting newness of the plotters has to be submitted during supply of plotter.

- 4.15. Training of BHEL end user personnel on configuration and proper usage during installation will be part of the contract.
- 4.16. Insurance for the complete Systems/Goods shall be arranged by the Bidder at his own risk and cost throughout the period of lease. BHEL, under any circumstances, will not be responsible for any loss/damage/theft of any Systems/goods, due to any reasons, whatsoever. Claim(s) etc., if any, will be dealt with the underwriters directly by the Bidder. Evidence of insurance policy shall be submitted to BHEL.
- 4.17. Subcontracting Order/contract or any part thereof shall not be allowed
- 4.18. Make, Model and Product No must be mentioned clearly in the offer.
- 4.19. No items shall be offered whose end of sale has been declared by the OEM or has been declared to be under phase out.
- 4.20. Cartridge / Ink shall be original and should be replaced proactively before exhaustion.
- 4.21. Thickness of paper should be minimum 80 GSM
- 4.22. The offered Plotter should be able to handle 50 A0 size prints per hour at a time without any degradation in performance.
- 4.23. Bidder shall provide necessary support for shifting plotters with in building floor(s) / outside current premises in case of exigencies.

5. Service Level Agreement (SLA):

- 5.1 SLA will be applicable for the entire contract period.
- 5.2 The bidder as part of their services, will ensure a minimum availability of 98% of the total available time on 8 working hours per day basis computed quarterly for the product for the entire contract period.
- 5.3 Deduction for lower availability

Availability of Plotters will be calculated in a quarter as follows:

Total working hours-Total down time in hours
---- x 100
Total working hours

Where Total working hours= Total no. of BHEL unit working days during quarterly period under consideration x 8

Down-Time = Difference in hours between time of fault rectification and time of reporting of fault.

Total down time =Cumulative downtime during the quarterly period under consideration

During the contract period, if the availability for product is less than 98% during a quarter, deduction shall be made from the payment of applicable quarter, as per following formula:

i. For 95.0% <= Availability < 98.0% (Penalty @1.5 times rental charges per quarter): Deduction (D) per quarter = (100-Availability)% X rental charges per quarter X 1.5

ii. For Availability < 95.0% (Penalty @2 times rental charges per quarter):

Deduction (D) per quarter = (100-Availability)% X rental charges per quarter X 2

- 5.4 If the uptime for equipment / system falls below 95% continuously for 3 months, BHEL reserves the right to demand that the system / equipment be replaced by the Bidder, without any extra charge.
- 5.5 If the availability of the system or part thereof is continuously below 75% over a period of 3 months, BHEL reserves the right to terminate the contract in full, without any cost implication.
- 5.6 Total deduction for a quarter shall be limited to maximum quarterly rental charges as per contract for quarter.
- 5.7 Any complaint referred by the BHEL shall be attended to within 24 hours from the time of complaint logging. If delay of more than 7 days is anticipated in repairing, suitable temporary replacement plotter shall be provided for continuity of the service.
- 5.8 If the operation of the Plotter is not satisfactory (poor quality of copies / prints,, taking longer time to print etc.) plotter shall be replaced within 3 working days.

6. Delivery (Supply & Installation) Schedule:

5.1. Supply, installation and commissioning shall be completed within 30 days from the date of Order.

7. Support:

- 7.1 All the supplied equipment / systems (hardware/software) shall be covered under a Comprehensive On Site service support for the entire contract period. The period shall start from the date of successful commissioning of the Equipment / System.
- 7.2 Support shall cover the following:
 - a. Repair / Replacement of faulty / defective Hardware and other supplied items inclusive of supply of all types of spare parts etc. (Including batteries if any)
- 7.3 All Software Patches, Upgrades, updates, Service Packs, etc. of the Operating System and all other Software supplied by the OEM must be made available during the entire contract period.
- 7.4 Support during Annual Maintenance Contract Period:
 - a. Periodic health checks of the systems using diagnostic tools and implementing proactive rectification measures.
 - b. Troubleshooting performance related issues.
 - c. Analyzing and reporting all system related issues.
 - d. Backup of all configurations.

6. Payment Terms and conditions

- 6.1. The payment shall be paid after end of each quarter. First payment shall commence only after successful commissioning of the plotter and signing of commissioning certificate.
- 6.2. Quarterly payment will be made after certification by indenting department.
- 6.3. Printing charges will be on actual i.e. number of pages printed in a quarter.

7. Other terms and Conditions

- 7.1 Prices shall remain firm for the entire duration of contract.
- 7.2 Prices shall remain firm for any increase or decrease in the Order/Contract value (Exworks) up to 30%. The insurance (transit & during contract life) shall be in the scope of the vendor/ bidder. Insurance for the composite systems/ Goods shall be arranged by the bidder at his own risk and cost during transit, movement, storage and throughout the period of contract. BHEL under any circumstances, will not be responsible for any loss/ damage/theft of any systems/goods, due to any reason, whatsoever. Claims(s) etc., if any, will be dealt with the underwriters directly by the bidder. Evidence of insurance policy shall be submitted to BHEL after placement of order.

21. Rates:

- i) Rates to be quoted on net F.O.R. destination inclusive of freight, handling and packing charges, transit insurance, installation, regular/ on-site insurance and on site comprehensive maintenance including spares during the entire lease period and shall remain FIRM without any deviation till completion of the lease contract.
- ii) Bidders, in their own interest, are requested to check up the different tax tariff like "right to use" etc. at BHEL-PEM, Noida. After opening of Price-Bid, no request for any change in rates/ tariff due to above will be entertained.

22. PRICE DISCREPRENCY:

Following shall be considered for evaluation and ordering for non-conformities/ errors/ discrepancies in price bid:

- i. Bidders should quote total price in "figures" with corresponding words in price bid format.
- ii. If, in the price structure quoted for the required goods/ services/ works, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly., unless in the opinion of the Purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price corrected accordingly.
- iii. If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected.
- iv. If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject of (ii) and (iii) above.
- v. If there is such discrepancy in an offer, the same shall be conveyed to the bidder with target date up to which the bidder has to send his acceptance on the above lines and if the bidder does not agree to the decision of the Purchaser, the bid is liable to be ignored.

23. LANGUAGE & CORRECTIONS:

- i. The Bid shall be in English language. All correspondence and documents relating to the bid exchanged between the bidder and the purchaser shall also be in ENGLISH language. However, any technical document/literature etc. printed in a language other than English shall be accompanied by its true English translation duly signed for its correctness. Any document submitted with the bid but not in English language shall not be treated as part of the bid document. The responsibility for the correctness of the translations if any solely rests on the bidder and purchaser shall not be responsible for any loss/likely loss arising out of error in translation whatsoever. In such cases, for the purpose of interpretation of the bid, the English translation shall prevail.
- ii. Tenderer shall quote the rates in English language and Indo-Arabic numerals only. Total Price shall be entered in figures as well as in words. For the purpose of tender, metric system of units shall be used.
- iii. All entries in the tender shall either be typed or written legibly in ink. Cancellations, corrections, insertions, erasing, over-writing (if unavoidable) shall be authenticated with signature and seal by the bidder.

24. BHEL shall be resorting to Reverse Auction (RA) (Guidelines as available on www.bhel.com on "supplier registration page") for this tender. RA shall be conducted among all the techno-commercially qualified bidders.

Price Bids of all the techno-commercially qualified bidders shall be opened and same shall be considered as initial bids of bidders in RA. In case any bidder(s) do(es) not participate in online Reverse Auction, their sealed envelope price bid along with applicable loading, if any, shall be considered for ranking.

25. Order of Precedence:

In the event of any ambiguity or conflict between the Tender Documents, the order of precedence shall be in the order below:

- a. Amendments/Clarifications/Corrigenda/Errata etc. issued in respect of the tender documents by BHEL
- b. Notice Inviting Tender (NIT)
- c. Price Bid
- d. Commercial Terms and Conditions
- e. Forms

It may please be noted that guidelines/ circulars/ amendments/ govt. directives issued from time to time shall also be applicable.

26. Acceptance of LOA/Work Order/ PO/ Contract:

Letter of seller / bidder's acceptance of the LOA/Work Order/ PO/ Contract is to be submitted within one week of issue of LOA/Work Order/ PO/ Contract.

27. Delivery Period

Supply, installation and commissioning shall be completed within 30 days from the date of Order.

28. <u>Liquidated Damages:</u>

Purchaser reserves the right to recover from the Seller/ Contractor, as agreed liquidated damages and not by way of penalty, a sum equivalent to half (½) percent, of the total fixed lease charges, excluding GST per week or part thereof, subject to a maximum of ten (10) percent of the total fixed lease charges excluding GST, if the Seller/ Contractor fails to deliver any part of ordered supply and services within the period stipulated in the Order/ Contract (30 days from the date of Order).

29. Payment Terms:

- I. The quarterly lease payment will be due after completion of the quarter from the date of succes sful completion of installation & signing of commissioning certificate by BHEL. However, 1st q uarter lease rental payment will be proportionate as per commissioning date of the equipment.
- II. Payment will be made quarterly basis after completion of each quarter and submission of invoic e(s) complete in all respect, on Certification from BHEL.
- III. Pro rata lease charges will be payable for the quarter in which installation and acceptance (by B HEL in form of commissioning certificate) takes place.
- IV. Printing charges will be on actuals i.e. number of pages printed in a quarter.
- V. No interest shall be payable for delayed payment (if any).

31. Security Deposit: NOT APPLICABLE.

32. Quantity Variation:

Prices shall remain firm for any increase or decrease in the Order/Contract value (Exworks) up to 30%. BHEL shall have the right to increase or decrease quantities and scope up to the above extent of value and bidder shall be bound to accept the same at the contracted prices without any escalation..

33. Integrity Pact: NOT APPLICABLE.

34. BREACH OF CONTRACT:

In case of Breach of Contract, BHEL shall recover 10% of the contract value from the Vendor using following instruments:

- (i) encashment of security instruments like Performance Security with respective BHEL unit against the said contract.
- (ii) balance amount (if value of security instruments is less than 10% of the contract value) from other financial remedies i.e. available bills of the Vendor, retention amount etc. with respective BHEL unit.
- (iii) balance amount from security instruments like EMD, Performance Security and other financial remedies i.e. available bills of the Vendor, retention amount etc. with other units of BHEL.
- (iv) if recovery is not possible then legal remedies shall be pursued.

35. Taxes and Duties

All payments against Tax Invoice to vendors/contractors shall be released only after:

- i) Vendor/ contractor declaring such invoice in GSTR-1/GST-ANX-1 as per the relevant GST Act.
- ii) The tax component charged by the vendor in the invoice should match with the details uploaded by vendor in GSTR-1/GST-ANX-2 and GST liability is discharged through GSTR 3B.

iii) In case, any GST credit is delayed/denied to BHEL due to non/delayed receipt of goods and/or tax invoice or expiry to timeline prescribed in the relevant GST Act for availing such ITC, or any other reasons not attributable to BHEL, tax amount shall be recoverable from the vendor/contractor along with interest levied/ leviable on BHEL.

NOTE: - Payment to vendors can be released without GST in case above conditions are not fulfilled if due date of filling GST returns has not passed.

36. The Bidder declares that they will not enter into any illegal or undisclosed agreement or understanding, whether formal or informal with other Bidder(s). This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process.

37. DEALING WITH BIDDERS UNDER SUSPENSION

The offers of the bidders who are under suspension as also the offers of the bidders, who engage the services of the banned firms, shall be rejected. The list of debarred firms is available on BHEL web site bhel.com .

38. BHEL shall be under no obligation to accept the bid and shall have the right to accept or reject bid in part or in full without assigning any reason whatsoever. BHEL also reserves the right to reject quotation without assigning any reason whatsoever. Quotation of the party which have been black-listed / debarred / banned by PSUs / kept on hold by any office of Delhi-based Divisions of BHEL during the last three years will be rejected. Late tenders will be rejected.

39. PREFERENCE TO MAKE IN INDIA:

For this procurement, Public Procurement (Preference to Make in India), order 2017 dated 15.06.2017 & 28.05.2018, 04.06.2020,19.07.2024 and subsequent orders issued by the respective Nodal ministry shall be applicable even if issued after issue of this NIT but before finalization of contract/PO/WO against this NIT. In the event of any Nodal Ministry prescribing higher or lower percentage of purchase preference and/ or local content in respect of this procurement, same shall be applicable.

Note: Only Class-I and Class-II Local suppliers as per MII order dated 04.06.2020 & 19.07.2024 will be eligible to bid for this tender. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. As per the order, Minimum Local Content for Class-I and Class-II is 50% and 20% respectively.

- 40. MSE Preference: MSE preference will be given as per extant guidelines of Government of India (GOI)
- 41. GOI circular dated 18.05.2023 for Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017 will be used for order finalization.
- 42. Compliance to Restrictions under Rule 144 (xi) of GFR 2017 is necessary. Bidder to submit Land Border compliance certificate attached as annexure- to NIT.

43. In the course of evaluation, if more than one bidder happens to occupy L-1 status, effective L-1 will be decided by soliciting discounts from the respective L-1 bidders.

In case more than one bidder happens to occupy the L-1 status even after soliciting discounts, the L-1 bidder shall be decided by a toss/ draw of lots, in the presence of the respective L-1 bidder(s) or their representative(s).

Ranking will be done accordingly. BHEL's decision in such situations shall be final and binding.

44. TAX DEDUCTION AT SOURCE:

Tax shall be deducted at source from the running bills as per applicable Income Tax Rules and other statutory requirements.

45. TERMINATION OF CONTRACT:

Notwithstanding anything contrary in this contract elsewhere, BHEL may at its sole discretion terminate the contract at any time, by giving a written notice, for any reason whatsoever including but not limited to any non-compliance to the terms and conditions of the contract, default, non-performance or breach of the contract by the vendor. This right of termination of BHEL shall be without prejudice to any other rights or remedies which BHEL may have against the vendor under the contract or any law.

46. In case of any act of default/ omission/ pilferage/ prejudice to any interest of BHEL, BHEL may take action against Contractor as per company guidelines in addition to the penalty & action explicitly mentioned in this tender document.

47. ARBITRATION & CONCILIATION: 45.1 CONCILIATION:

If at any time (whether before, during or after the arbitral or judicial proceedings), any Disputes (which term shall mean and include any dispute, difference, question or disagreement arising in connection with construction, meaning, operation, effect, interpretation or breach of the agreement, contract), which the Parties are unable to settle mutually, arise inter-se the Parties, the same may, be referred by either party to Conciliation to be conducted through Independent Experts Committee (IEC) to be appointed by competent authority of BHEL from the BHEL Panel of Conciliators under BHEL Conciliation Scheme. For more details please visit BHEL website www.bhel.com

45.2 ARBITRATION:

Except as provided elsewhere in this Contract, in case amicable settlement is not reached between the Parties, in respect of any dispute or difference; arising out of the formation, breach, termination, validity of execution of the Contract; or, the respective rights and liabilities of the Parties; or, in relation to interpretation of any provision of the Contract; or, in any manner touching upon the contract, then, either Party may, by a notice in terms of Section 21 of Arbitration & Conciliation Act in writing to the other Party commence arbitration. The notice shall as far as possible contain the particulars of all claims to be referred to arbitration.

The arbitration shall be conducted by Sole Arbitrator to be appointed mutually by the Competent Authority of BHEL (purchaser) & Seller within the statutory period as applicable. As far as practicable, names of 2 or more persons shall be forwarded to the Seller for seeking consent of the Seller to one of the names proposed for appointment as arbitrator in the case. If the parties fail to agree on the name of Sole

Arbitrator, then appointment shall be made as per the provisions of section 11 of the Arbitration & Conciliation Act.

The Arbitrator shall pass a reasoned award and the award of the Arbitrator shall be final and binding upon the Parties. The language of Arbitration shall be English.

Subject as aforesaid, the provisions of Arbitration of Conciliation Act 1996 (India) or statutory modification/ Amendments or re-enactments thereof and the rules made thereunder and for the time being in force shall apply to the arbitration proceedings under this clause. The seat and venue of arbitration shall be Delhi/ New Delhi.

The cost of arbitration shall be borne equally by the parties' subject to the final apportionment of the cost of the arbitration as per the award/order of the arbitrator.

Subject to the arbitration in terms of Clause above, the Courts at Delhi-NCR shall have exclusive jurisdiction over any matter arising out of or in connection with this contract.

Notwithstanding the existence or any dispute or difference and/or reference for the arbitration, the Contractor shall proceed with and continue without hindrance the performance of its obligations under this Contract with due diligence and expedition in a professional manner except where the Contract has been terminated by either Party in terms of this Contract.

48. LAWS GOVERNING THE CONTRACT:

Contract, including all matters connected with contract, shall be governed by the Indian Law, both substantive and procedural, for the time being in force including modification thereto, and shall be subject to the exclusive jurisdiction of the Indian courts at Delhi-NCR.

It shall be responsibility of the vendor to ensure compliance of Labor laws, safety regulations, workmen compensation, insurance, BOCW act or other relevant acts.

49. JURISDICTION OF COURT:

Courts at Delhi-NCR shall have exclusive jurisdiction to decide the dispute, if any, arising out of or in respect of the contract(s) to which these conditions are applicable.

50. SETTLEMENT OF DISPUTES:

- 30.1 Except as otherwise specifically provided in the Order/ Contract, all disputes concerning questions of the facts arising under the Order/ Contract, shall be decided by Purchaser, subject to written appeal by the Seller/ Contractor to the Purchaser, whose decision shall be final.
- 30.2 Any dispute or difference shall be, to the extent possible, settled amicably between the parties hereto, failing which the disputed issues shall be settled through arbitration.
- 30.3 Seller/Contractor shall continue to perform the order/contract, pending settlement of dispute(s).

51. BHEL FRAUD PREVENTION POLICY:

The Bidder along with its associate/ collaborators/ sub-contractors/ sub-vendors/ consultants/ service providers shall strictly adhere to BHEL Fraud Prevention Policy displayed on BHEL website http://www.bhel.com and shall immediately bring to the notice of BHEL Management about any fraud or suspected fraud as soon as it comes to their notice.

52. FORCE MAJEURE:

52.1 Notwithstanding anything contained in the contract, neither the Seller nor the Buyer shall be held responsible for total or partial non-execution/non-performance of any of the contractual obligations, in case such execution/performance is impeded/prevented due to occurrence of a 'Force Majeure'

event not within the reasonable control of the party affected, which materially interferes or directly affects the performance of the obligations or duties under the contract.

Force Majeure event means an event beyond the control of the parties to the contract including but not limited to war, Military operations of any nature, Act of God, earthquakes, floods, fire, quarantine restrictions, acts of public enemy, blockades, civil war, explosion, epidemics, insurgency, change in law or government policy etc.

- 52.2 The party claiming to be affected by such Force Majeure event shall notify/inform the other party in writing without delay within a reasonable period of the occurrence and cessation of such event specifying the Force Majeure event and its effect on performance of contractual obligations. In the event of the parties hereto not agreeing that a force majeure event has occurred, the parties shall submit the dispute(s) for resolution pursuant to the provisions hereunder, provided that the burden of proof as to whether a force majeure event has occurred shall be upon the party claiming such an event.
- 52.3 If it is agreed between the parties that a Force Majeure event has occurred and its effect continues for a period of 36 months, then either party shall be free to cancel the contract. However, if the effect of such event ceases within this period of 36 months, the performance of the obligations put on hold shall be resumed immediately.
- 52.4 Not-withstanding the above provisions, Purchaser shall reserve the right to cancel the Order/Contract, wholly or partly, in order to meet the overall project schedule and make alternative arrangements for completion of delivery and other schedules.
- 52.5 If a war like situation has developed in a country where Sellers's works (of this PO) is located or there is political instability or civil war and Indian Embassy located in that country/Indian Government forbids or advises for not having any business dealings in that country/ region/zone, then BHEL reserves the right to cancel the order/Contract without incurring any liability for any kind of payment or compensation to the Seller on that account.

53. STATUTORY VARIATION:

- 53.1 In general, Statutory variation for GST is payable to the Seller during currency of the contract between Buyer and Seller. Further, for period beyond the currency of the contract, BHEL will reimburse the actual applicable tax even if the same is higher than the amount applicable within the contractual period in case BHEL is able to take the input tax credit. However, the decision of BHEL in this regard will be final and binding on the seller/contractor otherwise vendor/contractor has to bear the differential upward increase in tax and ex- works price is to be adjusted accordingly
- 53.2 No other variations such as on Custom Duty, exchange rate, minimum wages, prices of controlled commodities, any other input etc. shall be payable by the purchaser unless specifically agreed upon.
- 54. The Bidder along with its associate/ collaborators/ sub-contractors/ sub-vendor/ consultants/ service providers shall strictly adhere to BHEL Fraud Prevention Policy displayed on BHEL web site http://www.bhel.com and shall immediately bring to the notice of BHEL Management about any fraud as soon as it comes to their notice.
