#### **WORK SPECIFICATION**

#### 1. SCOPE OF WORK OF THE CONTRACTOR SHALL BE AS FOLLOWING:

- **a.** The contractor shall be responsible for "Direct activities of Assembly Shop at FBM, BHEL Jhansi". List of activities are described below:
  - I. Air testing (AT) of transformer tank and accessories
  - **II.** Vacuum testing (VT) of transformer tanks
  - **III.** Shot blasting of items/ sub-assembly/ assembly
  - IV. Primer, MIO and final painting of items/ sub-assembly/ assembly
- **b.** The work shall conform to BHEL standards given in various drawings, documents, Quality sheets etc. that will be provided during execution of work. If any portion of works is found to be defective in workmanship and not conforming to documents/ standards, the contractor shall re-do the work at their own cost, failing which recoveries, as determined by BHEL, shall be deducted from contractor's bills.

- **f.** Electricity, compressed air and cutting gases shall be provided by BHEL free of cost. EOT crane shall be provided by BHEL free of cost; however, operation of the same shall be the responsibility of contractor. Trained Crane operators to be deployed by contractor.
