- a. Delivery of material shall be completed within 6 months from the date of PO. Date of receipt of the material at BHEL-FSIP Store, Jagdishpur shall be treated as date of delivery.
- b. Test required as per specification. Test certificate to be dispatched along with material.
- c. Final inspection shall be done at BHEL FSIP Jagdishpur after receipt of material.
- d. Tender shall be finalized through Price bid opening. RA shall not be conducted for this tender enquiry.
- e. “For this procurement, the local content to categorize a supplier as a Class I local supplier / Class II local supplier / Non-Local Supplier and purchase preference to Class I local supplier, is as defined in Public Procurement (Preference to Make in India), Order 2017 dated 04.06.2020 issued by DPIIT. In case of subsequent orders issued by the nodal ministry, changing the definition of local content for items of the NIT, the same shall be applicable even if issued after issue of this NIT, but before opening of Part II bids against this NIT”
- f. Coil weight shall be 3MT-6MT subjected to consideration of nominal ID of the coil to be 508 MM & Max OD up to 1500 MM.
- g. Vendor to send dispatch documents (Invoice, TC) along with material.
- h. **This tender has the condition that if NTPC approved supplier (for Singrauli Project) became L-1, then PO shall be placed of total tender quantity i.e., 1230 MT and if unapproved (not approved with M/s NTPC) supplier became L-1 then order for 410 MT only will be placed and balance 820 MT will be counter offered to NTPC approved supplier(s) for their acceptance.**
- i. **If any new Indian bidder are approved by M/s NTPC for above project, those bidders must submit approval certificate issued by M/s NTPC before the price bid opening date. Failure to do so will result in the rejection of their offer.**
