The bidder should respond by submitting their offer online only in our e-Procurement platform at (<u>https://eprocurebhel.co.in</u>). Offers are invited in two-parts only.

- 5.0 BHEL reserves the right to accept or reject any or all Offers without assigning any reasons thereof. BHEL also reserves the right to cancel the Tender wholly or partly without assigning any reason thereof. Also, BHEL shall not entertain any correspondence from bidders in this matter (except for the refund of EMD).
- 6.0 In case wherever scope comprises of supply and services, bidders must visit site/ work area and study the job content, facilities available, availability of materials, prevailing site conditions including law & order situation, applicable wage structure, wage rules, etc. before quoting for this tender as the job shall be executed at site. They may also consult this office before submitting their offers, for any clarifications regarding scope of work, facilities available at sites or on terms and conditions.
- 7.0 For any clarification on the tender document, the bidder may seek the same in writing or through e-mail and/or through e-procurement portal, as per specified format, within the scheduled date for seeking clarification, from the office of the undersigned. BHEL shall not be responsible for receipt of queries after due date of seeking clarification due to postal delay or any other delays. Any clarification / query received after last date for seeking clarification may not be normally entertained by BHEL and no time extension will be given.

- 8.0 BHEL may decide holding of pre-bid discussion [PBD] with all intending bidders as per date indicated in the NIT. The bidder shall ensure participation for the same at the appointed time, date and place as may be decided by BHEL. Bidders shall plan their visit accordingly. The outcome of pre-bid discussion (PBD) shall also form part of tender.
- 9.0 In the event of any conflict between requirement of any clause of this specification/documents/drawings/data sheets etc. or requirements of different codes/standards specified, the same to be brought to the knowledge of BHEL in writing for clarification before due date of seeking clarification (whichever is applicable), otherwise, interpretation by BHEL shall prevail. Any typing error/missing pages/ other clerical errors in the tender documents, noticed must be pointed out before pre-bid meeting/submission of offer; else BHEL's interpretation shall prevail.
- **10.0** Unless specifically mentioned otherwise, bidder's quoted price shall deemed to be in compliance with tender including PBD.
- 11.0 The Bidder has to satisfy the Pre-Qualifying Requirements stipulated for this Tender in order to be qualified. The Price Bids of only those bidders will be opened, who will be qualified for the subject job on the basis of satisfying the Pre-Qualification Criteria specified in this NIT as per Annexure-1 (as applicable), past performance, Techno-Commercial bids etc. and date of opening of price bids shall be intimated to only such bidders. BHEL reserves the right not to consider offers of parties under DEBARMENT.

#### 12.0 VALIDITY OF OFFER:

Bidders' offers shall be submitted with the following validity periods unless specified otherwise in tender:

- i. Original offers shall be valid for a period of 120 days from the date of Techno-Commercial bid (Part-I) opening.
- ii. If revised price bid/ price impact is asked by BHEL, the validity of the same shall be 90 days from the date of price bid opening or 120 days from Part-I opening, whichever is later.
- iii. In case where Reverse auction (RA) is conducted, the validity of the same shall be 90 days from the date of successful RA completion or 120 days from Part-I opening, whichever is later.
- iv. In case of negotiation, validity of offer shall be 90 days from receipt of revised /negotiated final price or 120 days from Part-I opening, whichever is later.
- v. Offers with shorter validity than above are liable to be rejected.

#### 13.0 EVALUATION CRITERIA:

Bidder to quote on F.O.R. Destination basis (including Freight, Packaging and Forwarding charges). Offers other than F.O.R. Destination Basis will not be accepted by BHEL. Offers will be evaluated based on Total cost to BHEL (excluding GST) on F.O.R. basis, as indicated in Price Bid of Tender. The evaluation currency for this tender shall be INR.

#### 14.0 TRANSIT INSURANCE:

Transit insurance for supply of finished material from Vendor's works to site shall be in the scope of BHEL. Detailed as per sl. no. 2.22.4 of Chapter II of TCC (Vol – IA).

#### 15.0 REVERSE AUCTION (RA): Not Applicable for this Tender.

Reverse Auction – BHEL shall be resorting to Reverse Auction (RA) (Extant Guidelines as available on <a href="https://www.bhel.com/guidelines-reverse-auction-2021">https://www.bhel.com/guidelines-reverse-auction-2021</a> on "supplier registration page") for this tender. RA shall be conducted among all the techno-commercially qualified bidders.

Price Bids of all the techno-commercially qualified bidders shall be opened and same shall be considered as initial bids of bidders in RA. In case any bidder(s) do(es) not participate in online Reverse Auction, their sealed envelope price bid along with applicable loading, if any, shall be considered for ranking.

- **16.0 QUANTITY VARIATION:** Quantity variation of ± 30% is applicable.
- **17.0 LIQUIDATED DAMAGES/PENALTY:** Detailed as per Sl.no. 8.3 (V) of TCC (Vol-IA).
- **18.0 PERFORMANCE SECURITY:** As per Clause no. 4.5 of TCC (Vol-IA).
- **19.0 SPLITTING OF ORDER:** As specified in TCC, the entire scope of work is being divided into 02 nos. of Packages (i.e., Package A & Package B). Package-B shall be awarded on price matching philosophy as defined in Clause no. 8.2 of TCC (Vol-IA). In case the no. of Techno-commercially qualified Bidders (N) are three or more, the distribution shall be limited to N-1 qualified bidders.
- **20.0** On submission of offer, further consideration will be subject to compliance to tender & qualifying requirement and customer's acceptance, as applicable.
- **21.0** The bidders shall not enter into any undisclosed M.O.U. or any understanding amongst themselves with respect to tender.
- 22.0 The bidder shall submit documents in support of possession of 'Qualifying Requirements' duly self-certified and stamped by the authorized signatory, indexed and properly linked in the format for PQR. In case BHEL requires any other documents/proofs, these shall be submitted immediately.
- 23.0 The bidder may have to produce original document for verification if so decided by BHEL.
- **24.0** The consultant / firm (and any of its affiliates) shall not be eligible to participate in tender(s) for the related works or services for the same project, if they were engaged for the consultancy services.
- 25.0 Guidelines/rules in respect of Suspension of Business dealings, Vendor evaluation format, Quality, Safety & HSE guidelines, Experience Certificate, etc. may undergo change from time to time and the latest one shall be followed. - 26.0 The Bidder along with its associate/ collaborators/ sub-contractors/ sub-vendors/ consultants/ service providers shall strictly adhere to BHEL Fraud Prevention Policy displayed on BHEL website <a href="https://www.bhel.com/bhel-fraud-prevention-policy-0">https://www.bhel.com/bhel-fraud-prevention-policy-0</a>> and shall immediately bring to the notice of BHEL Management about any fraud or suspected fraud as soon as it comes to their notice.
- **27.0** Bid should be free from correction, overwriting, use of corrective fluid, etc. Any interlineation, cutting, erasure or overwriting shall be valid only if they are attested under full signature(s) of person(s) signing the bid else bid shall be liable for rejection. All overwriting/cutting, etc. will be numbered by bid opening officials and announced during bid opening.
- 28.0 In the course of evaluation, if more than one bidder happens to occupy L-1 status, effective L-1 will be decided by soliciting discounts from the respective L-1 bidders. In case more than one bidder happens to occupy the L-1 status even after soliciting discounts, the L-1 bidder shall be decided by a toss/ draw of lots, in the presence of the respective L-1 bidder(s) or their representative(s). Ranking will be done accordingly. BHEL's decision in such situations shall be final and binding.
- **29.0** The Bidder declares that they will not enter into any illegal or undisclosed agreement or understanding, whether formal or informal with other Bidder(s). This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process.

In case, the Bidder is found having indulged in above activities, suitable action shall be taken by BHEL as per extant policies/ guidelines.
