### **WORKS SPECIFICATION**

### A. Details of Work


- 1.All 4 steel wire ropes of diameter 36 mm & length 100 meters each shall be supplied by BHEL Jhansi to Vendor.
- 2. Sleeve crimping shall be done by Vendor on steel wire ropes, diameter 36 mm with double sleeves crimping at single end after making a loop with thimble as per attached drawing.
- 3. All tools and tackles, manpower shall be in Vendor's scope.
- 4. Transportation, Unloading, Loading, handling of steel wire ropes outside BHEL Jhansi premises shall be in Vendor's scope.
- 5. 8 numbers (= 4 x 2) of Aluminium sleeves shall be in Vendor's scope.
- 6. 4 numbers of thimbles for loop shall be in Vendor's scope.

### B. Terms & Condition

- 1. Vendor must provide Test certificate of crimped sleeves issued by competent authority/person approved under factory act 1948.
- 2. BHEL shall witness the load test of sleeves of all 04 steel wire ropes as per applicable standard.
- 3. <u>The bidder is required to submit an amount of ₹3,60,000/- in the form of a Bank Guarantee (BG) or Fixed Deposit Receipt (FDR) before the free issuance of steel wire rope material for sleeve crimping work.</u>
- OR, the bidder may provide an undertaking to hold equivalent amount against any outstanding bills at BHEL Jhansi in place of aforesaid BG/FDR amount.



### Sleeve Crimping in 4 Nos. of Dia. 36mm of steel wire ropes for 125T EOT crane of BAY-9 (Works Contract)

1. Average Annual Financial turnover:

Average Annual financial turnover during the last 3 years ending 31st March 2024 should be at least Rs. 0.56 Lakh. Bidder to attach audited balance sheet and Profit & Loss Account of last three financial years, ending 31st March 2024, or Certificate of CA as proof of financial turnover for respective years. If turnover details of three years are not available, then available years turnover shall be evaluated by dividing it by 3.

#### 2.Experience (either A or B):

A. Experience of having successfully executed similar work, (supply/looping /crimping works of steel wire ropes) in the last 07 years ending the month previous to the month of issuing tender enquiry, either of the following: -

One similar works each valuing not less than the amount equal to Rs 1.48 Lakhs or

Two similar works each valuing not less than the amount equal to Rs 0.93 Lakh or

Three similar works each valuing not less than the amount equal to Rs 0.74 Lakh.
