BHEL Rudrapur has planned to undertake project, under Corporate Social Responsibility Scheme for the F.Y. 2024-25. In this connection, proposal in two bid (techno commercial & Price) is invited from reputed NGO having logistic capability and sound track record of execution of CSR work in the past. **Proposal received in single bid will be summarily rejected.** Price bid is to be kept in one envelope and rest other documents in another envelope. Both the envelopes are then to be put in common third envelope.

The project will be undertaken at various Government Hospital/Dispensary/ Centre, located within a range of about 30 km from BHEL factory situated at Kichcha Bypass Road, Rudrapur, Uttarakhand – 263153 as mentioned in product specifications. The NGO has to assess the nature and magnitude of work before submitting the proposal. Technically qualified NGO will be selected on the basis of overall lowest rate (L-1).

The NGO has to execute the programme in an organized manner with meticulous planning and having focus on ensuring maximum benefit to the intended beneficiaries in a cost-effective manner. Established procedure for the implementation of CSR activities has to be followed. Proper documentation, including survey before the implementation and impact of the project supported by photographs & Videos is to be maintained. The activity is to be publicized in both print and visual media.

Completion of work: The work should be of good standard and has to be completed <u>within 31st March'2025.</u>

No deviation allowed in completion time i.e. 31st March 2025.

Material will be dispatched directly to the all 4 locations as mentioned in Product Specification.

Payment: Party will submit single expenditure bill to BHEL-Rudrapur with all the associated bills. Payment shall be made within <u>15 days</u> after completion of satisfactory work & submission of bills to BHEL through electronic mode. Before the due bill payment date, project completion report with evidence, impact assessment and documentary evidence shall be furnished. The committee will review the reports. The bill will be released only after the report is accepted by the committee.

Proposal: The parties (NGOs) will provide their details as asked in techno-commercial bid and quoted rates are to be provided on price bid. Price Bid of only those parties will be opened who are techno-commercially suitable.

The work will be awarded to party (NGO) on the basis of L-1 charges payable on overall basis. However, BHEL reserves the right to accept or reject any bid without assigning any reason, thereof. The parties are advised to visit site for actual assessment of work before submitting tender.

General Terms & Condition: All the transportation charges and other miscellaneous expenditure including photography, videos, opening ceremony, snacks, banner etc. incurred in the project shall be borne by executing party (NGO/Social organization) & BHEL will not make any payment for this.
