4. In case the tenderer finds discrepancies or omissions in any of the tender document or doubt as to their meaning, he should at once address the authority inviting the tender, for clarification before tender opening.

Payment Terms:

payment shall be made by BHEL after replacement of all the damaged spares at all construction supply sub stations. Payment will be made within 30 days from the date of submission of bills along with all the enclosures as required by the BHEL. Payment through electronic fund transfer (EFT) / RTGS) only after deducting Bank charges.

GST:

1. Tender will be considered/ accepted, if & only if the vendor has a valid GST Registration No.
2. Central Tax/ State Tax/ Integrated Tax/ Union Territory tax to be quoted as extra in %.
3. Bidders to ensure correct applicability of Central Tax/ State Tax/ Integrated Tax/ Union Territory tax based on the Inter / Intra state movement Supply of goods and provision services or both.

Invoicing & Payment

The Tax Invoice for supply of Goods & Services should be raised as per the provision of GST Act & Rules and must compulsorily mention the following: -

- a. BHEL- NCTPS GSTIN: 33AAACB4146P2ZL
- b. HSN Code or Service Accounting Code for supply of goods or services.
- c. Name & address of supplier
- d. GSTIN of Supplier
- e. Description of goods or services
- f. Total value of supply/service excluding taxes
- g. Tax Rate – Central Tax & State Tax or Integrated Tax, Cess
- h. Amount of Tax charged
- i. Place of supply
- j. Address of delivery if different from place of supply
- k. Signature of authorized signatory

Reimbursement of GST to the vendor is contingent upon complying with the following condition by the service provider: -

- i. Uploading the onward GST Return (**GSTR-1**) in GSTN Network portal within the statutory time period.
- ii. Discharging the GST tax liability to the Government.
- iii. Submission of Tax Invoice to BHEL.
- iv. Submission of proof of payment of GST to BHEL.
- v. Availment of Input Tax Credit by BHEL.

Any reduction in rate of Tax on any supply of goods or services or the benefit of input tax credit shall be passed on to the recipient by way of commensurate reduction in prices.
