Tender Conditions

- 1. Tender must be submitted vide email to <u>tender.nctps3@bhel.in</u> within due date as per tender conditions.
- 2. In case of opening day falls on holiday or anything to be declared as a holiday, the receipt and opening of the tender shall automatically fall on the same timing of the next working day. You/your authorized Representative may participate in the tender opening
- 3. All entries in the tender documents either in printed or written format. Errors and over writings are not permitted. The tenderers concerned shall duly sign all cancellations and insertions. Tenderer shall sign in all sheets of tender documents.
- 4. In case the tenderer finds discrepancies or omissions in any of the tender document or doubt as to their meaning, he should at once address the authority inviting the tender, for clarification before tender opening.
- 5. The tender will be opened on 30.09.2025 @17:00 Hrs at BHEL, North Chennai Stage III site
- 6. All corrigenda, addenda, amendments, clarifications etc. to tender specification will be hosted in the webpages (https://eprocurebhel.co.in/nicgep/app) only.
- 7. Bidders shall keep themselves updated with all such developments.
- 8. Contract shall be awarded to single party only.
- 9. BHEL, North Chennai Stage-III site reserves the right to accept or reject any or all tenders without assigning any reasons whatsoever.
- 10. If a tenderer expires after the submission of the tender or after the acceptance of his tender, Bharat Heavy Electricals Limited, may at their discretion, cancel such tender. If a partner of a firm expires after the submission of the tender, or after the acceptance of the tender, Bharat Heavy Electricals Limited, may cancel such tender at their discretion, unless the firm retains its character.
- 11. Canvassing in any form in connection with the tender is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable for rejection.
- 12. The validity of the offer shall be 30 days from the date of tender opening.
- 13. Rate should be quoted as per the work/rate schedule. If not, it will be rejected.

Contract General Conditions

Terms and conditions:

- Necessary work permits shall be obtained by sub-contractor for working inside duct.
- Making necessary approach/scaffolding is in the scope of sub-contractor.
- If any insulation is to be removed, same shall be done within the quoted rate and re-installation of insulation also shall be carried out after completion of mechanical work.
- If any line support is cut for attending the work; same shall be re-stored by sub-contractor.
- Temporary platform, scaffolding pipe for approach, T&Ps and scraps shall be removed after completion of work.
- It is a lumpsum rate contract and payment will be made on lumpsum basis after successful completion of the work.
- Safety and necessary statutory requirements shall be fulfilled by the agency.
- Required support material and duct plate shall be provided by BHEL.
- Sufficient manpower including grinder, fitter, supervisor, safety person should be engaged by the vendor for completion of work.
- Payment will be made on 30 days from the submission of invoice along with satisfactory work completion protocols cleared by TANGEDCO.

- As the contract is given on emergency basis, any delay will not be permitted and a penalty of 1% will be levied for delay in each day limited to 10% of contract value.
- The contractor has to start the work immediately on receipt of work order.
- The contractor has to deploy required welders, grinders, fitters, temporary platform and adequate manpower for completion of work within stipulated time.
- Vendor should ensure carrying out the works without any damage of other equipment etc.
- Necessary work permits shall be obtained by the sub-contractor for carrying out the work.

Tools and plants:

- All the required T&Ps including chain blocks, welding machines, grinding machine, scaffolding is in the scope of vendor.
- All required consumables including electrodes LPG, oxygen, grinding wheels etc. are in the scope of sub-contractor.
- Required illumination arrangement shall be made by the vendor.

Payment Terms:

payment shall be made by BHEL after completion of service/repair work and performance of the same on submission of your invoices/bills (in Triplicate) duly certify by the user department. It will be made within reasonable time from the date of submission of bills along with all the enclosures as required by the BHEL. Payment through electronic fund transfer (EFT) / RTGS) only after deducting Bank charges.

GST:

- 1. Tender will be considered/accepted, if & only if the vendor has a valid GST Registration No.
- 2. Central Tax/ State Tax/ Integrated Tax/ Union Territory tax to be quoted as extra in %.
- 3. Bidders to ensure correct applicability of Central Tax/ State Tax/ Integrated Tax/ Union Territory tax based on the Inter / Intra state movement Supply of goods and provision services or both.

Invoicing & Payment

The Tax Invoice for supply of Goods & Services should be raised as per the provision of GST Act & Rules and must compulsorily mention the following: -

- e. Description of goods or services
- f. Total value of supply/service excluding taxes
- g. Tax Rate Central Tax & State Tax or Integrated Tax, Cess
- h. Amount of Tax charged
- i. Place of supply
- j. Address of delivery if different from place of supply
- k. Signature of authorized signatory

Reimbursement of GST to the vendor is contingent upon complying with the following condition by the service provider: -

- i. Uploading the onward GST Return **(GSTR-1)** in GSTN Network portal within the statutory time period.
- ii. Discharging the GST tax liability to the Government.
- iii. Submission of Tax Invoice to BHEL.
- iv. Submission of proof of payment of GST to BHEL.
- v. Availment of Input Tax Credit by BHEL.

Any reduction in rate of Tax on any supply of goods or services or the benefit of input tax credit shall be passed on to the recipient by way of commensurate reduction in prices.
