c) In case the numbers of qualified responses are three or more, the distribution shall be limited to two qualified responses i.e. L1 and L2, provided that the next lower bidder accepts the L-1 rates.

d) In case of two qualified bidders, BHEL reserves the right to place total order quantity on L1 bidder only.
