
**A. General terms and conditions:**

1. The offer shall be submitted as per the instructions mentioned in the tender document. Only one set of tender documents duly signed & stamped on each page by the authorized representative shall be submitted in BHEL. In case of any clarification, bidder may contact the under signed through phone or email.
2. **No overwriting / correction in price bid** shall be allowed. However, if correction is unavoidable, the same must be counter signed by the authorized signatory.
3. Tender must be submitted in single part. The cover envelope should be super scribed as follows:  
"NIT No. AA: GAX: 25:MA:104 Dated 17.03.2026"
4. **Total amount must be quoted in figures as well as in words in price bid.**
5. Tender documents are also available on CPP portal (<http://eprocure.gov.in/cpp/>) and BHEL Website ([www.bhel.com](http://www.bhel.com)) and the same can be downloaded and used as tender document for submission of bids.
6. BHEL reserves the right to accept or reject any or all offer without assigning any reason thereof. Also, BHEL shall not entertain any correspondence from the bidder in this matter.

8. The tenderer or its representative may attend the opening of bid if they desire to do so.
10. In case you are not submitting your offer against this enquiry, we request you to send a regret letter.
11. The NIT No. & due date must be legibly super scribed on the envelopes.
12. The above rates are deemed to be inclusive of all and any other incidental works required to complete the services.
13. Price quoted shall be valid till delivery of consignment by supplier at given locations.
14. Price shall be quoted as per 'Price Format' only as enclosed at Annexure-V. Quotations not filled in 'Price Format' are likely to be rejected.
15. The bidder shall sign the **Declaration Certificate** as enclosed at Annexure-I.
16. The bidder shall sign the **No Deviation Certificate** as enclosed at Annexure-II.
17. The bidder shall fill and sign the **Bidder's Detail** as enclosed at Annexure-III.
18. The bidder shall sign the **Declaration of GST Benefits** as enclosed at Annexure-IV.
19. Individual carry bags are to be provided for each sweet packet by the supplier.
20. Sweet packets must be suitably designed in consultation with BHEL by the supplier in line with photo to be shared to supplier by BHEL. BHEL logo to be affixed on sweet packets.

**B. EVALUATION CRITERIA:**

1. The rates quoted by the vendor shall be firm. No price variation and escalation due to increase in labour/material cost will be allowed.
2. If any information/documents submitted by the supplier are found false/fake at any stage, the tender will be cancelled.
3. **CORRECTION OF ARITHMETIC ERRORS:** Provided that the bid is substantially responsive, BHEL shall correct arithmetical errors on the following basis:
  - i. If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected, unless in the opinion of the BHEL there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price shall be corrected.
  - ii. If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected.
  - iii. If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to (a) and (b) above.
  - iv. If any bidder does not accept the correction of errors, their bids will be disqualified.
4. **COMPLETION PERIOD:** Total delivery is to be completed by 11 am on 31/03/2026 at three BHEL locations i.e. (i) Siri Fort, Khelgaon (ii) Lodhi Road & (iii) Noida Sec 16 A.
5. **QUANTITY VARIATION:** The quantity of sweet packets required is 2699 No. however it may vary by 10% during execution of work as per the direction of Engineer-in-charge of BHEL for which rate will remain same and you will have to provide the same within reasonable time.
6. **SUBLETING:** The Supplier shall not sublet, transfer or assign the full work or any part thereof to any other person/company/organization.
7. **TAXES AND DUTIES:**
  - i) To enable BHEL to avail GST Input tax credit, supplier shall submit GST compliant Tax invoice containing all the particulars as stipulated under Invoice Rules of GST Law. Such invoice shall be submitted within prescribed time limit in the name of BHEL.
  - ii) The supplier has to submit their GST registration certificate to BHEL within 30 days from the acceptance of work order. GSTIN of BHEL is 07AAACB4146P1ZH.
  - iii) Any statutory changes as and when made applicable by the Government shall become applicable against submission of documentary evidence.
  - iv) Payment to the supplier will be subjected to TDS as per rules in force from time to time. The Tax Deduction at Source (TDS) shall be done as per the provisions of Income Tax Act and GST as applicable, as amended from time to time and a certificate to this effect shall be provided to the supplier by BHEL.
  - v) Supplier shall issue GST compliant invoice in the name of BHEL.
  - vi) In case GST credit is delayed/denied to BHEL or subsequently recovered from BHEL due to delay in filing of GSTR-1 Return or delay in/nonpayment of tax to Govt. by supplier or for any other reasons not attributable to BHEL, in such case any financial implication on BHEL on account of delay/loss/recovery from BHEL of such GST Credit along with interest levied/leviable on BHEL till the time GST credit is available to BHEL, shall be recovered from the supplier's bill.
  - vii) Applicable GST shall also be recoverable from the contractor in case of LD recovery/penalty on account of breach of terms of contract.
8. **PAYMENT TERMS:**
  - a. Payment shall be made for the actual executed quantity of items, i.e. actual no. of packets provided.
  - b. No advance payment or the payment for mobilization of work will be made to the supplier.
  - c. The supplier shall not be entitled to any interest with respect to any money which may be due to him from BHEL.

- d. All payment will be subject to deduction of taxes at source as per rules.
- e. Payment shall be made to supplier within 30 days from the date of submission of GST complaint Tax invoice as mentioned above and other relevant documents.
9. **L.D. FOR POOR QUALITY:** In case, the quality of sweet packet & its contents are not found satisfactory, an L.D. of up to 10% of total invoice value will be deducted from the bill.
10. No excuses like hindrance because of extreme weather conditions, non-availability of labour and material etc. will be entertained for not providing services on time.
11. In case of any dispute, the decision taken by BHEL Management will be final and binding on the supplier.
12. The bidder along with its associate/ collaborators/ sub-suppliers/ sub-vendors/ consultants/ Service providers shall strictly adhere to BHEL Fraud Prevention Policy displayed on BHEL website <http://www.bhel.com> and shall immediately bring to the notice of BHEL Management about any fraud or suspected fraud as soon as it comes to their notice.
13. **ARBITRATION / CONCILIATION:** In the event of any dispute arising between the parties hereafter referred as BHEL and Supplier in respect of or connected with this contract, General & Special terms & conditions of tender, then the same shall be referred to Arbitration and Arbitrator will be nominated by the Head of Administration of BHEL Corp. Office, New Delhi, whose decision shall be final and binding on both the parties. However, any differences or doubt pertaining to meaning/ interpretation of any phrase word used in terms or in the schedule of services, their nature and manner of rendering of such services shall be the excepted matter and be referred to the Head of Administration of BHEL Corp. Office, New Delhi, whose decision shall be the final and binding. The provisions of Arbitration and Conciliation Act, 1996 or any statutory modification and re-enactment thereof will apply to such arbitration provided however, in all matters the venue of proceedings will be Delhi and only Delhi or appropriate Courts will have jurisdiction over the same.




