No Hard copy bid or bids through email/ fax shall be accepted.

In the event of any conflict between requirement of any clause of this specification/ documents/drawings/data sheets etc. or requirements of different codes/standards specified, the same to be brought to the knowledge of BHEL in writing for clarification before due date of seeking clarification (whichever is applicable), otherwise, interpretation by BHEL shall prevail. Any typing error/missing pages/ other clerical errors in the tender documents, noticed must be pointed out before pre-bid meeting/submission of offer, else BHEL's interpretation shall prevail.

- <u>5.</u> Techno-commercial offer of only those bidders shall be evaluated who will meet the pre-qualifying requirement of the tender specified in this NIT as per PART-'A' (as applicable), past performance etc.

<u>6.</u> After finalization of Techno-commercial evaluation, offers of vendors who have qualified in the Techno-commercial evaluation shall be considered for Price Bid Opening.

BHEL reserves the right not to consider offers of parties under HOLD.

7. Reverse Auction:

BHEL shall be resorting to Reverse Auction (RA) (Guidelines as available on www.bhel.com) for this tender. RA shall be conducted among all the techno-commercially qualified bidders.

Price bids of all techno-commercially qualified bidders shall be opened and same shall be considered as initial bids of bidders in RA. In case any bidder(s) do(es) not participate in online Reverse Auction, their sealed envelope price bid along with applicable loading, if any, shall be considered for ranking.

Bidder to submit duly filled in copy of **Annexure-V of GCC**. Guidelines for Reverse Auction are available in www.bhel.com → Tender Notification → Guidelines for Reverse Auction.

- **8.** Vendors shall quote in accordance with the requirements mentioned in the tender documents. Bidder to submit "No Deviation Certificate" as per Annexure-III of general commercial terms & conditions of GCC (Part D) of NIT. In case of deviations (Technical / Commercial), bidder to clearly mentioned the same with their Techno-commercial offer highlighting separately giving Clause references.
 - **9.** Standard pre-printed terms & conditions of the tenderers shall not be considered valid.

The bidder shall submit/upload documents in support of possession of 'Qualifying Requirements' duly self-certified and stamped by the authorized signatory, indexed and properly linked in the format for PQR. In case BHEL requires any other documents/proofs, these shall be submitted immediately.

The bidder may have to produce original document for verification if so decided by BHEL.

- **10.** <u>VALIDITY OF OFFER</u>: Offer should be valid for a period of 120 DAYS from the date of Techno-commercial Bid (Part-I) opening.
- **11. EVALUATION CRITERIA:** Evaluation shall be done on Net Cost To BHEL for the Lumpsum Price quoted by the bidder in Part-II and subsequent RA.
- **12.** Purchaser shall be under no obligation to accept the lowest or any other tender and shall be entitled to accept or reject any/all tender(s) in part or full without assigning any reason whatsoever.

13. Bid should be free from correction, overwriting, using corrective fluid, etc. Any interlineation, cutting, erasure or overwriting shall be valid only if they are attested under full signature(s) of person(s) signing the bid else bid shall be liable for rejection.

- a. Bidders shall quote Total Lump-sum Price for the entire scope of work at PART-II titled as "BOQ". Price mentioned elsewhere in the offer of the bidder shall be treated as Null and Void.
- b. BHEL has fixed the factors as in "Annexure-I /BOQ for calculation Purpose" for the amount of individual items of Bill of Quantity w.r.t. the total price quoted at PART II. The rate of individual item for the entire scope of work shall be arrived as per BOQ CUM RATE SCHEDULE "Annexure-I".
- c. Based on the pre-fixed factors, amount of individual items shall be derived by BHEL. This item rate shall be used to calculate the total amount of an item.
- d. Bidders to note that this is an 'Item rate contract'. Payment shall be made for the actual quantities of work executed at the Unit rate arrived at as per serial no d above.
