ANNEXURE-B

GENERAL TERMS AND CONDITIONS

1.0 Scope

Scope covers repair of civil structures, reconstruction of sewage line and miscellaneous repair works in BHEL field hostel at BHEL-Barh site. Detailed items of works to be executed (provisional) are given in rate schedule.

1.1 Scope of work are as follows:

- i) PCC flooring is required for proper approach to mess.
- ii) Cleaning of drainage/sewage line and septic tank wells.
- iii) New drainage line to be laid between soak pit well and main drain.
- iv) 04 Nos. of new inspection chambers is needed for proper cleaning and maintenance sewage system.
- v) Repair & PCC of vehicle parking shed.
- vi) Cleaning of 04 Nos of overhead water tank.

2.0 Towards Execution of Works.

- i) All supplied items and their installation will be in line with item description given in rate schedule.
- ii) All works will be under guidance of BHEL however responsibility for maintenance of quality will be in vendors scopes.
- iii) Contractor should provide to his employees all tools, tackles and equipment and maintain the same to carry out the job under the contact at his cost and if necessary contractor may take insurance policy of his men, vehicles, equipment and tools and tackles.

3.0 Measurement of the job

The following methods of measuring the job carried out by the contractor will be adopted:

- Measurement sheet clearly mentioning the work executed along with Joint Protocol shall be maintained.
- ii) Day shall mean a period of 8 hours from the schedule time of report on week days / working days.

4.0 Payment of the Contractor:

- i) Payment to be made to be contractor on the basis of work carried out.
- ii) Price Variation: Not Applicable.
- iii) Payment to the contractor will be made within 30 days from the receipt of the bill along with all necessary documents. The contractor bills will be dully verified checked and passed by connection section and forward to finance and Account Section for releasing payment to the party. All payments will be made by Cheque/RTGS/NEFT.
- iv) Income Tax & or GST TDS wherever applicable shall be deducted under relevant Act / Law.

5.0 Contractual and legal obligation of the Contractor:

- i) BHEL has the pivot of the contract with the contractor only and will give instructions to the contractor or his authorized representative. BHEL will have nothing to do or be concerned with the employment of employees working for the contractor. The relationship between BHEL and the Contractor will be that of independent entities and nothing herein contained will amount to joint venture, partnership or an employer –employee relationship.
- ii) Contractor shall supervise the work allotted to him and to be carried out by his employees.
- iii) Contractor to ensure that the employees deployed in the premises of BHEL are physically and mentally fit and do not have any criminal record. Such employees should possess requisite skill, proficiency, qualification experience etc. The contractor shall arrange to obtain police verification of each of worker deployed.
- iv) Contractor will be responsible for the good conduct of his employees. In case of any misconduct/misbehavior by any employee, the contractor will replace such employee(s) immediately.
- v) Contractor will keep watch on his employees and he will be liable for any pilferage / loss to BHEL due to acts of omission and commission by his employees. Similarly, liability for any compensation to outsiders on account of any act of omission and commission by the employees deployed by the contractor shall lie exclusively with him.
- vi) The contractor shall be responsible for enforcing all safety regulations as applicable.
- vii) The contractor to ensure that all precautions are taken for safety of his employees and equipments.
- viii) In the event of termination of contract for any reason, whatsoever, the contract shall withdraw all his employees form the establishment of BHEL. In case contractor decides to terminate services of his employees, he should settle all terminal dues including retrenchment compensation.

6.0 Towards statutory Liability

- i) All statutory requirements under Minimum Wages Act, 1948, Payment of Wages Act, 1936, Workmen Compensation Act, 1923, EPF & MP Act, 1952, Payment of Gratuity Act, 1972, ESI Act, 1948. The Contractor Labour (R & A), Act, 1970, Payment of Bonus Act, 1965, Income Tax, GST Act, Motor Vehicle Act, 1988 and all other applicable Acts shall be complied with by the contractor.
- ii) Contractor shall comply with all statutory requirements, rules, regulations, notifications in relation to employment of his employees issued from time to time by the concerned authorities.
- iii) The Contractor shall indemnify BHEL against all claims and losses under various labour laws, statutes or nay civil or criminal law in connection with employees deployed by him.
- iv) The liability for any compensation on account of injury sustained by an employee of the contractor will be exclusively that of the contractor.
- v) Contractor to obtain insurance cover for his employees/ equipments /tools and tackles etc and take third party risk insurance coverage at his own cost. BHEL shall not be responsible for any loss, damage, pilferage of his property and / or his employees.

7.0 Rights and obligations of BHEL.

- 1) In case the contractor does not carry out the contractual/ statutory obligations or the services rendered by him are found to be unsatisfactory, BHEL shall bring the same to his notice and he will be obliged to discharge the obligations and rectify the deficiency / anomaly within specified time failing which BHEL reserves the right to impose the specified penalty and / or terminate the contract without assigning any reason whatsoever. In such an event, no damages will be payable for short closure of the contract.
- 2)The contract may be terminated at any time without paying compensation whatsoever to the contact in case of misbehavior, disobedience, dishonesty, clandestine, insolvency, any court order, non-sanction of road permit or any other related activities on their part or their failure to fulfill the terms and conditions of the contract.
- 3)BHEL Reserves right to short close the contract at its discretion at any point of time without assigning any reason thereof.
- 4)The decision of BHEL regarding interpretation of any terms and conditions set forth in the agreement shall be final and binding on the contractor.

8.0 Duration of the contract

Duration of contract will be 30 days from date of placing of WO to the successful bidder; both the parties reserve the right to extend the contract on mutually agreed terms and conditions.

9.0 Arbitration and Governing Law

All disputes arising in connection with the contact shall be settled by mutual consultation. If no agreements is reached the dispute shall be settled in accordance with the provision of the Arbitration and Conciliation Act, 1996 and the rules made there under. The dispute shall be referred for arbitration to any arbitrator to be appointed by the Head of BHEL PSER Barh Site. The award of the arbitrator shall be final and binding on both the parties. The venue of the arbitration shall be in Kolkata in India. The Award to be given by Arbitration shall be a speaking award. All questions, disputes, differences arising under, out of or in connection with this contract shall be to be exclusive jurisdiction of Kolkata courts.
