Technical Specifications For Jigging (Shaping) Machine

Brief description of operation : The clay pugs with a moisture content of 16 -20 % from the pugmill are cut to the required length, conical shape formed using a suitable tool and put into the mould on the turntable to under go the shaping operation. The insulator after forming is placed into the chain drier along with the moulds for drying

Mode of operation : The mould from the drying chamber is placed in one of the stations, the operator then manually puts the clay pug into the mould such that there is no void in the head portion of the shaped insulator. The turn table moves to preshaping and final shaping stations and the final shaped insulator along with mould is picked up manually and placed in the drying chamber for drying

Throughput capacity :

The throughput capacity of the shaping machine shall be 240 pieces per hour

Construction and function:

1. The machine shall be designed as a double-stand machine with pre-arranged six-Station turntable. The machine frame shall consist of a solid and welded steel substructure with a steel upper part.
2. The turntable shall be indexed by a step-by-step gear that gives an exactly positioned feed distance. Drive of the step-by-step gear is effected via a geared motor.
3. At the I Station the conical shaped pugs of precise length are put into the aluminium plaster moulds and pressed into the mould by a rotating, up and down moving tool at Station II.
4. An oil spraying device with variable dosing for body and forming tools shall be located at the recessing stations (III and IV).
5. The actual shaping process of insulators shall be effected at Station III and IV. At Station III the insulator is pre-formed by a simple tool and the final contour of the article shall be formed at Station IV.
6. Forming tools stations III and IV shall be driven by separate motors. Thus, both recessing stations are independently regulable .
7. The up and down stroke movements of the forming tools are commonly effected by a hydraulic cylinder which controls the main carriage accommodated in ball guides and hardened guide shafts. Hydraulic power pack with cooling system, either air blast/refrigerant cooling, suitable for ambient temperature of approx. 45 – 50° C and 80% humidity shall be included
8. Each forming tool, mounted onto its own slide, shall be adjusted to the exact Station by a threaded spindle. The spindle movement shall be controlled by a programming unit with which a spindle time position curve can be programmed.
9. The final positions of the forming tools shall be limited by limit switches/proximity sensors



10. *In order to keep the no-load operations as little as possible, the up and down movements of the forming tools shall be effected in rapid motion before the machine switches to jiggering and/or slow lifting. All movements shall be infinitely variable so that the best possible forming periods can be achieved.*
11. *At Station V , below the turntable, a hydraulic ejector shall be provided which lifts the aluminium plaster mould to make it easier for the operator to unload the moulds. Station VI for mould loading & unloading*
12. *The complete electrical control panel with PLC controls shall be accommodated in a close, compact switchboard. The control shall be so designed such that the equipment can be run in fully automatic mode and manual mode*
13. *Appropriate emergency-off switches for the operator's safety shall be provided. A digital speed and pressing force indication of the tools shall also be provided.*
14. *The equipment shall have Automatic lubrication spraying system for jiggering.*

ANNEXURE – A

- 1.1 Registered agents will file an authenticated Photostat copy duly attested by a Notary Public/Original certificate of the Principal confirming the agency agreement and giving the status being enjoyed by the agent and the commission/ remuneration/ salary/retainer ship being paid by the principal to the agent before the placement of order by BHEL.
- 1.2 Wherever the Indian representatives have communicated on behalf of their principals and the foreign parties have stated that they are paying any commission to the Indian agents, and the Indian representative is working on the basis of salary or as retainer, a written declaration to this effect should be submitted by the party (i.e. Principal) before finalizing the order.
- 2.0 Disclosure of Particulars of agents/ representatives in India, if any.**
- 2.1 Tenderers of Foreign nationality shall furnish the following details in their offers.
- 2.1.1 The Bidder(S) Contractor(s) of foreign origin shall disclose the name and address of the agents/ representatives in India if any and the extent of authorization and authority given to commit the Principals. In case the agent/representative be a foreign Company, it shall be confirmed whether it is existing company and details of the same shall be furnished.
- 2.1.2 The amount of commission /remuneration included in the quoted price(s) for such agents/representatives in India.
- 2.1.3 Confirmation of the tender that the commission /remuneration, if any, payable to his agents/representatives in India, may be paid by BHEL in Indian Rupees only.
- 2.2 **Tenderers of Indian Nationality shall furnish the following details in their offers:**
- 2.2.1 The Bidder(S) Contractor(s) of Indian Nationality shall furnish the name and address of the foreign principals, if any, indicating their nationality as well their status, i.e. whether manufacture or agents of manufacture holding the Letter or authority of the Principal specifically authorizing the agent to make an offer in India in response to tender either directly or through the agents/ representatives.
- 2.2.2 The amount of commission/ remuneration included in the price(s) quoted by the Tenderer for himself.
- 2.2.3 Confirmation of the foreign principals of Tender that the commission/remuneration, if any, reserved for the Tender in the quote price(s), may be paid by BHEL in India in equivalent Indian Rupees on Satisfactory completion of the project or supplies of Stores and spares in case of operation items.
- 2.3 In either case, in the event of contract materializing, the terms of payment will provide for payment of the commission/remuneration, if any payable to the agents/representatives in India in Indian Rupees on expiry of 90 days after the discharge of the obligations under the contract.
- 2.4 Failure of furnish correct and detailed information as called for in paragraph 2.0 above will render the concerned tender liable to rejection or in the event of a contract materializing, the same liable to termination by BHEL. Besides this there would be a penalty of banning business dealings with BHEL or damage or payment of a named sum.
