QUALIFICATION REQUIREMENT

- a) The bidders should possess the experience of having executed erection , testing and commissioning work in thermal power plant minimum one unit capacity of 200 / 210 MW in the last seven years

Or

The bidder should be executing the erection and commissioning of minimum one unit of 500 MW or above capacity of boiler and its auxiliaries and equipments for power sector regions of BHEL

- b) The bidders should have a minimum average financial turn over of **Rs.700 Lakhs** per year in the preceding three years ending 31st March 2007.

The Bidder must have earned profit in any one of the last three financial years ending 31.03.2007 and should have positive net worth as on 31.03.2007.

Bidder should submit audited balance sheet and profit & loss account of the company for last three years ending 31.03.2007 in support of above requirement.

- c) Notwithstanding the above, BHEL reserves the right to reject any Tender or all the Tenders for reasons whatsoever beyond our control and the decision of BHEL is final.

BHEL shall operate the purchase preference prescribed by Government of India for Public Sector undertakings as applicable on the tender opening date.
