- b. Fixed Deposit Receipt (FDR) issued by Scheduled Banks/Public Financial Institutions as defined in the Companies Act (FDR should be in the name of the vendor/bidder, a/c BHEL)
- c. The EMD shall not carry any interest.
- d. Suppliers such as Central/State-PSUs/ Govt departments and Micro Small Enterprises are exempted from EMD.
- e. In case of unsuccessful bidder, the EMD will be refunded after finalization of the tender.
- f. BHEL reserves the right of forfeiture of EMD, in case the successful bidder who:
- f.1. After opening the tender and within the offer validity period, the tenderer revokes his tender or makes any modification in his tender which is not acceptable to BHEL.
- f.2 The supplier fails to deposit the required CEBG.
- **8.** Contract Execution Bank Guarantee (CEBG): The successful bidder has to submit Contract Execution Bank Guarantee (CEBG) of 10% of order value within 30 days from date of PO. All bank charges on account of issuance and confirmation of CEBG shall be borne by vendor.
- **9. Performance Bank Guarantee (PBG):** The successful bidder has to submit Performance Bank Guarantee (PBG) of 10% of order value for 30 days beyond the Warranty Period by supplier. PBG Confirmation charges shall be borne by vendor.
- 10. Rate shall be firm and there is no Price Variation.
- 11. Rate must be quoted in Rupees for supply and erection and Commissioning seperatativy on FOR BHEL Jagdsihpur Basis.
- (II) <u>Item Description:</u> Design, Fabrication, Loading, Supply, Transportation, Erection and Commissioning of the Motorized RCC sliding Door for clear opening size 7.0mx7.0m with 1.0m Thickness and an overlap of 500mm (i.e.0.5m) on three sides of door. The Motorized RCC sliding Door shall be provided with suitable structure steel frame work with vertical, horizontal and diagonal stiffeners consisting of rolled steel sections (ISMC/ISMB/ISA) confirming to IS:808-2021 as per scope of supply of Technical Specification ref no. FSIP/WEX/RCC Sliding Door/05 DATED 07.09.2022.

Note: Erection, testing and commissioning of motorized RCC door will be in vendor's scope. Cranes, hydras, scaffoldings and all other lifting equipment required during erection and commissioning of RCC sliding door will be in the scope of the vendor.

Scope of Supply & E& C: -

a) Design, Fabrication, Loading, Supply, Transportation, Erection and commissioning of Sliding RCC Door for clear opening of size 7.0m*7.0m with 1.0m thickness and an overlap of 500mm(0.5m) on three sides of the door and in confirmation with the attached drawing.

- b) The Motorized RCC door should be provided with suitable structural steel framework with vertical, horizontal and diagonal stiffeners, consisting of suitable rolled steel sections confirming to IS: 808:2021
- c) Material should be dispatched in parts/sub-assemblies and no individual part/sub-assemblies should have weight exceeding 10MT. All part/sub-assemblies to be assembled and credited at our site and further all machinery, tools and material required for the assembly are to be arranged by the vender.
- d) Erection, testing and commissioning of motorized RCC sliding door shall be in Vendor's scope.
- e) For all civil constructions required for erection and commissioning of the RCC sliding door, all relevant drawings and instructions shall be provided by the vendor well in advance.
- f) Operation and maintenance manuals (Two hard copies) and general assembly drawing along with soft copy in .pdf format.
- g) Training to our personnel for operation and maintenance.
