#### 1. Brief description of the machine:

The machine must be capable of testing Porcelain disc insulator shells being produced by us. The porcelain shell is subjected to hydraulic pressure (raw water is used as the testing fluid) at the pin cavity portion of the shells before cementing the pin to the shell. Different pin cavity will be subjected to volumetric pressure ranging from 150 to 600 kg/sq cm. The system should be capable of testing for the required volumetric pressure for a range of volume in the cavity portion. The insulator must not get damaged due to clamping force. Differential unit in series with the clamping mechanism must take care of this requirement. (Bidders are requested to see and ascertain themselves the working of similar machine in BHEL/EPD before quoting for the purpose of clarity if need be).
