1. This Booklet consists of the scope and bill of quantities of the entire work etc.
2. The Bidders are requested to go through the instructions contained in the documents attached and quote in the Rate Schedule attached.
3. The Bidders are advised to go through the General conditions of contract, Special conditions of contract, Tender specifications and all parts of this tender document and fully understand the scope of work before quoting. Any doubt in the documents should be got clarified from Erection Services Department of BHEL, Ranipet before submitting their offer.
4. Bidders shall note that all consumables, tools & tackles and **all the required Cranes**, are to be provided by the contractor.
5. **No advance payment towards mobilization of site operation** or for any other purpose will be made by BHEL. The payment for work will be made strictly as per payment terms in the tender specification.
6. **The Tender Documents should be submitted duly signed and stamped in all the pages** of the Tender Specification, General conditions of contract, special conditions of contract, Annexure etc. by the Bidder.
7. The bidders shall submit the duly filled up **Formats** given in this tender document, along with the offer.
8. Time is the essence of the contract and all the resources required for Dismantling and erection of ESPs shall be arranged by the contractor within the stipulated time period for avoiding any demurrage / penalties.

**Registration & GST Rate**

1. Bidder should indicate GSTIN No. (Copy of GST registration to be enclosed) and PAN No. (copy of PAN to be enclosed).
2. Bidders to ensure correct applicability of Central Tax/ State Tax/ Integrated Tax/ Union Territory tax based on the Inter / Intra state movement Supply of goods and provision services or both.
3. **Invoicing & Payment:** The Tax Invoice for supply of Services should be raised as per the provision of GST Act & Rules and must compulsorily mention the following: -

  - i. Uploading the onward GST Return (**GSTR-1**) in GSTN Network portal within the statutory time period.
  - ii. Discharging the GST tax liability to the Government.
  - iii. Submission of Tax Invoice to BHEL.
  - iv. Submission of proof of payment of GST to BHEL along with each bill is required for timely processing & payment.
5. **Input Tax Credit:** In case GST credit is delayed/ denied to BHEL, due to non/delayed receipt of goods and/or services and/or tax invoice or expiry of timeline prescribed in GST Law for availing such ITC, or any other reason not attributable to BHEL, GST amount shall be recoverable from Vendor along with interest & penalty levied/ leviable.
6. In case vendor delays declaring such invoice in his return and GST credit availed by BHEL is denied or reversed subsequently as per GST law, GST amount paid by BHEL towards such ITC reversal as per GST law shall be recoverable from vendor/contractor along with interest & penalty levied/ leviable on BHEL.
7. In case of discrepancy in the data uploaded by supplier in the GSTN portal or in case of any incomplete work/service, then BHEL will not be able to avail the tax credit and will notify the supplier of the same. Supplier has to rectify the data discrepancy in the GSTN portal or issue credit note (details to be uploaded in GSTN portal).
8. For any such delay in availing of tax credit for reasons attributable to vendor (as mentioned above), interest as per the GST Act & Rules, along with penalty, if any will be deducted for the delayed period i.e. from the month of receipt till the month tax credit is availed, from the running bills.
9. **Penalty for Non-compliance of GST Act.** Penalty amount so determined along with GST if applicable thereon shall be recovered from the contractor.

**2.15 ARBITRATION:**

Except where otherwise provided for in the contract all questions and disputes relating to the meaning of the specifications, designs, drawings and instructions herein before mentioned and as to the quality of workmanship or materials used on the work or as to any other question, claim, right, matter or thing whatsoever in anyway arising out of or relating to the contract, designs, drawings, specifications, estimates, instructions, orders or these conditions or otherwise concerning the work or failure to execute the same whether arising during the progress of the work or after the completion or abandonment thereof shall be referred to the arbitrator nominated by the Unit Head of BHEL-Ranipet.

The cases referred to arbitration shall be other than those for which the decision of the Accepting Officer, or Engineer-in-charge as the case may be is expressed in the contract to be final and conclusive. There will be no objection if the arbitrator so appointed is an employee of BHEL and that he had to deal with the matters to which the contract relates and that in the course of his duties as such he had expressed views on all or any of the matters in dispute or difference.

The arbitrator to whom the matter is originally referred being transferred or vacating his office or being unable to act for any reason, such General Manager as aforesaid at the time of such transfer, vacation of office or inability to act shall appoint another person to act as an arbitrator in accordance with the terms of the contract. Such person shall be entitled to proceed with the reference from the stage at which it was left by his predecessor.

Subject as aforesaid the provision of the Arbitration and Conciliation Act 1996 or any statutory modification or reenactment thereof and the rules made there under and for the time being in force shall apply to the arbitration proceeding under this clause.

It is a term of the contract that the party involving arbitration shall specify the dispute or dispute to be referred to arbitration under this clause together with the amount or amounts claimed in respect of each such dispute.

The arbitrator shall be deemed to have entered on the reference on the date he issues notice to both the parties fixing the date of first hearing.

The arbitrator shall give a separate award in respect of each dispute or difference referred to him.

The venue of arbitration shall be such place as may be fixed by the Arbitrator in his sole discretion. The award of the Arbitrator shall be final conclusive and binding on all parties to this contracts.

In the event of disputes or differences arising between one public sector and a Government Department or between two public sector enterprises the above stipulations shall not apply, the provisions of BPE Office memorandum No. BPE/CL/001/76 MAN/2(1.10)76-BPE (GM-1) dated 1<sup>st</sup> January 1976 or its amendments for arbitration shall be applied.

<p style="text-align: center;"><b>SECTION –IV</b></p> <p><b>4.1 SPECIAL CONDITIONS FOR ESP</b> The special conditions for ESP shall be comprising of but not limited to the following:</p> <p><b>4.1.1</b> Any fixtures, concrete block supports, steel structures, required for temporary supporting for pre-assembly, checking, welding, lifting and handling during pre-assembly and erection shall be arranged by contractor, at his cost.</p> <p><b>4.1.2</b> The scope of equipment to be erected under this contract are detailed in tender specification, Technical Description etc. The schedule of weights given are approximate and are meant only to give a general idea to the Tenderer about the magnitude of the work involved.</p> <p><b>4.1.3</b> All works such as cleaning, leveling, blue-matching, aligning, assembling for temporary erection and alignment, dismantling of certain equipment for checking/cleaning, surface preparation, fabrication of tubes and pipes as per general engineering practice at site. Cutting, grinding, straightening, chamfering, filling, chipping, drilling, reaming, scraping, shaping, fitting up etc., as may be applicable in such erection work are to be treated as incidental to erection and necessary to complete the work satisfactorily, shall be carried out by the Contractor, as part of the work.</p> <p><b>4.1.4</b> It shall be the responsibility of the contractor to provide ladders on columns for initial work till such time stairways are completed. For this, the ladder should not be welded on the column and should be pre-fabricated clamping type ladders. Temporary welding on any structural member is permitted under special circumstances only with the approval of BHEL.</p> <p><b>4.1.5</b> No member of the structure/platform should be cut without specific approval of BHEL.</p> <p><b>4.1.6</b> Welding of necessary instrumentation tapping points, will also be the responsibility of the Contractor and will be done as per the instructions of BHEL Engineer. The welding of all the above items will be Contractor's responsibility even if the</p> <p style="padding-left: 40px;">1) Product groups under which these items are not specifically indicated in the technical Specifications.</p> <p style="padding-left: 40px;">2) Items are supplied by an agency other than BHEL.</p> <p><b>4.1.7</b> All welded joints should be painted with anti-corrosive paint. Daily welding reports in the proforma suggested by BHEL should be submitted the next day morning without fail.</p> <p><b>4.1.8</b> All rotating machineries and equipment shall be cleaned, lubricated, checked for their smooth rotation if necessary by dismantling and refitting before erection. If in the opinion of BHEL Engineer, the equipment is to be checked for clearance at any stage of work or during commissioning period, all such works are to be carried out by Contractor at his cost.</p> <p><b>4.1.9</b> <del>Contractor shall carry out chipping and blue matching of foundation concrete with the packer plates. The packer plates shall be supplied by BHEL. Necessary machining and blue matching of packer plates shall be carried out by the contractor with in the quoted rates.</del></p> <p><b>4.1.10</b> Electrostatic precipitator collecting electrodes may require strengthening and repair due to minor transport damages before erection and spot heating in position to get correct alignment. This shall be carried out by the contractor as part of the work.</p> <p><b>4.1.11</b> <del>Erection, alignment/ fixing in final position of HIGH VOLTAGE RECTIFIER Transformer of ESP are in the scope of work. However testing and commissioning will be done by other agencies.</del></p> <p><b>4.1.12</b> <del>Installation of High voltage Interlocks (excepting rotary switch interlock in EC Panels) is in the scope of work</del></p>

Necessary equipment like air blower, venturi, instrumentation etc. will be provided by BHEL free of charges. Handling at stores, transport, erection, commissioning, carrying out the leakage test and attending to leakages till satisfactory sealing / leak proof shall be in the scope of work. Contractor shall dismantle the test equipment and return to BHEL stores in good condition after due reconciliation, cleaning, servicing. No separate/ additional payment is envisaged for the above.</del></p> <p><b>4.1.14</b> Complete erection, alignment, testing, pre-commissioning etc. of drive motors of collecting electrode and emitting electrode rapping mechanism is in the scope of work.</p> <p><b>4.1.15</b> Additional platforms of permanent nature for approaching different equipment, as per site requirements which may not be indicated in drawings, shall be installed by the contractor. The materials required for platforms will be supplied by BHEL in running meters at free of cost.</p> <p><b>4.1.16</b> All welders shall be tested and approved by BHEL Engineer / client of BHEL before they are actually engaged on work. BHEL reserve the right to reject any welder without assigning any reason.</p> <p><b>4.1.17</b> In case of any class of work for which there is no such specifications as laid down in the contract, such work shall be carried out in accordance with the instructions and requirements of BHEL Engineer at the quoted rates only.</p> <p><b>4.1.18</b> BHEL Engineer is entitled to stop any welder from his work if found unsatisfactory for any technical reason or there is a high percentage of rejection the work welded by him which, in the opinion of BHEL Engineers, which adversely affect the quality of welding, though the welder has earlier passed the tests.</p> <p><b>4.1.19</b> All charges for testing of welders including destructive and non-destructive tests shall have to be borne by the contractor.</p> <p><b>4.1.20</b> All welded joints shall be subject to acceptance by BHEL Engineer/client.</p> <p><b>4.1.21</b> <del>The contractor shall make suitable security arrangements including employment of security personnel (round the clock) to ensure the protection of all materials/equipment and works from theft, fire, pilferage and any other damage and loss at stores/storage yard/pre assembly area/erection site, till the contract is getting over.</del></p> <p><b>4.1.22 APPLICATION OF INSULATION &amp; CLADDING</b></p> <ol style="list-style-type: none"> <li>1. Application of insulation and sheet metal covering includes leading the materials from stacking area/storage sheds to the place of work</li> <li>2. The insulation work should be carried out with contractor's own scaffolding materials, tools etc.</li> <li>3. Welding of hooks, supports as per pitch/applying red oxide paint to welded portion as directed and as per the drawings before application of Mineral Wool / Glass Wool mattresses and as instructed by BHEL Engineer.</li> <li>4. Wool insulations are received at site as bonded / unbonded mattresses in standard sizes. These are to be dressed / cut to suit site requirement by the Contractor.</li> <li>5. The contractor shall supply manpower and consumables to carry out the required tests on the equipment such as Air-in leakage Test ( using air blower provided by BHEL), Gas tightness test by smoke test method or kerosene method and other tests such as Gas Distribution test, Performance Guarantee test etc., to be specified by the Resident Engineer, BHEL at free of cost. Contractor shall supply labour for all these without any extra cost under this contract.</p> <p>3.2 In case any defect is detected during tests, trial runs such as loose components, undue noise or vibration, strain on connected equipment etc., the Contractor shall immediately attend to these defects and take necessary corrective measures. If any re-adjustment and re-alignment are necessary, the same shall be done as per BHEL Engineer's instructions. If any part of the equipment needs repair, rectifications or replacement, the same shall be done by the Contractor at his cost. The parts to be replaced shall be provided by BHEL.</p> <p>3.3 During this period, though the BHEL's/Client's staff will also be associated in the work, the Contractor's responsibility will be to arrange for the complete labour requirement for the successful trial run of equipment till it is handed over to customer.</p> <p>3.4 It shall be specifically noted that the above employees of Contractor may have to work round the clock along with the BHEL Commissioning Engineers and hence any overtime payment so involved, the Contractor's quoted rates shall be inclusive of all these factors also.</p> <p>3.5 During commissioning, re-aligning of rotating and other equipment, attending to leakages and minor adjustment of erected equipment may arise. The quoted rate of Contractor shall be inclusive of all such works.</p> <p>3.6 In case any rework is required because of Contractor's faulty erection which is noticed during commissioning the same has to be rectified by the contractor at his cost. If, during commissioning, any improvement or rectification due to design requirements is involved the same shall be paid at man-hour rates quoted. For this purpose, daily labour report indicating there in, nature of work carried out, consumables used etc., shall be maintained by contractors and for signed by BHEL Engineers every day.</p> <p><b>4.1.24 PROGRESS OF ERECTION WORK:</b></p> <p>1. During the course of Erection, if the progress is found unsatisfactory, or if the target dates are to be advanced, or in the opinion of BHEL if it is found that the welders employed are not sufficient, BHEL will induct on work their own welders, in addition to Contractor's welders working and recover from the Contractor's bills the charges incurred for engaging the welders with the overheads. This is binding on the Contractor.</p> <p>2. In case the Contractor's progress is found unsatisfactory, BHEL may deploy unskilled, semi-skilled, skilled operators, Technicians and other required manpower and will assist in improving the progress. All the expenses incurred for, will be recovered from Contractor's bills with overheads.</p> <p>3. It is obligatory on the part of the Contractor to give daily feedback on progress of erection.</p>

The omission of specific reference to any method, equipment or material necessary for the proper and efficient services towards the work allotted shall not relieve the contractor of the responsibility of providing such services/facilities to complete the project or portion of project awarded to him. The quoted rate shall deem to be inclusive of all such contingencies.</p> <p><b>5.1.2</b> The contractor shall carry out the work in accordance with instructions/drawings/specification standard practices supplied by BHEL from time to time.</p> <p><b>5.1.3</b> Provision of all types of labour, supervisors, Stores staff, watch and ward as required, tools and tackles, consumables as specified under various clauses of Tender Specification for erection, testing and commissioning and dismantling of existing structures.</p> <p><b>5.1.4</b> Proper out turn as per BHEL plan and commitment.</p> <p><b>5.1.5</b> Completion of work in time.</p> <p><b>5.1.6</b> Good quality and accurate workmanship for proper performance of equipment.</p> <p><b>5.1.7</b> Repair and rectification.</p> <p><b>5.1.8</b> Re-conservation/preservation of all components.</p> <p><b>5.2</b> FACILITIES TO BE PROVIDED AND DEVELOPED BY THE TENDERER AT HIS COST</p> <p><b>5.2.1</b> It shall be the responsibility of the contractor to construct his own office shed, stores shed, labour sheds with all facilities like electricity, water supply, sanitary arrangements in the area allotted to him for the purpose.</p> <p><b>5.2.2</b> Distribution of water for construction purposes and as well as drinking purpose from the single point provided by BHEL to various works fronts shall be the Contractor's responsibility and at his cost.</p> <p><b>5.2.3</b> Necessary meters for recording consumption of water and power for cost analysis purpose and maintenance of the same during execution period shall be Contractor's responsibility.</p> <p><b>5.2.4</b> Provision for distribution of electrical power from the given single central point to the required places with proper distribution boards, approved cable laying, including supply of all materials like cables, switch boards, pipes, etc., observing the safety rules laid down by the Electricity Authority of the State/BHEL/their customer shall be the responsibility of the tenderer /contractor.</p> <p><b>5.2.5</b> As there are bound to be interruptions in regular power supply, power cut/load shedding in any construction site due to inherent power shortage in State on this account, suitable extension of time only be given and contractor is not entitled for any compensation. The decision of BHEL Engineer in this regard is final and binding on the Contractor.</p> <p><b>5.3.2</b> BHEL reserves the right to reject the use of any gas in case the required purity is not maintained.</p> <p><b>5.3.3</b> The Contractor shall submit Weekly / fortnightly / monthly statements / reports regarding consumption of above gases for cost analysis programme.</p> <p><b>5.3.4</b> The Contractor shall ensure safekeeping of the inflammable cylinders at separate place away from normal habit with proper security etc.</p> <p><b>5.4 ELECTRODES</b></p> <p><b>5.4.1</b> All the electrodes required shall be arranged by Contractor at his cost. It shall be the responsibility of the Contractor to obtain prior approval of BHEL before procurement, regarding suppliers, type of electrodes etc. On receipt of the electrodes at site, it shall be subjected to inspection and approval of BHEL. 2. Water washing of all damaged 8 (Eight electrical fields may be done **If required or as per EIC instruction.**
3. Inspection of Eight fields and associate structure bearing like ESP roof, collecting structure frame, emitting frame, collecting, and emitting rapping mechanism and its gear box, ESP hoppers of associate fields and shaft & support insulator housing and support structure.
4. Locking of structure at the desired location for cutting damaged components if required.
5. Proper scaffolding, and safety equipment like safety belt, fall back arrester, lifeline etc. to be installed at proper location for cutting of damaged components/erection of new components.
6. Manhole to be cut at desired location of Hopper to takeout damaged components from ESP internal if any.
7. Cut and remove damaged internals of ESP fields if required as already materials were removed from the fields. Prior to gas cutting of damaged internals proper holding or locking arrangement should be done to avoid free fall of material while cutting if any. Scrap materials safely lower to 0 Mtr. from the field inside.
8. Transportation of scrap materials from site to scrap yard as directed by E-I-C within plant premises if any.
9. Arrangement of material handling equipment like winch, trailer, hydra, forklift etc any other equipment required for the execution of work will be under BIDDER scope as per availability. BIDDER must arrange on its own. If hydra, forklift is arranged by an BIDDER then ensure that the driver must have valid license and a flagman must be available while using the same.
10. **Work may be carried out in unit running conditions by isolating the ESP Pass or during overhaul for which restoration work will be undertaken** BIDDER has to take due precaution during execution of work so as not to put any materials over ESP roof top in those passes which are in service & ESP TR sets in charged condition. Proper isolation/ barricading of working area from other areas has to be ensured by BIDDER. Scaffolding where required will be under the BIDDER's scope and must follow NTPC PTW rules and regulations.
11. Final box up of field (Restoration of openings which will be made for scrap removal) to be complete at desired location. Insulation and cladding work have to be completed by the BIDDER.
12. After completion of work the entire area has to be cleaned by an BIDDER.

Contractor has to provide ISI marked safety helmets to all the deployed manpower. Other PPE for safe work environment to the workers to be provided by the contractor. Damaged Safety Helmets and Safety shoes should be replaced by the Contractor promptly as & when required.
- d) The Contractor shall be liable to arrange & pay for the expenses towards Medical Treatment in respect of all workers employed for the execution of the Contract.
- e) LD shall be imposed for delay in completion of the job in each unit as per GCC.
- f) When the ground for withholding payments is removed payment of the contractor shall be made by NTPC.
- g) The clearance settings and other measurements affecting quality are to be taken in presence of NTPC.

- h) Electrically operated any T&P hand tools must be non-metallic and checked/ certified by Safety department prior to use at site.
- i) All types of consumables are in the scope of Contractor.
- j) Contractor has to provide test certificates for all T&P.
- k) It shall be contractor's responsibility to maintain and keep his manpower in specified area only. Contractor has to keep all the loose components and T&P's provided by NTPC if any under his custody round the clock during execution of work.
- l) Contractor will also supply safety gadgets as per requirement (like safety belt, ear plug, nose mask etc.) apart from protective equipment such as safety helmets, safety shoes to all his workmen.

#### **10.0: SAFETY ASPECTS OF CONTRACT:**

- a) The Contractor shall strictly abide by the NTPC Safety rules. The contractor has to strictly follow the safety regulations for safe working of men and equipment, particularly with respect to electrical connections, welding, cutting, pulling and lifting, grinding and of working at high elevations and scaffolding. For detailed instructions kindly refer following clauses:
- b) The contractor should clearly understand that safety of men at work is more important than the work itself.
- c) The contractor has to depute Safety officers having academic qualification and industrial experience round the clock for safe mobilization of work.
- d) Certified and Tested Welder, Cutter to be deputed during the job mobilization.
- e) The contractor shall ensure that safety of highest standard is ensured by his entire work force. The contractor will be fully responsible for the safety of his workers including those supplied for manpower assistance.
- f) Besides the various statutory requirements prescribed to ensure safety, special attention is here by drawn to the following safety precautions.
- g) All persons deployed by contractor should be medically fit.
- h) Work should be started only after ensuring that valid permit to work is available for working in the relevant area.
- i) All persons must wear safety helmet, safety shoes and use other personal protective equipment like dust mask, safety belt, hand gloves, grinding goggles and fire restrained

- l) Hand railings/ toe guards etc. wherever removed shall be restored as soon as possible after completion of work.
- m) Wherever openings have been made in the floor, suitable warning boards will be displayed, and the contractor will have to close the opening after completion of job. Also, no opening will be made in the floor/ platform /grating without prior approval of NTPC and same shall be clearly brought out in the PTW and JSA.
- n) Job area to be barricaded properly.
- o) Violation of any safety norms shall draw the penalty as per the safety clauses of NTPC.

#### **Safety Precautions related to Welding and Gas Cutting:**

- DA Hoses should be kept away from the welding cables; the hoses should be healthy with proper clamping to prevent chances of gas leak.
- Gas cylinders should not be rolled on the ground or carried in bicycles etc. Trolleys should be used for their transportation.
- For lifting and lowering cylinder proper cage should be used. Anchoring at valve portion should be avoided as the valve is delicate portion of the cylinder and is liable to break causing serious accident.
- All welders, grinder men, and cutters shall use protective goggles.
- Welding cables should have proper insulation. No naked cable should be used.
- While welding or gas cutting, the area where the sparks/ hot metal is likely to fall should be identified and all inflammable materials should be removed from or effectively covered in the affected area to prevent any chance of fire.
- Use of fire blanketing is to be ensured by the contractor.

#### **Safety Precautions related to working at heights:**

- No loose material shall be left at heights as material falling may cause serious injuries.
- Working platforms at height should have adequate space and proper railings. Where permanent railings are not feasible, temporary railings using manila rope or any other means should be provided.
- Toe guards should be provided in the platforms deployed for the work. All scaffolding should be inspected for its soundness and strength; only tubular scaffolding materials should be used.
- Any scaffolding shall be constructed with a minimum of three supports as per safety norms for a standard-length plank.
- Proper approaches should be made up to the working area.
- Each scaffolding plank should be properly supported at least at four places. Gaps should not be left between planks.
- All workers working at a height of more than two meters of any other location fall from where

#### **Safety Precautions related to Electrical Equipment:**

- All portable hand lamps used inside enclosed space shall be of 24-volt ratings.
- All portable hand lamps shall have insulated handle, cage guard/ cover over the bulbs.
- All electrical cables shall be of double insulated type and joints in electric power supply cables should be avoided to the extent possible. In case joints are unavoidable these should be minimum, and the joint should be properly insulated.
- Inserting bare terminals in plug sockets is prohibited.
- All welding machines, grinding machines, drilling machines etc. should have their bodies properly earthed.
- All grinder men should use hand gloves and safety goggle while working with grinder.
- All electrical hand tools should preferably be of fiber body to reduce risk of electric shock.
- All welding machine connections shall be made with welding receptacles only.

#### **Working at confined space:**

- Oxygen content is checked for the space inside tank /vessel and oxygen content is more than the minimum specified (20%)
- It is to be ensured that the space inside tank/ vessel is free from toxic/ poisonous gases.
- Forced Ventilation arrangements for Air Circulation inside Tank/ vessel is to be provided.
- Only 24 volts DC hand lamps are to be provided inside at work location.
- The valves on inlet pipes to tank/ vessel are to be ensured in closed condition. The closed valves on inlet pipes are to be checked as locked.
- Manholes in tank/ vessel are to be kept in open condition and are cordoned.
- Workers should wear all required PPEs including Helmet/ Shoe/ Safety belt in good condition. Dust mask/ respirator is to be provided to workers for protection against dust/ fumes.
- Experienced workers are to be engaged for work.
- Supervisory staff of BIDDER is to be made available for safe operation.

#### **Demolition Works:**

- Detail Inspection of the area and structure to be dismantled is to be carried out.
- Disconnection of all the service lines example electricity, water, gas etc. is to be done.
- Supporting the uncontrolled collapse of walls, pillars, and other structure.
- Proper means such as chutes are provided to carry the waste material from floor to ground level.
- The area is fenced, and caution boards are provided.
- PPEs are to be issued to the workers and ensuring their use.
- Effective supervision is to be provided till completion of the demolition and ensured demolition is done systematically.

- While working with hazardous chemical, skin/ eye contact shall be prevented through the use of impervious gloves, clothing, boots, apron, and eye goggles or full-face shield.
- If the airborne exposure limit may be exceeded and engineering controls are not feasible, wear appropriate respiratory protection.
- The hazard area shall be isolated from unnecessary people.
- Remove all sources of heat and ignition. Keep all combustibles (wood, paper, oil, etc.) away from the leak.
- Ventilate potentially explosive atmospheres.
- Toners shall be unloaded with mechanical or electrical hoist. If not possible, unload manually from the truck in a slanted ramp.
- The valve protection hoods shall not be removed before unloading. If that is not done, accidental impact can damage the valve and liquid chlorine can come out from the cylinder which cannot be controlled.
- Store the cylinders in a covered shed & dry area only.
- Chlorine cylinders should not be stored above 2 layers to avoid danger of falling & getting damaged.
- In Chlorine handling, use lead washers. Do not use rubber washer or steam gasket washer because rubber hose easily hardened & develops cracks.
- Use seamless copper tube & C.S piping for Cl<sub>2</sub> gas transfer.
- Effective supervision is to be provided during the job of handling hazardous chemicals.

Note: Any deviation from the above during work shall be accounted as violation of safety norms and shall be treated as unsafe practice. In such cases the execution of the job shall immediately force to be stopped until the noncompliance(s) is/ are properly addressed, and penalty shall be imposed upon the BIDDER as per GCC.

#### **Safety Training:**

- Contractor shall ensure that all of his workmen deployed for the works have understood safety requirement for the assigned work.
- Before each start of work, safety requirements are to be briefed by concerned technical and safety supervisor.

5. Insurance and other statutory requirements are in contractor's account.
6. The contractor should ensure that manpower deployed, must wear PPE like safety shoe, Safety helmet, hand gloves, safety goggle etc. While executing the job at the workplace & take all safety precautions. NTPC shall not be responsible for any death, injury or accident of manpower deployed by contractor for the job, which may arise out or in the course of their duties, nor shall be liable to pay any damage or compensation to such person.

25. The recovery in respect of any spare which is damaged due to negligence on the part of contractor will be done at the rates as mentioned in the price catalogues of BIDDER or any other source and overheads at the rate of 30%.
