### **Terms and conditions:**

- payment will be made after receipt of spares at NCTPS Stage III site in working condition.
- The contractor has to start the manufacturing the spares immediately on receipt of work order.

### **Payment Terms:**

payment shall be made by BHEL after completion of repair work and performance of the same on submission of your invoices/bills duly certified by the user department. It will be made within 15 days from the date of submission of bills along with all the enclosures as required by the BHEL. Payment through electronic fund transfer (EFT) / RTGS) only after deducting Bank charges.

### **GST:**

1. Tender will be considered/ accepted, if & only if the vendor has a valid GST Registration No.
2. Central Tax/ State Tax/ Integrated Tax/ Union Territory tax to be quoted as extra in %.
3. Bidders to ensure correct applicability of Central Tax/ State Tax/ Integrated Tax/ Union Territory tax based on the Inter / Intra state movement Supply of goods and provision services or both.

### **Invoicing & Payment**

The Tax Invoice for supply of Goods & Services should be raised as per the provision of GST Act & Rules and must compulsorily mention the following: -

- f. Total value of supply/service excluding taxes
- g. Tax Rate – Central Tax & State Tax or Integrated Tax, Cess
- h. Amount of Tax charged
- i. Place of supply
- j. Address of delivery if different from place of supply
- k. Signature of authorized signatory

Reimbursement of GST to the vendor is contingent upon complying with the following condition by the service provider: -

- i. Uploading the onward GST Return (**GSTR-1**) in GSTN Network portal within the statutory time period.
- ii. Discharging the GST tax liability to the Government.
- iii. Submission of Tax Invoice to BHEL.
- iv. Submission of proof of payment of GST to BHEL.
- v. Availment of Input Tax Credit by BHEL.

Any reduction in rate of Tax on any supply of goods or services or the benefit of input tax credit shall be passed on to the recipient by way of commensurate reduction in prices.
