10	Sl. 2 of rate schedule for Mechanical Work	Segregated tonnage of LP piping based on piping material.	Bill of material placed as annexure - V of Volume - II may be referred for material of piping.
11	Sl. 5 of rate schedule for Mechanical Work	Fabrication of Mitre bends and tees of size 300 mm NB and above for LP piping.	CW pipes will be supplied in running meters and bends,tees,reducers of CW piping shall be supplied in fabricated condition.However the contractor may be required to do fabrication of some bend,tees, reducers above 300mm for CW piping and payment for this shall be made as per Mechanical - BOQ Sl. no. 5.
12	Sl. 6 of rate schedule for Mechanical Work	Supply & application of coal tar tape	This item of rate schedule shall be included in Civil BOQ. However bids shall be evaluated on total price quoted against Civil and Mechanical BOQ together.

13	Raw water piping from Valve room to reservoir is included in contractor's scope of work.		
14	BHEL shall place two separate orders on single evaluated L-1 bidder as below : a. One order for items against CIVIL BOQ and b. Another order for items against MECHANICAL BOQ. Bid evaluation will be done on the basis of total quoted price of Civil & Mechanical BOQs. Completion period, Compensation for delay, Guaranty period, Rate Revision and Mobilisation advance shall be applied separately for the two contracts. However the description of these clauses shall remain as per tender terms.		
15	These clarifications (TCN-01) will form a part of the tender document and should be submitted (duly signed) along with bid as specified. Quoted price of bidders will be presumed on the basis of original tender & these clarifications (TCN-01).		
16	All other terms and conditions shall be as per tender.
