 3. **Verification of PQR documents:** Bidders to ensure that Third party/customer issued certificates being submitted as proof of PQR qualification should have verifiable details of document/certificate issuing authority such as name & designation of Issuing Authority and its organization contact number and e-mail Id etc. In case the same found not available, Purchaser has right to reject such document from evaluation.
 4. Separate POs shall be placed for Main Supply (incl. E&C spares), Mandatory Spares and Supervision of E&C. BG & LD shall be applicable as per GCC-R07.

5. **PQR for MSME/Start-Up vendor's:** This item/Package/System falls under the list of items defined in Para 3 of Ministry of Finance guideline dated 20-09-2016 (procurement of items related to public safety, health, critical security operations and equipments, etc) & hence criteria of prior experience/turnover shall be same for all the bidders including startup /MSME.
6. **Tender Evaluation** - Evaluation will be done on overall L1 (Total cost to BHEL) excluding GST with necessary loading as applicable. The evaluation currency for this tender shall be INR. Further, bidders have to submit price break in ratio of 88% to BHEL-PEM scope (Main Supply incl E&C spares, Mand. Spares and Supervision of E&C) as per Annex-1 and 12% to BHEL-TBG scope (Main Supply incl E&C spares, Special Tools & Tackles, Mand. Spares and Supervision of E&C) as per Annex-2. In case of non-compliance by bidders, the same shall be adjusted accordingly.
7. Bidders to quote Freight charges as % of Total Quoted Ex-Works Price, also. In case of non-compliance, freight percentage shall be calculated w.r.t. total Ex-works price accordingly.

- 16.** In line with SS&P circular 31 dated 11.12.20, In the event of ordering when contract value exceeds 25 lakhs, Bidder has to mandatorily furnish Gem seller ID prior to award of contract
- 17.** BHEL shall be resorting to **Reverse Auction (RA)** (Guidelines as available on www.bhel.com) for this tender. RA shall be conducted among the techno-commercially qualified bidders. Price bids of all techno-commercially qualified bidders shall be opened and same shall be considered for RA. - 21.** Over all (%) Quantity Variation: The variation on overall package value due to changes in the scope shall be $\pm 5\%$.

consequences thereof. Hence all bidders are requested to be more careful at the time of uploading the Unpriced and Price Bid for Part-I and Part-II respectively to avoid mismatch.

- 23.** Commercial terms of NIT only to be considered and mentioned anywhere in technical specification in case contradicting to be ignored.
- 24.** All Bidders to comply Govt. of India, Ministry of Power, order no-25-11/6/2018-PG dated 02/07/2020 regarding mandatory testing of all the imported items/equipment's/components.
- 25. Make in India:** *"For this procurement, the local content to categorize a supplier as a Class I local supplier/ Class II local supplier/ Non-Local supplier and purchase preference to Class I local supplier, is as defined in Public Procurement (Preference to Make India), Order 2017 dated 16.09.2020 issued by DPIIT. In case of subsequent orders issued by the nodal ministry, changing the definition of local content for the items of the NIT, the same shall be applicable even if issued after issue of this NIT, but before opening of Part-II bids against this NIT."*

Minimum Local Content - *Since this package falls under the category of goods, services or works in respect of which nodal ministry/ department has communicated that there is a sufficient local capacity and competition, only Class-I local suppliers as defined in the PP (MII) order are eligible to bid.*

Following point to be noted regarding verification of local content: -

The supplier at the time of tender, bidding or solicitation shall be required to provide a certificate that the item offered meets the minimum local content, in accordance with para 9 of PP-MII order revision dated 16.09.2020.

This Point will supersede point no 26 of ITB of GCC Rev 07.
