This is an amendment to our earlier NIT No.1696 Dated 12.06.06. The scope of work has been modified and accordingly changes have been made in the qualifying requirements as given below. The vendors who have already submitted their offer against this tender have to submit their fresh bid ,however, they need not submit EMD again for this tender.

SUB:TENDER FOR EXECUTION AND HANDING OVER OF CIVIL WORKS FOR 220 KV SUBSTATION AT RAIBAREILLY IN UP.

Sealed Tenders (Under two part bid system) are invited from competent civil contractors for execution and handing over of Civil and earthing works of 220 KV Substation at Raibareilly in UP. Only those who are technically and financially capable to execute the Job and who fulfil the Qualifying Requirements [QR] given under are eligible to quote against the above NIT. Tenderers should submit their offer in a sealed envelope as per the procedure specified in tender documents. The QR of contractor for tender submission shall be as under:

- a. Vendors should have a minimum average annual turnover of. Rs.1.35 crore and should submit balance sheet and Profit & Loss Account for latest three years.

- b. Vendor should have successfully executed/executing similar job (ref note below) during last seven years ending 31.07.06. Vendor should produce Certification/proof in support of execution/executing similar package from User/end user and should be either of the following:
 - i. **Three similar completed/ executing works costing not less than Rs 1.8 crore.**

 - OR
 - ii **Two similar completed /executing works costing not less than Rs.2.25 crore**

 - OR
 - iii **One similar completed/ executing work costing not less than Rs.3.6 crore**

- c) Vendor should have earned profit in at least one year during last three Financial years.

NOTE: Similar job shall mean successful completion/executing of civil works of switchyard or substation or power house or industry or infrastructure involving predominantly concrete works

Quotations received from bidders who do not fulfil the QR shall be summarily rejected without any further evaluation and information to bidders. Tenderers, who are not enlisted with Transmission Business Group, BHEL, should enclose all information required for a complete Evaluation & Enlistment in prescribed formats and other details as a proof of their credentials in a separate sealed envelope Superscribed " Request for Registration and enlistment" and submit prior to their offer along with Demand Draft of Rs. 1000/- in favour of BHEL, Transmission Business Group, payable at New Delhi as application fee. The enlistment format is available on Web and may be downloaded.
