ENLISTMENT OF CONTRACTORS FOR CIVIL & HOUSEKEEPING WORKS

Recently we have enlisted contractors for civil & housekeeping works in BHEL, Tiruchy. Since it is proposed to keep the enlistment open for three months (i.e.) from 16.08.06 to 15.11.06, those who are interested fulfilling the following eligibility criteria may contact the undersigned for enlistment of contractors for different categories as listed below.

Sl. No.	Category	Value (upto Rs. In lakh)
01	Civil, Structural & allied works in Factory & Township – Class – I	1000
02	Civil, Structural & allied works in Factory & Township – Class – II	500
03	Civil, Structural, maintenance works etc. in Factory & Township – Class – III	300
04	Civil, Structural, maintenance works etc. in Factory & Township – Class - IV	100
05	Housekeeping works – Class – I	100
06	Housekeeping works – Class – II	50
07	Housekeeping works – Class – III	25
08	Housekeeping works – Class – IV	10

Above value excludes cost of cement, steel reinforcement & structural steel which will be issued by BHEL at free of cost.

Eligibility criteria:-

1. Separate Registration is required for EPF & ESI. In case of pending registration, copy of application has to be submitted for registration. The Registration Nos shall have to be produced before award of work.
2. Average annual financial turnover of similar works in the last three years should be at least 30% of value of respective classes for which registration is sought.
3. During last seven years successfully completed works either i) Three similar works not less than 40% value in each or ii) Two similar works not less than 50% value in each or iii) One similar work not less than 80% value, all for the respective classes.
4. Value of Structural steel works completed should be not less than 30% of the required average annual financial turnover in the last three years. (Applicable for Sl.No.1 & 2)
5. Solvency certificate should be furnished for the value of 40% of the respective classes for which registration is sought.

All other details contained in the application form which can be had from the undersigned by sending DD for Rs.500/- (Rs.575/- if required by post) drawn in favour of BHEL.

Enlistment fee as indicated in the application form shall be furnished while submitting the application. The enlistment will be kept valid upto 28 02 2010 for civil works (Sl.No.01 to 04) and upto 14 05 2010 for housekeeping works (Sl.No.05 to 08). BHEL reserves its right to accept / reject any or all the applications without assigning any reasons.
