The following commercial terms and conditions shall be applicable for the tender:

1. Tender to be addressed to:

- 2. Offer should contain complete scope of supply with all technical details, specification, delivery and acceptance to all our terms and conditions.
- 3. All quality requirements shall be as per the respective specifications enclosed.
- 4. The supplier shall guarantee their product for a period of 12 months from the date of installation or 18 months from the date of dispatch which ever is earlier.
- 5. Prices quoted by the bidder shall be fixed and not subjected to any escalation whatsoever during the period of bid validity and execution of the Purchase Order.
- 6. All taxes and duties payable as extra to the quoted price should be specifically stated in the offer.
- 7. The offer shall be valid for a period of 120 days from the date of tender opening.

- 8. Our payment terms shall be 90% payment (within 45 to 90 days) against supply of materials at BHEL, Tiruchy along with relevant test certificate and guarantee certificate and the balance 10% after acceptance of the goods.
- 9. Time is the essence of the contract. Therefore the delivery of goods specified in the Purchase Order should be made within the time prescribed. Failure to dispatch the materials in time as per the delivery indicated in our Purchase Order would make the supplier liable to an unconditional penalty at the rate of 0.5% of the value of goods for each week of delay subject to a maximum of 15% of the order value.
- 10. Alternatively the purchaser at his option will be entitled to terminate the contract and purchase elsewhere at the risk and cost of the supplier either the whole of the goods or any part which the supplier has failed to deliver or dispatch within the stipulated delivery period or if the same were not available, the best and nearest available substitute therefor. The supplier is liable for any loss, which the purchaser may sustain by reason of such risk purchases.
- 11. The quotation must indicate the tariff item number and rate of excise duty applicable. The original Excise Duty Gate Pass has to be furnished in case ED is charged to BHEL. If the supplier is availing MODVAT credit for his input materials, the effect of Proforma Credit should be passed on to the purchaser.
- 12. The supplier should arrange for inspection of the goods at their works before dispatch, which shall be witnessed by BHEL inspection personnel. The intimation for inspection should be given at least 10 days in advance.
