Sealed Tenders (Under two part bid system) are invited from competent civil contractors for receipt of equipment/ material at site, unloading, inspection, verification, storage, up-keeping during storage, erection, testing, commissioning and handing over of works of 220/66 KV Substations at Salempur (Ladwa) 66 KV substation at Lohara, 66 KV substation at Mathana. Only those who are technically and financially capable to execute the Job and who fulfil the Qualifying Requirements [QR] given under are eligible to quote against the above NIT. Tenderers should submit their offer in a sealed envelope as per the procedure specified in tender documents. The QR of contractor for tender submission shall be as under:

d) The contractor should meet the minimum QR for T&P and testing equipments as per Annexure-I.

NOTE: Similar job shall mean successful erection, testing and commissioning of Complete/executing substations of 220 KV and above ratings including Power Transformer for Salempur and same as above excepting 66 kV and above ratings for Lohara and Mathana substation.

Quotations received from bidders who do not fulfil the QR shall be summarily rejected without any further evaluation and information to bidders. Tenderers, who are not enlisted with Transmission Business Group, BHEL, should enclose all information required for a complete Evaluation & Enlistment in prescribed formats and other details as a proof of their credentials in a separate sealed envelope Superscribed " Request for Registration and enlistment" and submit prior to their offer along with Demand Draft of Rs. 1000/- in favour of BHEL payable at New Delhi as application fee.
